**THENCE** South 44°03'33" West, along the southeasterly line of said Lot 14 and the northwesterly right-of-way line of said Throckmorton Street, a distance of 8.00 feet to a cut "X" set for corner;

**THENCE** North 45°56'27" West, departing the southeasterly line of said Lot 14 and the northwesterly right-of-way line of said Throckmorton Street, over and across said Lot 14, a distance of 150.00 feet to a 1/2-inch iron rod set with yellow plastic cap stamped "LIM ASSOC" for corner, said point also being in the northwesterly line of said Lot 14 and the southeasterly line of a 15-foot alley (Volume 2, Page 214, M.R.D.C.T.);

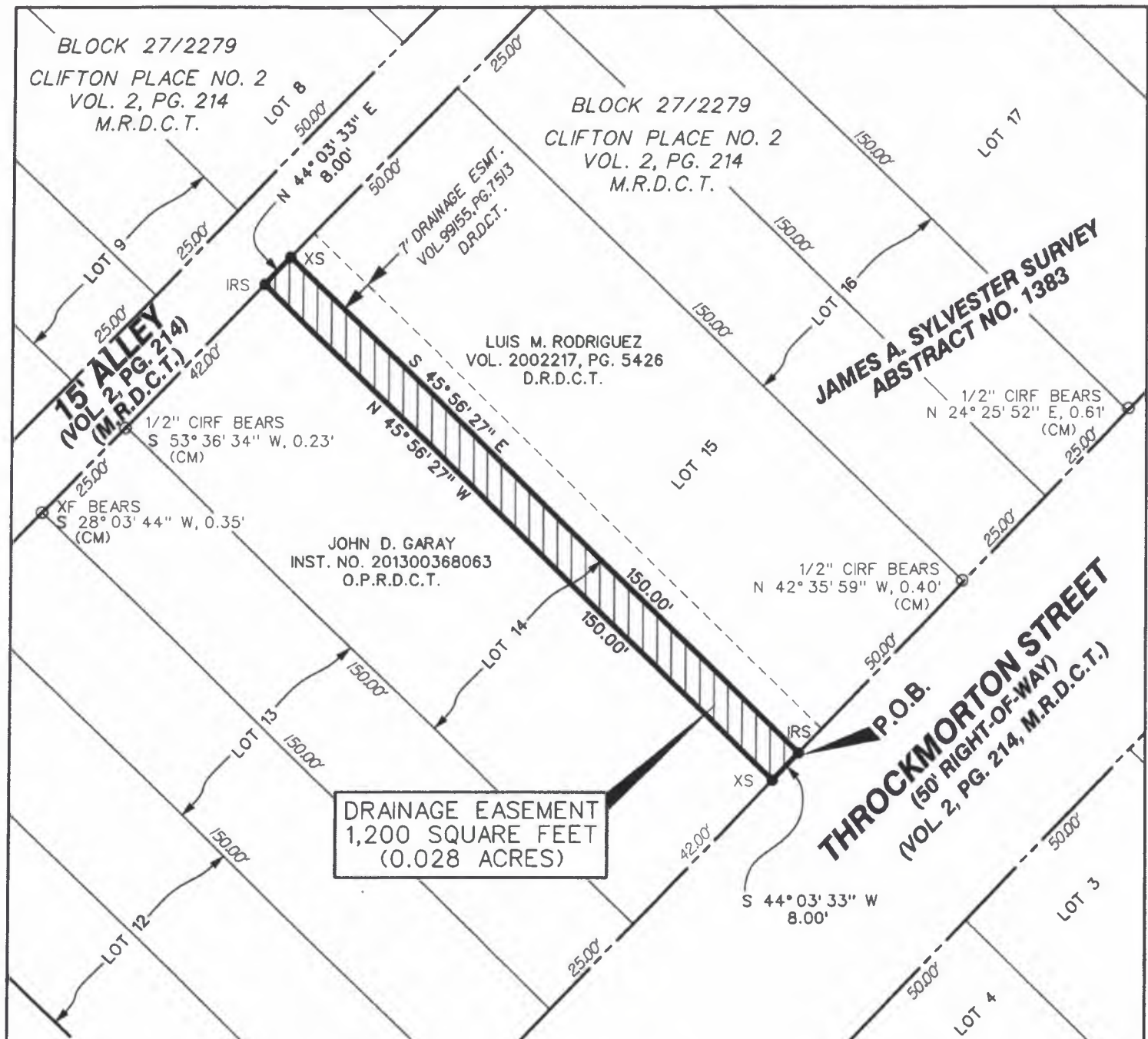

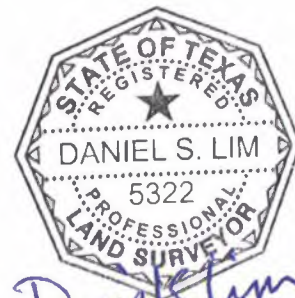

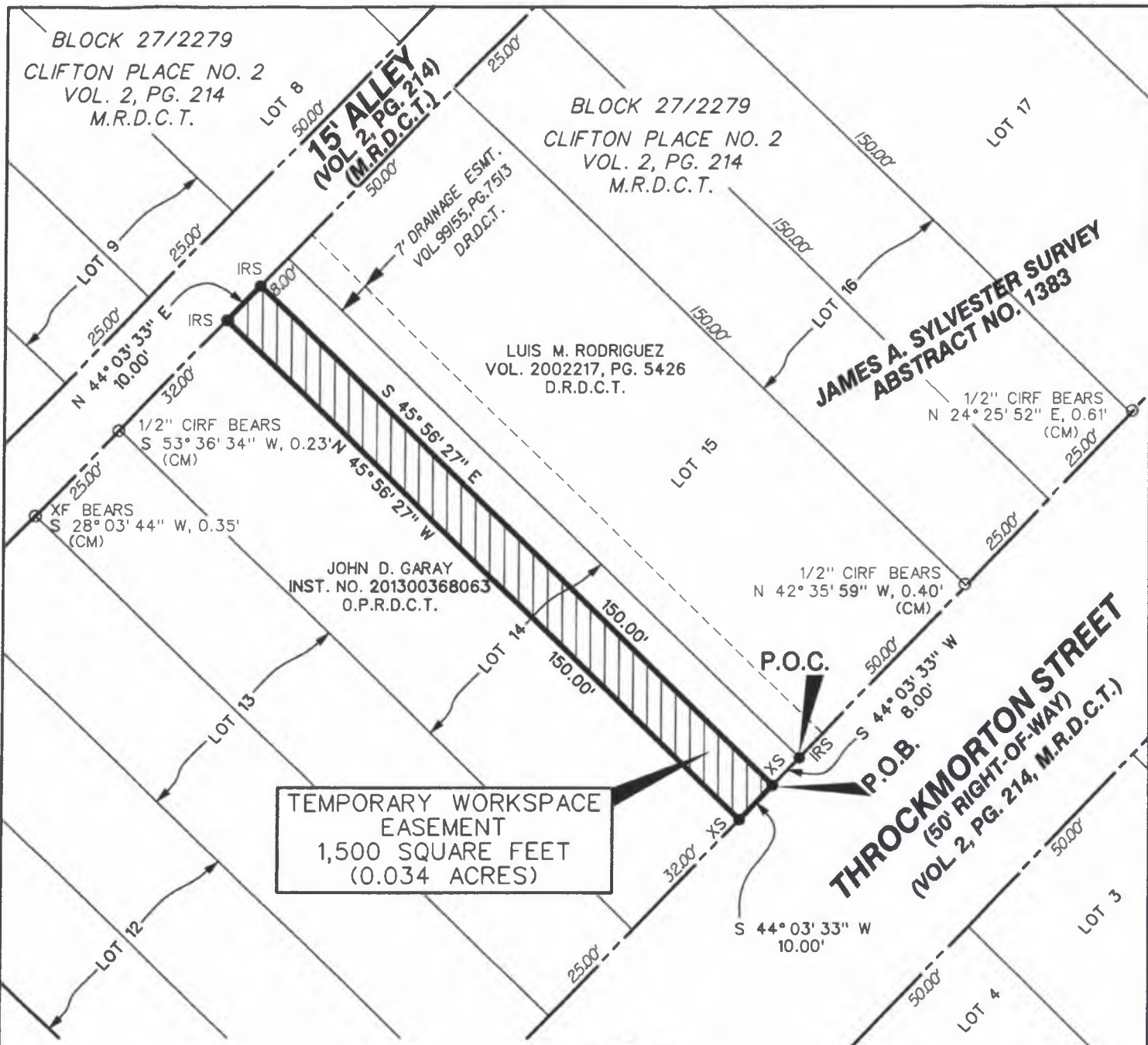
