WHEREAS, on April 8, 2015, City Council authorized a three-year master agreement for the purchase of traffic signal heads, pedestrian signal heads, related hardware and supplies with Dynamic Vision Co., Inc. in the amount of \$1,363,560.00, General Traffic Equipment Corp. in the amount of \$655,642.50, Consolidated Traffic Controllers, Inc. in the amount of \$385,074.30, and Iteris, Inc. in the amount of \$213,120.00, in a total amount of \$2,617,396.80, by Resolution No. 15-0652; and

WHEREAS, on June 26, 2019, City Council authorized a five-year master agreement for the purchase of traffic signal parts and equipment with Mobotrex, Inc. in an estimated amount of \$1,471,560.00, Paradigm Traffic Systems, Inc. in an estimated amount of \$893,640.00, Consolidated Traffic Controls, Inc. in an estimated amount of \$569,967.00, Traffic Parts, Inc. in an estimated amount of \$202,731.25, and Dynamic Vision Co., Inc. in an estimated amount of \$182,780.00, by Resolution No. 19-1027.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That **(1)** the master agreement for the purchase of traffic signal parts and equipment for the Department of Transportation is rescinded with Traffic Parts, Inc. (254147) in the estimated amount of \$202,731.25; and **(2)** a master agreement for the purchase of traffic signal parts and equipment for the Department of Transportation is authorized with Paradigm Traffic Systems, Inc. (344177), approved as to form by the City Attorney, for a term of five years in the estimated amount of \$273,480.00. The amount payable pursuant to this master agreement may exceed the estimated amount, but may not exceed the amount of budgetary appropriations for this master agreement during its term. The City Manager is further authorized, in the City Manager's sole discretion, to exercise an option to extend the contract for six months by filing a notice of extension with the City Secretary's Office.

SECTION 2. That the Purchasing Agent is authorized, upon appropriate request and documented need by a user department, to issue a purchase order for traffic signal parts and equipment for the Department of Transportation. If a written contract is required or requested for any or all purchases of traffic signal parts and equipment for the Department of Transportation under the master agreement instead of individual purchase orders, the City Manager is hereby authorized to execute a contract, approved as to form by the City Attorney.

SECTION 3. That the Chief Financial Officer is hereby authorized to disburse funds in an estimated amount of at least \$273,480.00, but not more than the amount of budgetary appropriations for this master agreement during its term to Paradigm Traffic Systems, Inc. from Master Agreement Contract No. POM-2019-00009155.
