WHEREAS, on May 11, 2022, the City Council authorized to execute a cooperative purchasing agreement for (1) citywide hazardous and non-hazardous waste disposal services with GPI Venture, Inc. (357112) through an interlocal agreement with Dallas/Fort Worth International Airport in an estimated amount of \$2,430,000; and (2) citywide bio-hazardous decontamination and spill clean-up services with Cleaning Guys, LLC dba CG Environmental (VS0000055324) through an interlocal agreement with the Texas Department of Transportation in an estimated amount of \$1,927,380.72, approved as to form by the City Attorney, for a term of two years, in the total estimated amount of \$4,357,380.72. The amount payable pursuant to this cooperative purchasing agreement may exceed the estimated amount, but may not exceed the amount of budgetary appropriations for this cooperative purchasing agreement during its term. Payments made to GPI Venture, Inc. and Cleaning Guys, LLC dba CG Environmental shall be based only on the amount of the services directed to be performed by the City and properly performed by GPI Venture, Inc. and Cleaning Guys, LLC dba CG Environmental under the cooperative purchasing agreement; and

WHEREAS, on April 3, 2024, the City's Office of Procurement Services extended the contracts for an additional six months, from May 10, 2024, through November 9, 2024.

WHEREAS, TRIUMVIRATE ENVIRONMENTAL, INC., a Massachusetts corporation ("TEI"), entered into an Asset Purchase Agreement with Assignor dated May 31, 2024, whereby TRIUMVIRATE ENVIRONMENTAL SERVICES, INC., a Florida corporation and wholly owned subsidiary of TEI, which is fully authorized to transact business in Texas ("Assignee"), would purchase certain assets of Assignor used by Assignor in connection with Assignor's business; and

WHEREAS, on August 16, 2024, such transaction occurred, and Assignee purchased certain assets of Assignor; and

WHEREAS, Assignor assigned and transferred to Assignee all of Assignor's right, title, claim, and interest in and to the Contract, and Assignee acknowledged and agreed to all the terms and provisions and conditions and exhibits of the Contract, accepted the assignment of the Contract from Assignor, and assumed and agreed to perform all services and all obligations of Assignor under the Contract, in accordance with all the terms and provisions and conditions and exhibits of the Contract accruing from and after August 16, 2024.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the City Manager is hereby authorized by City Council to exercise a final option to extend the agreements for six months by filing a notice of extension with the City Secretary's Office. (CR 22-0728)
