





Bus Ridership









- There has been significant discussion in recent years about creation of a frequent “grid” bus system – east/west or north/south routes
- Over the past couple of decades, key crosstown routes have been some of the busiest and fastest-growing in the DART system
- The DARTzoom bus network changes contain more grid-like elements, but is not a full grid

January changes form the baseline of the New Bus Network, and are the first steps in the process

DART is starting work on a Five Year Plan for additional improvements beyond January

Expected Plan completion this year

Possible changes include: additional frequency improvements, speeding up bus operations, etc.



Background



- Since 2019, multiple departments have been and are collaborating on Smart Cities Initiatives.



Examples of Previous Smart Cities Initiatives



- Public Works started installing conduit in street reconstruction projects for future fiber optic installation.
- As a pilot project in early 2020, CableRunner connected fiber optic lines in storm sewers between City Hall and the Canton St. Service Center and to five traffic signals.




View from one of the traffic signal cameras connected to CableRunner fiber

Examples of Previous Smart Cities Initiatives



- October 2020: City Council awarded \$2M of CARES Act funding to Neo Networks to construct 10 wireless broadband networks to provide Wi-Fi services.
- December 2020: The wireless networks were constructed based on areas with low access to the internet and proximity to COD facilities and COD/DISD collaborative digital divide projects.



(10) Wireless broadband networks provide Wi-Fi to approximately 3,200 homes.



Examples of Previous Smart Cities Initiatives



April 2021: City teams/contractors used \$2.8M in CARES Act funding to complete 10 Streetlight Wi-Fi Pilot Projects:



- Project included the installation of telecom fiber from adjacent City facilities to new streetlights and Wi-Fi equipment on 10 residential blocks (Wi-Fi serves 150-300 homes); locations were selected upon:
 - Areas with low access to the internet,
 - Areas needing streetlights as identified by the Mayor's Safety Task Force (Seven locations in identified areas),
 - One of 16 Strategic Lighting Zones that incorporated data from:
 - Market Value Analysis (MVA),
 - Areas of racial and ethnically concentrated poverty,
 - The City's Opportunity Zones,
 - Neighborhood Investment Zones,
 - DPD's target action grid.

- Integrated Streetlight Wi-Fi Pilot Projects:
 - \$500K of CARES Act funding used to install telecommunications fiber and provide Wi-Fi at four integrated streetlight poles (smart poles):
 - Fiber from FS# 15 to three smart poles at Lake Cliff Park,
 - Fiber from OCMC to one smart pole at Jefferson and Crawford intersection.

Next Steps

- City staff has been evaluating Ubicquia technologies to include UbiHub products to provide the following:
 - Wi-Fi,
 - 4K Cameras with Artificial Intelligence (AI) processing,
 - Gun Shot Detection,
 - Lighting controls,
 - Air Quality Monitoring (AQM).
- The UbiHub products are plug-and-play capable with many of the City's existing streetlights.

- Red Cloud Neighborhood Project

 - Recently constructed streetlights within the Red Cloud Neighborhood will serve as UbiHub equipment for:
 - AI cameras,
 - Wi-Fi access points,
 - Environmental monitors.

- Tietze Park – Fiber Install from Fire Station No. 17 to six traffic signals on both Richmond Ave and Skillman St.
- Recent construction of Richmond Ave included the placement of conduit and underground pull boxes to allow for the installation fiber and Ubiquiti Wi-Fi equipment on the six traffic signals.
- Additional fiber will be installed by aerial or boring on Skillman St to connect to Tietze Park.

- On November 10, 2021 Council approved contract with University of Texas at Arlington (UTA)
 - To develop a City of Dallas specification for synthetic fiber reinforced concrete (SFRC)
 - To perform infield testing and data collection on SFRC vs. current City pavement types.
 - Continue the study and analysis to predict remaining service life of SFRC and existing pavement types



Objective




- To implement an innovative pavement system for the City of Dallas with minimum long-term maintenance and speedy construction to avoid longer traffic closure during new construction and/or repair.
- To Evaluate the pavement performance and development of a new specification for the city of Dallas:
- To achieve Sustainable longer life of pavement
- To expedite the overall construction time
- To open the pavement to traffic in maximum 3 days after concrete poured vs traditional 7 plus days)



What is Fiber-reinforced concrete



- Synthetic Fibers with hooked shaped ends to knit concrete together
- Used as an additive to concrete in lieu of rebar



Benefits over Standard Reinforced Concrete



FRC benefit in concrete from UTA studies:

- Speed of curing/opening to traffic
- Improve cracking resistance
- Improve durability
- Improve load carrying capacity of pipes/slabs with traditional steel reinforcement
- Reduced or limit crack widths and crack deterioration rates
- Less joint spalling in pipes/culverts

FAIR PARK TRAIL LOOP

At the April 14th Regional Transportation Council (RTC) meeting, North Central Texas Council of Governments (NCTCOG) staff briefed the RTC on the Fair Park Trail Loop project and the RTC approved award of \$8 million in CMAQ funds including 1.6 million in RTC Transportation Development Credits (TDCs).

Background

In 2020, the RTC awarded Dallas County \$1,603,876 to construct the Fair Park/East Dallas Trail Phase I (north alignment – in blue on the map to the right). Dallas County agreed to contribute \$1,069,250 to the project.



In order to advance the “southern alignment” (in green on map above), Fair Park First, the City of Dallas, Dallas County and NCTCOG staff agreed:

- 1) To replace the federal funds the RTC awarded for Phase I (\$1,603,876) in 2020 with funding from the City of Dallas and Fair Park First

- 2) Have the City of Dallas and Fair Park First partner with Dallas County to **construct the northern alignment**
- 3) To request \$8 million from the RTC to fund **design and construction of the southern alignment**

April 14, 2022, RTC Meeting Action

- **The RTC approved \$8M in CMAQ funds** including 1.6 million in RTC Transportation Development Credits (TDCs) to fund **design and construction of the “southern alignment”**.

SANTA FE PEDESTRIAN BRIDGE TEMPORARY CLOSURE **DELAYED**

The March Interagency Transportation report included information about closure of the **Santa Fe Trail pedestrian bridge** over Garland Road/Gaston Avenue. At that time, TxDOT planned to temporarily close the pedestrian bridge starting at 7:00 a.m. on Monday, April 4th.

TxDOT has [delayed](#) closure of the Santa Fe Trail pedestrian bridge. Below is the text from TxDOT's press release:

“DALLAS – The temporary closure of the Santa Fe Trail pedestrian bridge over SH 78 (Garland Rd./Grand Ave.) in East Dallas is postponed until further notice while crews make additional revisions to the detour route. A new schedule will be shared as it is finalized.”

City staff will share more information as it becomes available.

APRIL 11TH – START OF WORK ZONE AWARENESS WEEK

Texas Department of Transportation (TxDOT), the Texas Department of Public Safety, and AAA launched the 2022 National Work Zone Awareness Week for the Dallas metro area on April 11th.

In the **past five years in the TxDOT Dallas District** (Dallas, Collin, Denton, Ellis, Kaufman, Navarro, and Rockwall counties) there were:

- Nearly **30,000 crashes** in work zones
- **13,000+ injuries** in work zone crashes
- **167 fatalities** in work zone crashes
- **Distracted driving**, including cell phone usage, is by far the **leading cause** of work zones crashes
- Driving under the influence and speeding are also contributing factors to work zone crashes.
- **In Dallas County, distracted driving crashes nearly doubled between 2020 and 2021**



Simple actions from drivers can be the difference between a safe drive or a crash in a work zone:

- **Slow down**
- **Pay attention**
- **Don't tailgate**

- Watch out for road crews
- Allow extra time





DART SERVICE CHANGES COMING APRIL 18

Effective Monday, April 18th, Dallas Area Rapid Transit (DART) will implement a series of **minor modifications to the New Bus Network** which launched on January 24th.

Future changes may be scheduled throughout 2022 based on careful consideration of rider feedback.

Bus Route Changes

- Bus routes **15 and 238** will have **slight route changes** starting April 18.



- **Route 423** (SWMD North Shuttle) **will no longer serve Clements University Hospital**. As a result, timepoints and departure times will be adjusted, but service frequency will remain unchanged.
 - The **South Shuttle Route will be unaffected**.
- Modifications are being made to improve on-time arrivals and departures to **routes 228 and 241**.
- There will be **minor schedule adjustments** on the following shuttle routes:
 - **408 (Galatyn Park)**
 - **412 (Medical City)**
 - **413 (TI Forest Lane)**
 - **417 (TI Main North)**
 - **419 (TI Main South)**

GoLink Changes

Several DART **GoLink zones will be expanded or modified** including the Park Cities GoLink, Preston Hollow GoLink, South Irving GoLink, East Irving GoLink, Inland Port GoLink, North Dallas GoLink, and South Central Plano GoLink.

Service levels on these and all other GoLink zones will continue to be carefully monitored and updated, based on performance and rider feedback.




RIVERFRONT BOULEVARD PROJECT

Engineering design of the Riverfront Boulevard project is approximately 90% complete.

The design firm is working on comments the City and Dallas County made on the design plans. The City and Dallas County with the assistance of NCTCOG staff continue to work with Union Pacific Railroad (UPRR) to address items within the UPRR right-of-way.

- Project is approximately 1.25 miles from **Cadiz** and **to just north of the Union Pacific Railroad** crossing (north of Commerce).
- Scope includes **improvement of roadway** with **provisions for bicycle lanes** in each direction and **enhanced sidewalks**.
- Scope also includes **water, wastewater and storm drainage** improvements.



Several key items impacting the construction start date are in the final stages of discussion with UPRR. These include placement of drainage in between the railroad bridge supports, ballast protection, and easements.

Once construction starts, it is anticipated the project will take three and a half years to construct.

GUEST SPEAKER

State Representative Jeff Leach was the guest speaker at the April 2022 Dallas Regional Mobility Coalition (DRMC) meeting. Representative Leach is in his fifth term service in House District 67 which includes portions of Plano, Allen, Richardson and Dallas in Collin County. He chairs the House Committee on Judiciary & Civil Jurisprudence and also serves on the House Committee on Juvenile Justice and Family Issues.

Representative Leach said he thought the next Legislative Session would focus on “meat and potatoes” issues including infrastructure, water, education, and transportation. He specifically stated that transportation is an important component of Texas’ future.

Representative Leach was asked if he expects changes to Senate Bill 2, the 2021 property tax reform bill. He said he does expect changes but does not have any specifics as to what the changes will be. Furthermore, he stated he expects an omnibus plan for property tax relief to be part of the 2023 Session.

He mentioned that there is an April 26th hearing on electric vehicle contributions and said that will be a topic of interest during the next Session.

INTERNATIONAL SERVICE EXPANSION

On **March 27, 2022**, **Finnair** began its inaugural non-stop **service between DFW Airport and Helsinki** that will operate four times a week.

This new route will connect DFW, American Airlines’ largest hub, to Helsinki, Finnair’s largest hub, and provide North Texas customers a new connection to over 70 cities in Europe.

Air France resumed service with non-stop service to Paris five times a week on a 280-seat Boeing 777-200ER.

Air Canada has resumed non-stop service to Montreal, beginning with five times a week flights.

Turkish Airlines has increased its flight to Istanbul to daily non-stop service from DFW Airport.

Finally, **Qantas Airlines announced that it will launch new non-stop service between DFW and Melbourne, Australia starting December 2, 2022**. DFW will be the only destination not located on the west coast of the U.S. with this service. This is in addition to Qantas' service to Sydney that resumed on February 16, 2022.



- The FY 22 IMP includes 782 street projects; 374 (48%) projects have been completed as of March 2022
- Pavement Condition Index (PCI) ratings are updated once completed first year's work
- Next data asset collection beginning of FY 23 to be utilized for next bond



Streets



- A new paving model was implemented in October 2021
- In addition to PCI, Public Works is evaluating other pavement health metrics to add as a data point in our street deterioration curves
- Moving forward , we will need asset assessments every 2 years to enhance our deterioration curves
- Price and inflation also play an important role in paving model success



Streets



- Previous and current model did not account for price inflation
- After the past year, we are now evaluating the inclusion of a moderate inflation rate
- Expecting future construction contracts to be impacted by inflation, which will reduce lane miles and impact PCI




Five-Year IMP - Sidewalks

 - In June 2021, Public Works completed the City's first Sidewalk Master Plan.

Sidewalk Project Scoring Criteria





Five-Year IMP - Sidewalks



- The FY 22 IMP has 14 planned projects and as of March 2022, 8 (57%) of those projects have been completed
- Sidewalk Funding for initial \$30M in projects included in the Sidewalk Master Plan:
 - FY 21-23 budgets included/assumes \$15.4M for Sidewalk Master Plan projects
 - A total of \$14.6M is needed in future budgets to complete the first \$30M of priority projects identified in the Sidewalk Master Plan
- Once the initial \$30M in Sidewalk Master Plan projects are funded, the Sidewalk Master Plan will be recalibrated based on scoring criteria and site changes (new parks, transit, etc.)



Alleys – Unimproved Alley Clean Up



- Work done by contractor funded through \$4M in ARPA funds (not included in the IMP)
- To date, all 1,363 unimproved alleys have had:
 - Vegetation cut back
 - Large debris removed
- Neighborhoods now have a clean slate to maintain the alleys
- As alleys were cleaned, a list of the completed alleys were provided to Code Compliance for follow-up






Alleys - Unimproved

- Council authorized to purchase on February 9, 2022, to utilize reclaimed asphalt pavement for unimproved alleys
- The equipment will be delivered in May due to nation-wide supply chain issues
- The goal is to complete the program by end of September

Alleys - Improved



- Scheduled for FY 22 – 1st year of program
 - Work to be done in house
- FY 23 and beyond will have stand-alone contracts
 - Evaluating the creation of 4 smaller contract opportunities (\$500K each/\$2M total) per year to support M/WBE contractors



Bridges



- Number of Bridges or culverts: 762
- Inspected by TxDOT every 2 years
- TxDOT Ratings
 - 7 Components with separate ratings
 - Scores 1 – 9; 9 being the best
 - Threshold is 4, anything 4 or below requires immediate repair
- Bridges with a component score of 6 or less, we are monitoring



Bridges



- Will advertise the first annual maintenance contract for bridges, June 2022, will address many of the 177 bridges with score 6 or less
- Contract will be for routine maintenance items, guard rail repairs, minor deck replacements, etc
- Anticipate taking contract to council in September or October 2022, will be subject to annual appropriations

Neighborhood Traffic Calming Program (NTCP)



- In 2021, the Department of Transportation began developing an updated traffic calming program and policy, with the following goals:
 - Define and update the required steps for traffic calming requests
 - Update policies and approaches to utilize new tools and strategies
 - Reliance on data to inform decision making



Neighborhood Traffic Calming Program (NTCP)



- Traffic calming tools & strategies vary based on the roadway conditions, road classifications, site conditions, etc.
- The NTCP will take an incremental approach, focusing on initial assessment of existing conditions such as signs, pavement markings, and related items
- Based on the initial assessment, traffic calming strategies can be considered



Traffic Calming – Factors to Consider



- Vehicle speeds
- Reported crashes
- Vehicle and/ or pedestrian volumes
- Proximity to schools, hospitals, parks, and other pedestrian generators
- Roadway topography and geometry
- Site specific conditions (i.e., site distance, emergency or transit routes, existing bike lanes, driveway density, etc.)



Traffic Calming Strategies



- Horizontal deflection: hinders the ability for a motorist to drive in a straight line by creating a horizontal shift in the roadway. This shift forces a motorist to slow the vehicle in order to comfortably navigate the measure.
- Vertical deflection: creates a change in the height of the roadway which forces a motorist to slow down to maintain an acceptable level of comfort.
- Street width reduction: narrows the width of a vehicle travel lane. As a result, a motorist slows the vehicle in order to maintain an acceptable level of comfort and safety.

Requests for Traffic Calming



- An updated and standardized service request process through 311 has been developed, along with a standard operating procedure for staff, which will:
 - Create standardized and familiar approach to address traffic safety concerns and ensure equity in the evaluation of requests
 - Provide process tracking and a consistent point of contact for solutions being implemented
 - Promote community engagement with prompt and/or longer-term traffic calming solution planning

Note: The Traffic Safety Engineering team receives approximately 1500 service requests per year and currently operates with five dedicated engineers.



Service Request Process



- Steps in the process:
 - Create a “Traffic Safety Concern” Service Request through 311 (available on app or by calling 311) with a 60-day service level agreement
 - Department of Transportation Engineering team will review the service request, contact the requestor for additional information (as needed), complete a site visit to better understand the roadway dynamics and driver behavior, and develop recommendations within an “Engineering, Education, or Enforcement” framework
 - If an engineering solution is recommended, staff will coordinate with the requestor to route a petition to ensure support of at least 2/3 of impacted property owners



Project Prioritization



- All eligible “low-cost” locations will be implemented on a first come, first serve basis
- Capital projects will be funded through a variety of funding mechanisms, and will be in a separate category of projects
- As funding is utilized, an inventory of eligible locations will be developed and prioritized

Traffic Calming Funding



- FY 2020-2021 Budget: \$500,000 in dedicated neighborhood traffic calming funding
- FY 2021-2022 Budget: \$1,000,000 in dedicated traffic calming funding
 - An additional \$200,000 was provided for the street racing pilot program, which is primarily for arterial roadways
- Low-cost projects (example: speed cushions) versus capital projects



Proposed Action



- City Council approval of Traffic Calming Policy via resolution in Summer 2022
- Internal and external communication and outreach about the Traffic Calming Program



Staff Recommendation



- Staff recommends the Committee forward the following to City Council for consideration and approval:
 - Adoption of Traffic Calming Policy & Program which will replace the outdated existing policies

- The purpose of this publication is to provide a high-level understanding of the Neighborhood Traffic Calming Program (NTCP) for residential and mixed-use roads including the criteria, steps, and goals of pursuing a traffic calming project.
- Steps, qualifications, project determination tables, evaluation methods are listed but not exhaustive.
- This Policy is subject to modification based on any new best practices widely accepted by relevant agencies.
- This Neighborhood Traffic Calming Policy is designed to replace the requirements outlined in the previous Road Hump and Street Closure Policies.
- The guidelines in this Policy take into consideration the street design recommendations of the City of Dallas Complete Streets Design Manual (2016), Vision Zero (2021), Bike Plan (2022), Curb Lane Management Policy, and Thoroughfare Management Plan.
- All implementations will follow best practices set forth by the Institute of Traffic Engineers (ITE), the National Association of City Transportation Officials (NACTO), the Federal Highway Administration (FHWA); state, regional, and industry standards, and already-built traffic calming projects in cities across the United States.

Policy Statement

Traffic Calming is the application of techniques at a specific location which result in a reduction in vehicular speeds, traffic volumes, traffic noise, incidents and/or a combination of them. The techniques are based on a combination of engineering, education, and enforcement and may include educational programs, improvements in traffic signing and markings, speed limits reductions, or physical changes to the roadway to alter driving patterns.

The City of Dallas Department of Transportation (DDOT) is committed to maintaining and improving the safety, livability, and integrity of neighborhoods while also meeting the needs of multimodal roadway users. Speeding vehicles and unnecessary cut-through traffic in residential neighborhoods can create safety hazards and negatively affect livability. It is the Department of Transportation's goal to address traffic related problems in a manner least intrusive to the neighborhood and overall transportation network. To accomplish this goal, the department has developed this policy and accompanying procedures to assure a systematic and comprehensive approach to each situation.

The City of Dallas Neighborhood Traffic Calming Policy and Program (NTCP) establishes a process for receiving requests, determining eligibility, and collaboratively working with residents to develop solutions which best address the noted concerns. By following this policy, it will provide an appropriate and consistent application of traffic calming measures throughout Dallas' residential streets. The support of the residents where traffic calming is being considered is critical to the success of any neighborhood traffic calming program and therefore, they must be an integral part of the process.

This policy is supported by following best practices set forth by the Institute of Traffic Engineers (ITE), the National Association of City Transportation Officials (NACTO), the Federal Highway Administration (FHWA); state, regional, and industry standards and best practices, and already-built traffic calming projects in cities across the United States. This traffic calming policy is intended to build on the guiding principles set forth in the Strategic Mobility Plan, Connect Dallas, and the Vision Zero Action Plan.

We will achieve traffic calming in appropriate locations through a combination of Engineering, Education, and Enforcement. Coordination with the Dallas Police Department (DPD), Dallas Fire-Rescue (DFR), neighborhood organizations, and other stakeholders will ensure program effectiveness.

Purpose

The Neighborhood Traffic Calming Program (NTCP) represents an important milestone in the development and consistent application of various traffic calming solutions within the City of Dallas. This program addresses the need for specific traffic calming measures when other methods are not appropriate or no longer meet the needs of the neighborhood. Effective and efficient traffic calming measures may minimize negative vehicular impacts associated with

traffic within residential neighborhoods and could provide new or expanded active mobility opportunities for pedestrians, bicyclists, and transit use.

Some traffic concerns may not require the use of the neighborhood traffic calming. Traffic safety concerns will be addressed utilizing a combination of “the 3 Es” of engineering, education, and enforcement. The Department of Transportation traffic safety engineers coordinates with the Dallas Police Department (DPD) when enforcement is needed, ensures proposed traffic calming measures do not inhibit emergency response from Dallas Fire & Rescue (DFR) or DPD, and provides resident and motorist education. This type of transportation management establishes an integrated set of strategies to optimize the performance of existing and future infrastructure to improve equitable security, safety, and reliability in the transportation network.

This Neighborhood Traffic Calming Policy provides clarity to the “process for the planning, evaluation, and implementation of neighborhood traffic calming” ([FHWA, ePrimer](#)) and is designed to replace the outdated Road Hump Policy and Street Closure Policy.

Opportunities

The Neighborhood Traffic Calming Policy provides many opportunities for residents, as they are often the primary group interested in addressing vehicle speed and volume through their neighborhoods. It also provide opportunities for communities and other City of Dallas departments and government entities to collaborate to find the optimal solutions.

Residents:

- Defines consistent process steps to be followed each time
- Creates standardized and familiar approach to address traffic safety concerns
- Reiterates the relationship of “the 3 Es” – Engineering, Education, and Enforcement
- Provides process tracking and a single point of contact for solutions being implemented
- Promotes community engagement with prompt and/or longer-term traffic calming solution planning

Other Stakeholders

- Allows coordination with other City of Dallas departments and external entities such as neighboring cities, TxDOT, and utilities companies that may be impacted by proposed solutions and perceived solutions
 - e.g. Nearby construction is causing increased volume
 - Can another route to be considered?
 - Would better signage reduce/eliminate volume?
 - Would a temporary solution to address the temporary inconvenience suffice instead of installing a permanent solution envisioned by residents?
 - e.g. Add better solutions to capital improvement projects
 - Traffic circle and raised table vs. series of road humps

Goals

The goals of the Neighborhood Traffic Calming Program take into consideration design standards applicable design manuals and standards and planning documents.

These goals are:

- Providing residential neighborhoods potential solutions to mitigate unsafe vehicle speeds and/or volume of non-local traffic in residential areas.
- Mitigating safety risks on the City's transportation infrastructure through quality planning, engineering, parking management, illuminated streets, well-operating signals, and clear markings and signage for our multimodal system.
- Providing for multiple transportation modes-pedestrian, bicycle, transit, and automobile-and include environmentally sustainable solutions appropriate for the situations.
- Utilizing quantifiable data and innovation to create responsible and effective mobility solutions which maximizes the transportation network operating efficiency.

Eligibility for Neighborhood Traffic Calming Program (NTCP)


Traffic calming measures should be implemented only after the existing traffic conditions have been studied and it has been determined that traffic challenges exist with speeding or unusually high traffic volumes. Traffic safety concerns can be addressed utilizing engineering applications, enforcement , and/or education of the specific traffic concern at hand.

Traffic engineers will indicate when and where the Neighborhood Traffic Calming Program is necessary.

The following steps outline the process a resident can follow to initiating the NTCP.

A. 	Requestor identifies a Traffic Safety Concern <u>and</u> submits a service request through Dallas' 311 system <ul style="list-style-type: none">• Include as much details as possible
B. 	Department of Transportation (DDOT) traffic engineer responds to Traffic Safety Concern service request <p>Response activities may include:</p> <ul style="list-style-type: none">• Contacting requestor for additional information• Forwarding the service request to other City department or partnering agency for proper handling• Conducting initial site assessment• Begin necessary engineering studies

C.



DDOT communicates to requestor outcome of the service request.

All services requests will result in at least one of the following outcomes:

- **Engineering** – Apply engineering principles and best practices to improve on the effectiveness and functionality of roadways by factoring in safety for all road users.
 - Prompt engineering solutions that can be resolved within 75 days, such as traffic signs or markings, will have a work order created by the appropriate district engineer
 - Longer-term engineering solutions, such as speed cushions or road diets, will be referred to the Neighborhood Traffic Calming Program Coordinator.
- **Education** - Provide information or instruction regarding pertinent ordinances, laws, and best practices that govern bicyclists', pedestrians', and motorists' movements and operations.
- **Enforcement** – Partner with Dallas Police Department for added police presence, speed deterrence, and targeted enforcement.

Factors to Consider

When evaluating neighborhood streets, the primary factors considered by the traffic engineers are speed, volume, reported crashes, and roadway topography of the street. Each request is independently evaluated based on its location, roadway use, and unique site conditions for traffic calming strategies, therefore what may work for one neighborhood may not be the best solution for another, even if they are in the same general area.

Speed

The speed limit is an essential element of neighborhood traffic safety. Speed limits are considered reasonable when the majority of drivers can operate their vehicle and have the awareness of all neighborhood elements (i.e. schools, parks, pedestrians, other drivers and roadway users, and site-specific features). While higher speeds contribute to heightened potential of incidents on the roadway, speeds that are set too low can also create unsafe roadway conditions. If a formal traffic study is ordered, the traffic safety engineer evaluates the speed of the road users and determines if 85% or more of the vehicles in the study were traveling at or below the posted speed limit. This is known as the “85th percentile speed” and is a standard measure in traffic engineering. *NOTE: Texas Transportation Code 545.352 prima facie speed limit for urban districts is 30 MPH*

Volume

The number of vehicles on a roadway is considered as its volume. Volume in respect to traffic calming measures are generally low. Local internal residential streets with posted speed limits less than or equal to 30 MPH is the target for Neighborhood Traffic Calming Program (NTCP). Neighborhoods also have collector roads with the sole purpose of collecting interior neighborhood traffic and routing them to a larger roadway to accommodate and facilitate traffic movement. To provide safer traffic operation conditions inside our neighborhoods, we must manage the volume and its traffic characteristics and behavior to accomplish safety on our internal neighborhood streets.

Reported Crashes

Crashes are incidents that disrupt or stop traffic. Information collected by various investigation authorities is kept by Texas Department of Transportation (TxDOT) in a database that DDOT uses to aid in the evaluation of safe vehicle operation per unique site conditions. DDOT reviews the previous 24 months of *reported* crashes and the valuable information it contains. These datapoints contribute to determining the best traffic calming resolution.



Roadway Topography

The roadway topography includes the road's geometry plus the unique site conditions, e.g. trees, curves and slopes of land, and man-made physical features, homes, buildings, etc. These elements contribute to a driver's ability to safely move along the roadway and for other roadway users to interact with moving vehicles. DDOT uses this information to aid in the assessment of traffic calming enhancements for the NTCP. The combination of the natural features and man-made features with the geometry of the road in question affects the possible traffic calming solutions that can be implemented.

NTCP – Request Evaluation Process

After the traffic engineer evaluates and assesses the traffic safety concern, s/he will determine eligibility for the Neighborhood Traffic Calming Program. If eligible, the traffic safety concern is transferred to the NTCP's coordinator, along with all the supporting documentation obtained from the initial receipt of the service request to the results and interpretations of the traffic study.

Once the NTCP Coordinator has reviewed the documentation and determined the best and most feasible solutions, s/he will contact the initiating Requestor to discuss the possible solutions and any required documentation.

NTCP – Preparing and Installation

For each proposed project through the Neighborhood Traffic Calming Program, there is required documentation.

At a minimum, the Requestor will be required to fill out a survey that gathers signatures from 2/3 of the adjacent property owners and residents along the petitioned street.

The petition will include at a minimum the following information, so residents signing for/against the proposed solution will be informed:

- Description of impacted areas, with map identifying boundary zone
- Description of problem: speeding, cut-through traffic, etc.
- Number of elementary or middle schools
- Pedestrian generators, within or adjacent to requested street
- Adjacent land use
- Roadway type (e.g. arterial, collector, local residential)
- Number of reported crashes within past 24 months (fatalities & injuries)
- Traffic volumes; amount of traffic in each direction
- Existing speed limit on roadway within impacted area
- 85th percentile speed in both directions within petition area

Additionally, the Department will engage in public outreach with the community in the preparation of a traffic calming plan for the identified project area. This will always occur whether the project is reactive (responding to a Requestor’s traffic safety concern) or proactive (DDOT staff identifying problems and initiating action prior to complaints, crashes, and other adverse consequences).

Notice and outreach may include original request for traffic calming, neighborhood associations, community organizations, business owners, and any other stakeholders within the impacted area deemed essential by DDOT.

Once outreach is completed and all considerations are made, the project coordinator will create a final draft design, timeline for implementation, expected outcomes and method of measuring expected outcomes.

NTCP – Monitoring and Evaluation

A post implementation traffic evaluation may be conducted to ensure the planned outcome is achieved and the traffic calming measure is effective. If a project does not meet its objectives, additional measures may be considered with respect to available funding. A measure not fully effective does not automatically justify removal.

Measures of Effectiveness (MOE)

At the end of any project, the work completed should be reviewed and measured to determine if what was done meets the needs of the neighborhood. There are two primary categories that measure the effectiveness of traffic calming devices - *devices that reduce speed* and *devices that reduce volume*.

Devices to *reduce speed* have the goal of reducing excessive neighborhood speeds to acceptable levels. Common examples may include road humps/speed cushions.

Devices to *reduce volume* have the goal to reduce cut-through traffic on local residential roads that should otherwise be traveling on collector roads.

Maintenance

The City of Dallas embraces infrastructure and safety improvements. It's important to consider who is responsible to maintain these improvements over time. Planned projects must have an agreed-upon maintenance agreement to move forward with installation and construction.

Any necessary maintenance related to transportation improvements will be the responsibility of the City. The installation of signage and marking must conform to DDOT standards and the Texas Manual on Uniform Traffic Control Devices (TMUTCD).

Removal of an Improvement

DDOT reserves the right to modify or remove any traffic calming measure for traffic safety or emergency response needs. If DDOT determines that a measure should be modified or removed, notification will be made to the adjacent property owners and residents along the petitioned street.

If neighborhood representatives would like to have a traffic calming measure modified or removed, the process is the same as for installation and it is subject to review by the Assistant Director or Director of Transportation. A Neighborhood Traffic Management survey with signatures from property owners representing at least 2/3 of the adjacent property owners and residents along the petitioned street.

Definitions

- Collector road – a street with the sole purpose of collecting interior neighborhood traffic and routing them to a larger roadway
- Community survey – a benchmarking document to determine the neighborhood consensus for traffic calming implementation
- DDOT – the City of Dallas Department of Transportation
- Neighborhood traffic calming – the effort of traffic calming a primarily residential area ([FHWA, ePrimer](#))
- Neighborhood Traffic Calming Program (NTCP) – strategies and processes DDOT uses to “reduce automobile speeds or volumes, mainly through the use of physical measures, to improve the quality of life in both residential and commercial areas and increase the safety and comfort of walking and bicycling” ([FHWA, ePrimer](#))
- NTCP Manual – a guide providing design criteria and means and methods for proposing the most feasible solutions
- Residential street – all local interior streets to a neighborhood

SUBJECT **I-345 Feasibility Study Upcoming TxDOT Public Meetings**

The Texas Department of Transportation (TxDOT) will be hosting public meetings on May 24, 2022 and May 26, 2022 to present and solicit public input on the recommended alternative for the future of I-345.

Background:

Interstate 345 (I-345) is located on the east side of Downtown Dallas and carries traffic between I-30, US 75/I-45 and Woodall Rodgers Freeway (Spur 366). More than 180,000 vehicles use the 1.4-mile roadway every day. TxDOT has been conducting a feasibility study of I-345 to take the concepts created through the Dallas CityMAP process and develop refined alternatives, evaluate the alternatives, and identify a preferred alternative that would be recommended for inclusion in the regional long-range transportation plan (Mobility 2045 Update, or its successor). Once the preferred alternative has been added to the regional long-range transportation plan, the North Central Texas Council of Governments (NCTCOG) and TxDOT could begin working to secure funding engineering and construction.

Two rounds of public engagement have been held thus far as part of the feasibility study:

1. Initial public meetings were held in December 2019 to provide the public with preliminary information about the project and to ask for feedback, including the identification of environmental constraints and/or issues that need to be addressed during the environmental analysis.
2. The second round of public meetings was held in June 2021 to preview five alternatives and get feedback.

Planned May 2022 Public Meetings:

The purpose of the public meetings is to present information on the I-345 feasibility study process and receive feedback from the public on the preferred alternative for the future of I-345.





SUBJECT **Proposed Changes to Chapter 42A Sec. 22 and 28.2 of the Dallas City Code**

Outlined in this memorandum are two amendments to the existing *Chapter 42A, "Special Events; Neighborhood Markets; Dallas Street Seats; Dallas Farmers Market Farmers Market; Streetlight Pole Banners"* of the Dallas City Code. Convention and Event Services – Office of Special Events (CES-OSE) has provided an overview of these changes respective to Neighborhood Markets and the Dallas Street Seats Pilot Program.

As Chapter 42A serves as gateway and guide for the public who host various temporary outdoor activations throughout the city, two council committees have been involved in stewarding the chapter since 2020: Transportation and Infrastructure and the Quality of Life, Arts & Culture (QoLAC) committees. Originally, QoLAC exercised primary policy recommendation authority over Chapter 42A. With the addition of the Temporary Parklet and Dallas Street Seats Pilot Program, the Transportation and Infrastructure Committee was added to the policy oversight of this ordinance as these programs take place in the city right-of-way. As such, please accept this dual memorandum to ensure the proposed ordinance changes are communicated in a timely manner across both committees.

As outlined in the May 25, 2022 draft agenda as Item 36, CES-OSE is recommending the amendment of two sections of the existing *Chapter 42A* as follows:

1. *Sec. 22 Location of a Neighborhood Market* provides an exception for residential properties with a valid certificate of occupancy for a non-residential use for Neighborhood Markets by adding the underlined language below:
A neighborhood market may not be conducted:
 - (1) in the central business district;
 - (2) in a single family, duplex, or townhouse zoning district as defined in the Dallas Development Code, except in the case that the location has a valid Certificate of Occupancy for a non-residential use or by special exception granted by the director on a case-by-case basis;
 - (3) within one mile of another neighborhood market permitted under this chapter that has the same or overlapping operating dates and times;
 - (4) at any location where one or more neighborhood markets have already been conducted a total of 28 days during the particular calendar year;
 - (5) at any location other than the one listed in the permit application;
 - (6) at a public park; or
 - (7) on a sidewalk.

2. *Sec. 28.2 Application Issuance for the Dallas Street Seats Pilot Program* adds an additional year to the pilot to give applicants more time to complete the requirements of the program, extending the program through July 31, 2023.

Chapter 42A Section 22 - Neighborhood Market Program

To clarify the requirements under the *Location of a Neighborhood Market* section of the code, CES-OSE collaborated with Planning & Urban Design, Building Inspection, Code Compliance, and outside partners to add language that encourages equity and food access.

As currently written, the ordinance does not allow for Neighborhood Markets to be held in a single family, duplex, or townhouse zoning district as defined in the Dallas Development Code (Chapter 51A). City staff have recommended the addition of language that allows for an exception for properties with valid certificates of occupancy for a non-residential use. This would allow for the permitting of markets at schools, churches, and other non-residential uses allowable under the underlying zoning district.

Special Event Permits are for temporary activations (60 days in a calendar year) and are tied to additional temporary type permits from other departments, including, but not limited to Temporary Health Permits that have higher fees. In comparison, the Neighborhood Market Permit program has been designed for permit applicants and their vendors to have easy access to affordable permits from all departments.

CES-OSE is currently working with two clients, For Oak Cliff and Good Local Markets – White Rock, that do not presently meet the zoning requirements for a Neighborhood Market as outlined in Chapter 42A. Thus, they have been required to obtain a Special Event Permit which is allowed under their chosen residentially zoned properties. The amendment recommended in the agenda item offers an exception that alleviates this challenge.

Dallas Street Seats Pilot Program

CES-OSE launched the Temporary Parklet Program on May 18, 2020, as authorized by the COVID-19 Economic Recovery and Assistance Ad Hoc Committee. On June 24, 2020, City Council approved amendments to the Special Events Ordinance - Chapter 42A by Council Resolution No. 20-0970 allowing the permitting of temporary parklets through December 31, 2020. On December 9, 2020, City Council approved Ordinance No. 31708, an extension of the temporary parklet program through April 30, 2021. Concurrently, City Council approved amendments to Chapter 42A to create the “Dallas Street Seats Pilot Program.”

The Dallas Street Seats Pilot Program was originally slated to end on July 31, 2022. With the ongoing pandemic and the level of financial investment required to construct the street seat, the onboarding process of applicants has taken longer than anticipated. To allow more time for the Dallas Street Seats Pilot Program to develop and increase participation, CES-OSE staff seeks to extend the program through July 31, 2023.

MAY 12, 2022, REGIONAL TRANSPORTATION COUNCIL ITEMS OF INTEREST ([LINK TO COMPLETE AGENDA AND MATERIALS](#))

- **CHANGING MOBILITY: DATA, INSIGHTS, AND DELIVERING INNOVATIVE PROJECTS DURING COVID RECOVERY**
 - Michael Morris, NCTCOG Director of Transportation, presented data regarding travel behavior, roadway trends, transit trends, bicycle and pedestrian trends, airport trends, and the funding impact COVID has had on the region. As of February 2022, Bicycle and pedestrian travel has increased by 28%, while freeway volumes, toll road, airport passengers, and transit ridership has decreased by 2%, 13%, 21% and 43% (in the order listed).
- **AIR QUALITY FUNDING OPPORTUNITIES FOR VEHICLES**
 - There are several funding opportunities for projects that address air quality, including clean vehicle projects, available through federal, state, local, and non-profit entities. Additionally, NCTCOG has evaluated all applications received for the “Electric Vehicle Charging Station Call For Projects”. The amount requested exceeded the available funding and NCTCOG does not plan on holding a second round of applications. - **FISCAL YEAR 2022 MULTIMODAL PROJECT DISCRETIONARY GRANT PROGRAM**
 - This grant program is \$2.85 billion dollars for three combined funding opportunities: the National Infrastructure Project Assistance Grants Program (MEGA), the Nationally Significant Multimodal Freight and Highway Projects Grant Program (INFRA), and the Rural Surface Transportation Grant Program (RURAL). For the eastern subregion, NCTCOG proposes submitting the South Dallas County Inland Port Multimodal Connectivity Project and partnering with TxDOT to resubmit the IH 30 Canyon project. For the western subregion, NCTCOG proposes to resubmit the East Lancaster Avenue Complete Streets and Transit Technology Project.





DFW AIRPORT IS 2ND BUSIEST AIRPORT IN THE WORLD

Dallas Fort Worth International Airport (DFW) welcomed more than 62.5 million passengers in 2021 making **DFW the second busiest in the world by passenger volume** according to Airports Council International (ACI).

DFW saw a 58.7% growth over 2020 and has its sights set on returning to 2019 numbers in 2022. This increase showcases DFW's collaboration with airline partners who continue to expand their routes and services at the Airport. As one of the only airports in the U.S. to increase service and the number of destinations served over the past two years, DFW focuses on customer experience as the Airport continues as a leader in the industry. The Airport has implemented numerous advancements to enhance the customer's experience like ultraviolet-C (UV-C) lighting within the ventilation system to better clean circulated air, automated self-bag drops, smart restrooms and other innovative solutions to best serve customers.

The ACI report also recognized DFW as the world's most connected airport for the second consecutive year by offering more convenient connection opportunities than any other hub airport in the world. DFW also was listed as **the third busiest airport in terms of flights for the third consecutive year**.

DFW HITS CARGO MILESTONE

Dallas Fort Worth International Airport (DFW) announced at the 2022 International Air Cargo Association (TIACA) Executive Summit in San Francisco that the Airport **achieved a major milestone of moving one million U.S. tons of cargo in calendar year 2021**. This milestone is significant because of its impact on the local economy as well as being an indicator of growth for the Airport and the North Texas region.

This feat was driven by ongoing shifts in the global supply chain, including a shift from ocean to air freight. The Airport has also worked to streamline processes and gain efficiencies, avoiding the congestion seen at other major air cargo gateways.

A key component in DFW's strategy is to invest in systems that accelerate digitization of the cargo ecosystem, including the DFW Cargo Cloud. The DFW Cloud is an open-architecture digital data-sharing platform that allows cargo community members to seamlessly and securely exchange data, reduce paperwork and facilitate efficient transactions and handoffs between partners.
