WHEREAS, on January 13, 2021, the City Council authorized a three-year service price agreement, with two one-year renewal options, for reflective lane striping services for the Department of Transportation with Elite Striping, LLC dba Action Services, in an estimated amount of \$15,332,904.86, by Resolution No. 21-2143; and

WHEREAS, on January 22, 2024, Administrative Action 24-5141 authorized Supplemental Agreement No. 1 to exercise the first of two one-year renewal options for reflective lane striping services with Elite Striping, LLC dba Action Services, with zero cost, having no effect on the contract amount; and

WHEREAS, on January 14, 2025, Administrative Action No. 25-5218 authorized Supplemental Agreement No. 2 to exercise the second of two one-year renewal options for reflective lane striping services with Elite Striping, LLC dba Action Services, with zero cost, having no effect on the contract amount.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the City Manager is hereby authorized to execute a service price agreement with The Confidence Group dba Confidence (VS99658) in the estimated amount of \$5,360,099.58, Elite Striping, LLC dba Action Services (VS100373) in the estimated amount of \$4,428,768.50, and ABH Pros LLP (VC0000034812) in the estimated amount of \$2,795,297.95, approved as to form by the City Attorney, for reflective lane striping services for the Department of Transportation and Public Works for a term of three years, in the total estimated amount of \$12,584,166.03. The amount payable pursuant to this service price agreement may exceed the estimated amount, but may not exceed the amount of budgetary appropriations for this service price agreement during its term. Payments made to The Confidence Group, Elite Striping, LLC, and ABH Pros LLP shall be based only on the amount of the services directed to be performed by the City and properly performed by The Confidence Group dba Confidence, Elite Striping, LLC dba Action Services, and ABH Pros LLP under the service price agreement. The City Manager is further authorized, in the City Manager's sole discretion, to exercise an option to extend the agreement for six months by filing a notice of extension with the City Secretary's Office.

SECTION 2. That the Chief Financial Officer is hereby authorized to disburse funds in an estimated amount of at least \$12,584,166.03 (subject to annual appropriations), but not more than the amount of budgetary appropriations for this service price agreement during its term to The Confidence Group dba Confidence, Elite Striping, LLC dba Action Services, and ABH Pros LLP Group from Service Price Agreement Contract No. PBW-2025-00028402.
