Being 4,851 square feet (0.111 acres) of land located in the Samuel Lockhart Survey, Abstract No. 817, Dallas County, Texas, being in the right-of-way of Manufacturing Street (80' right of way) described in the plat of Installation No. 11-A of the Trinity Industrial District recorded in Volume 77036, Page 2182, Deed Records, Dallas County, Texas, lying in Dallas City Block 7891 and along the west line of a tract of land described in the General Warranty Deed to San Jacinto Operating Company, recorded in County Clerk's Instrument No. 201800262324, Deed Records, Dallas County, Texas. Said 4,851 square feet (0.111 acres) of land being more particularly described as follows:

BEGINNING at a point in the east line of said Manufacturing Street and in the west line of said San Jacinto Operating Company tract, lying N09°30'39"E a distance 23.34 feet from a pk with shiner found at the southwest corner of said San Jacinto Operating Company tract;

THENCE N80°29'21"W, a distance of 19.80 feet to a point;

THENCE N09°30'39"E, a distance of 245.00 feet to a point;

THENCE S80°29'21"E, a distance of 19.80 feet to a point in the east line of said Manufacturing Street and in the west line of San Jacinto Operating Company tract, lying S09°30'39"W a distance 31.71 feet from a "X" found at the northwest corner of said San Jacinto Operating Company tract;

THENCE S09°30'39"W along said east line and said west line, a distance of 245.00 feet to the point of beginning, containing 4,851 square feet (0.111 acres) of land.

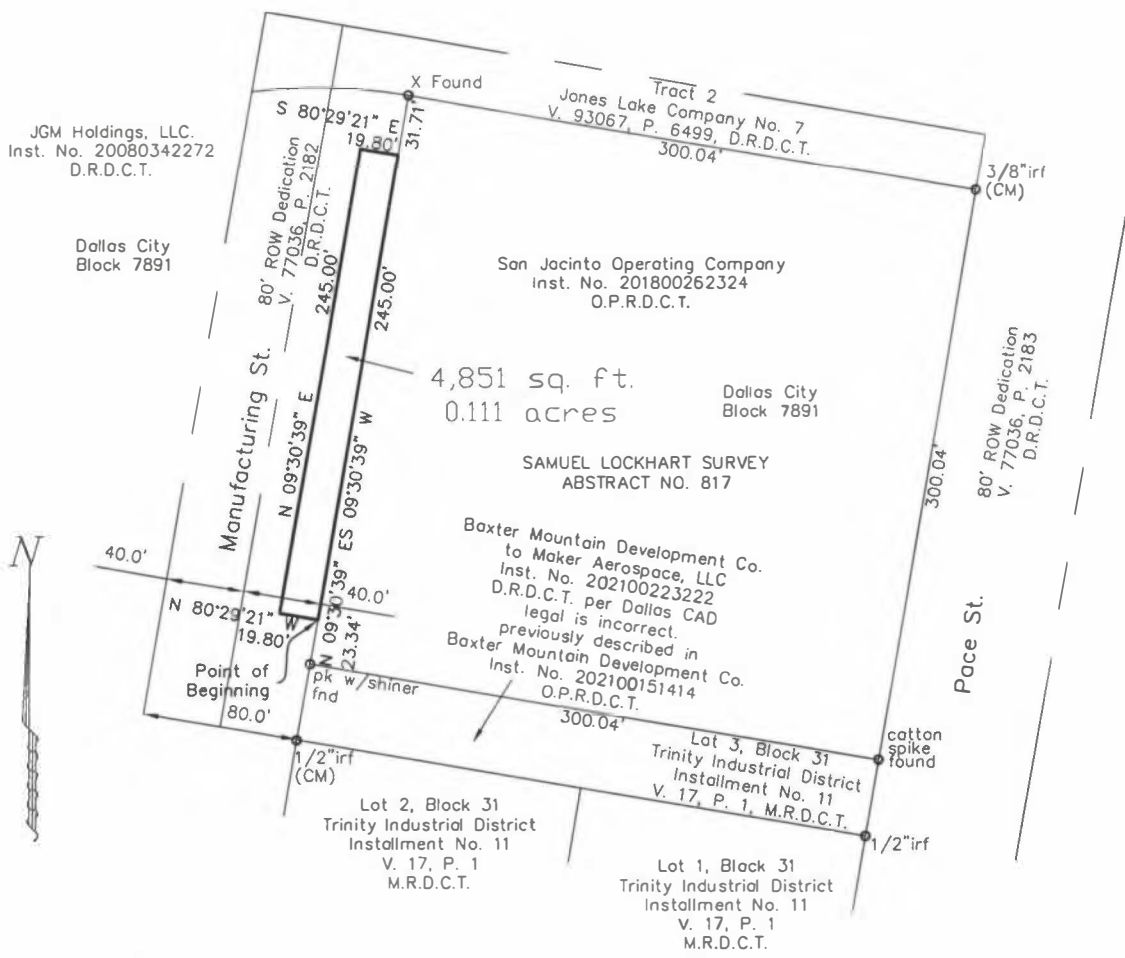

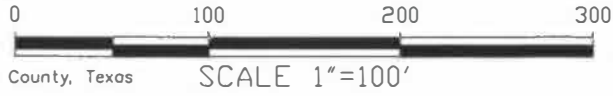
