WHEREAS, the federal off-system Highway Bridge Replacement and Rehabilitation Program is administered by the Texas Department of Transportation (TxDOT) to replace or rehabilitate structurally deficient and functionally obsolete bridges located on public roads and streets off the designated state highway system; and

WHEREAS, the City of Dallas owns the bridge located at Houston Street over Interstate Highway (IH) 30 and Trinity River (Route 178), National Bridge Inventory Structure No. 180570000911079, State Control-Section-Job (CSJ) No. 0918-47-511 ("Project"); and

WHEREAS, the Project is currently approved in the Highway Bridge Replacement and Rehabilitation Program, as authorized by the Texas Transportation Commission Minute Order No. 116522 dated August 16, 2023; and

WHEREAS, on June 11, 2025, the City Council authorized a request for waiver of the local match fund participation requirement on the following bridges to be replaced or rehabilitated under the federal off-system bridge program: Houston Street over IH-30 and Trinity River (CSJ No. 0918-47-511), and Jefferson Boulevard over IH-30 and Trinity River (CSJ No. 0918-47-512), by committing to perform or cause to be performed structural improvements to the bridge on State Highway 356 (Irving Boulevard) over Elm Fork of the Trinity River by Resolution No. 25-0928; and

WHEREAS, the waiver request was approved by TxDOT on July 28, 2025; and

WHEREAS, TxDOT is the lead agency to complete the engineering and construction of the Project; and

WHEREAS, once all associated work is completed, TxDOT will issue a "Notification of Completion" to the City, and the City will accept full responsibility for the continued operation and maintenance of the bridge; and

WHEREAS, TxDOT requires that a City resolution or ordinance be made part of the AFA.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the City Manager, or the City Manager's designee, is hereby authorized to execute an Advance Funding Agreement with the Texas Department of Transportation (TxDOT) in the estimated amount of \$19,224,500.00 (Agreement No. CSJ 0918-47-511, Assistance Listing No. 20.205) for the replacement or rehabilitation of the bridge on Houston Street over Interstate Highway 30 and Trinity River (Route 178), National Bridge Inventory Structure No. 180570000911079, to be completed by TxDOT as part of the approved off-state system federal-aid Highway Bridge Replacement and Rehabilitation Program, and all terms, conditions, and documents required by the agreement, approved as to form by the City Attorney, or the City Attorney's authorized designee.

SECTION 2. That this contract is designated as Contract No. PBW-2025-00028899.

SECTION 3. That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
