Field Notes Describing a 4,430 Sq. Ft. (0.113 Ac.) Tract of Land in Block D/1131

Being a 4,430 Square Foot (0.113 Acre) tract of land lying in the Macum Main Survey, Abstract No. 995, City of Dallas, Dallas County, Texas, lying in Block D/1131 of Alexander's Revised Plat of Fetzer's Addition, an addition to the City of Dallas recorded in Volume 200, Page 472 of the Deed Records of Dallas County, Texas and being a part of Lots 13, 14 and 15 conveyed to the City of Dallas by deed recorded in Volume 74006, Page 551 and being more particularly described as follows:

All Coordinates shown are On Datum, State Plane Coordinate System, Texas North Central Zone 4202, North American Datum of 1983, Realization of 2011, No Scale, No Projection.

BEGINNING at a ½-inch diameter iron rod (Controlling Monument) found on the Southwest Right-of-Way line of Colonial Avenue (a 48-foot-wide public street), at the most Northerly corner of said Lot 13, being also the most Easterly corner of Lot 12 of the property conveyed to the Cornerstone Baptist Church of Dallas, Inc. by deed recorded in Instrument Number 202100064901 of the Official Public Records of Dallas County, Texas (N=6964694.14; E=2497970.76) *FROM WHICH* a ½-inch diameter iron rod (Controlling Monument) found at the intersection of the said Southwest line of Colonial Avenue with the Southeast Right-of-Way line of South Boulevard (a variable width public street) bears North 45°23'51" West a distance of 113.97 feet (N=6964774.16; E=2497889.62):

THENCE South 45°23'51" East with the said Southwest line of Colonial Avenue a distance of 123.27 feet to a 5/8-inch diameter iron rod with cap marked "CITY OF DALLAS" set at the intersection of the Southwest line of Colonial Avenue with the North Right of-Way line of the Ervay Street / Colonial Avenue Connector (a variable width public street) (N=6964607.60; E=2498058.52) :

THENCE Northwesterly with the said North line of the Ervay / Colonial Connector and along a Curve to the Left, having a Radius of 549.41 feet, a Central Angle of 05°31'43", an Arc Length of 53.01 and a Chord which bears North 77°22'23" West a distance of 52.99 feet to a 5/8-inch diameter iron rod with cap marked "CITY OF DALLAS" set at the Point of Tangency (N=6964619.18; E=2498006.81):

THENCE North 80°08'14" West continuing with the said North line of the Ervay / Colonial Connector a distance of 92.17 feet to a 5/8-inch diameter iron rod set at the Point of Curvature of a Curve to the Right (N=6964634.97; E=2497916.02):

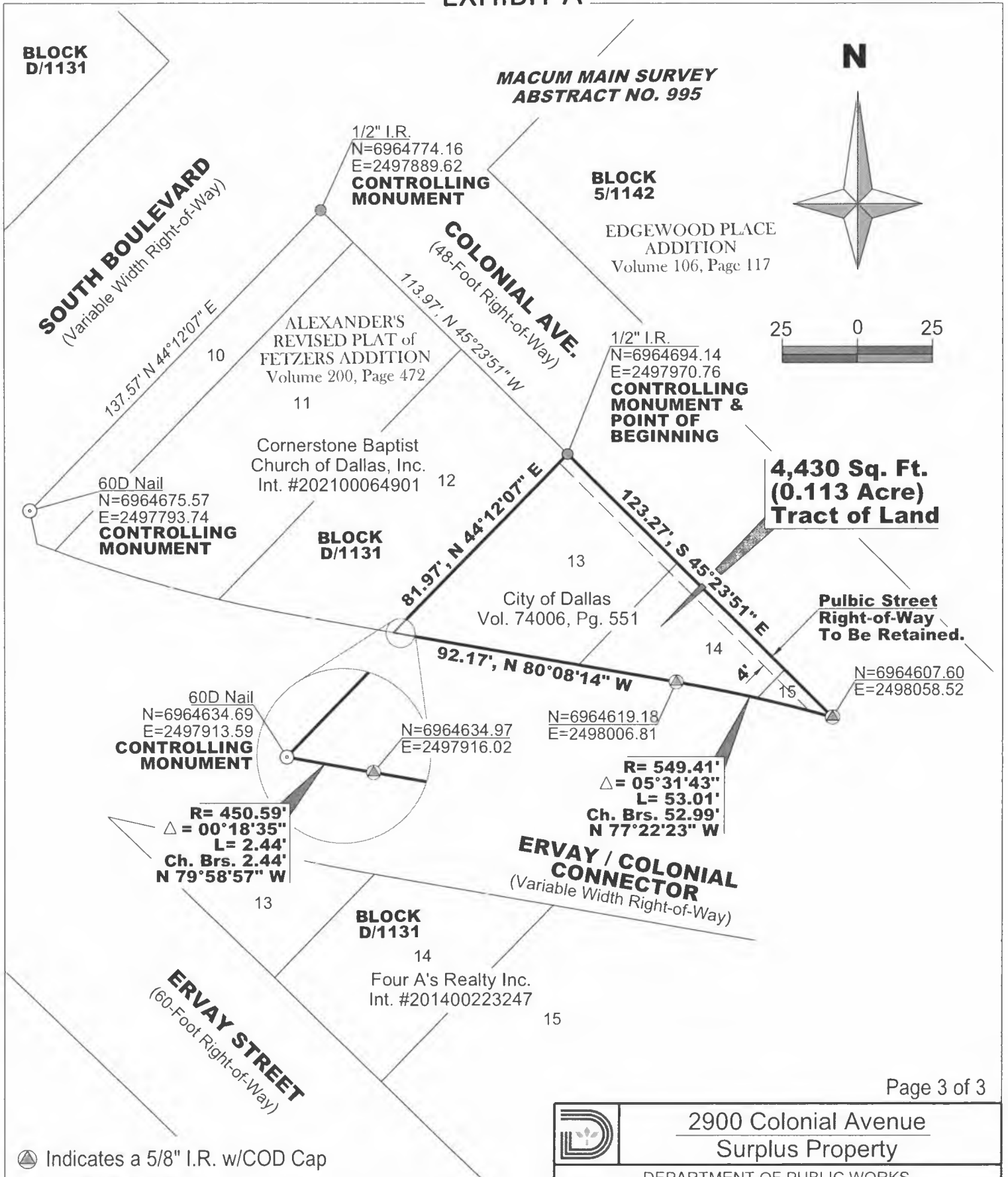
THENCE Northwesterly continuing with the said North line of the Ervay / Colonial Connector and along said Curve, having a Radius of 450.59 feet, a Central Angle of $00^{\circ}18'35''$, an Arc Length of 2.44 feet and a Chord which bears North $79^{\circ}58'57''$ West a distance of 2.44 feet to a 60-D nail (Controlling Monument) found at the intersection with the common line between said lots 12 and 13 (N=6964634.69; E=2497913.59):

THENCE North $44^{\circ}12'07''$ East, departing the last said North line of the Ervay / Colonial Connector and with the said common line between lots 12 and 13 a distance of 81.97 feet to the **POINT OF BEGINNING**, containing 4,909 Square Feet, or 0.113 Acres of land *SAVE AND EXCEPT* a 4.00-foot-wide strip of land along the Northeast side of the herein described tract containing 479 Square Feet, or 0.011 Acres of land to be retained for public Right-of-Way purposes, and yielding 4,430 Square Feet, or 0.102 Acres of land to be conveyed hereunder:
