**WHEREAS,** on August 14, 2019, the City Council authorized a professional services contract with Terracon Consultants, Inc., to provide engineering and architectural services for the condition assessment and design of roof and heating, ventilation, air conditioning, and refrigeration systems at Dallas Water Utilities' 270 facilities, in an amount not to exceed \$1,557,880.00, by Resolution No. 19-1133; and

**WHEREAS**, additional architectural and engineering services are required for construction administration services for roof and heating, ventilation, and air conditioning (HVAC) replacements and for elevator system maintenance; and

**WHEREAS,** Terracon Consultants, Inc., 8901 John West Carpenter Freeway, Suite 100, Dallas, Texas 75247, has submitted an acceptable proposal to provide the additional architectural and engineering service; and

**WHEREAS,** Dallas Water Utilities recommends that Contract No. 19-029/030E be increased by \$378,600.00, from \$1,557,880.00 to \$1,936,480.00.

Now, Therefore,

## BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

**SECTION 1.** That the proposed Supplemental Agreement No. 1 to the professional services contract be accepted and that Contract No. 19-029/030E with Terracon Consultants, Inc., be revised accordingly.

**SECTION 2.** That the City Manager is hereby authorized to execute Supplemental Agreement No. 1 to the professional services contract with Terracon Consultants, Inc., approved as to form by the City Attorney, to provide additional work at various sites to complete elevator systems maintenance, roof and heating, ventilation, and air conditioning replacements, in an amount not to exceed \$378,600.00, increasing the contract amount from \$1,557,880.00 to \$1,936,480.00.

**SECTION 3.** That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$378,600.00 to Terracon Consultants, Inc., as follows:
