THENCE North 41°25"59" West, PASS AT 3.00 feet the Northeast line of said Lakewood Club Ventures, Ltd. Addition, and continuing for a total distance of 53.07 feet to a Mag Nail with washer stamped "CITY OF DALLAS" set at the intersection with the Southwest Right-of-Way line of the relocated Brookside Drive, a 75-foot wide street conveyed to the City of Dallas by deed recorded in Volume 230, Page 554 of the Deed Records of Dallas County, Texas, and being also the most Northerly corner of the herein described tract of land:

THENCE South 45°34'01" East with the said Southwest line of the relocated Brookside Drive a distance of 214.01 feet to a Mag Nail with washer stamped "CITY OF DALLAS" set at the intersection with the above noted Northwest line of the Santa Fe Railroad:

THENCE South 48°10'08" West with the said Northwest line of the Santa Fe Railroad a distance of 53.11 feet to the **POINT OF BEGINNING**, containing 11,177 Square Feet, or 0.257 Acres of land.
