WHEREAS, on December 11, 2019, the City Council authorized a five-year master agreement for veterinary medical supplies and medications for the Department of Dallas Animal Services with Midwest Veterinary Supply, Inc. in the estimated amount of \$2,947,732.97, MWI Veterinary Supply, Co. dba MWI Animal Health in the estimated amount of \$1,857,933.62, IDEXX Distribution, Inc. in the estimated amount of \$762,592.50, and Merck Animal Health in the estimated amount of \$658,053.36, in a total estimated amount of \$6,226,312.45, by Resolution No. 19-1920.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That a master agreement for the purchase of veterinary pharmaceuticals and medical supplies for the Department of Dallas Animal Services is authorized with MWI Veterinary Supply Co. dba MWI Animal Health (VS0000035134) in the estimated amount of \$8,702,076.88, IDEXX Distribution, Inc. (333782) in the estimated amount of \$2,282,265.96, Dechra Veterinary Products, LLC (VC0000034481) in the estimated amount of \$1,588,570.11, and Merck Animal Health (VS0000070669) in the estimated amount of \$883,488.76, approved as to form by the City Attorney, for a term of five years, in the total estimated amount of \$13,456,401.71. The amount payable pursuant to this master agreement may exceed the estimated amount, but may not exceed the amount of budgetary appropriations for this master agreement during its term. The City Manager is further authorized, in the City Manager's sole discretion, to exercise an option to extend the agreement for six months by filing a notice of extension with the City Secretary's Office.

SECTION 2. That the Purchasing Agent is authorized, upon appropriate request and documented need by a user department, to issue a purchase order for veterinary pharmaceuticals and medical supplies for the Department of Dallas Animal Services. If a written contract is required or requested for any or all purchases of veterinary pharmaceuticals and medical supplies for the Department of Dallas Animal Services under the master agreement instead of individual purchase orders, the City Manager is hereby authorized to execute a contract, approved as to form by the City Attorney.

SECTION 3. That the Chief Financial Officer is hereby authorized to disburse funds in an estimated amount of at least \$13,456,401.71, but not more than the amount of budgetary appropriations for this master agreement during its term to MWI Veterinary Supply Co dba MWI Animal Health, IDEXX Distribution, Inc., Dechra Veterinary Products, LLC, and Merck Animal Health from Master Agreement Contract No. DAS-2025-00027395.

SECTION 4. That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
