  - Option A: Definition and **additional** land use regulations in 51A and regulations in Chapter 27
  - Option B: Definition and **minimal** regulations in 51A with **all regulations in Chapter 27**
- Creation of a new use: Event Venue

\*Numbering of options does not reflect a preference or hierarchy; it is a random assignation



## Option A: Definition and additional regulations in Zoning

### SEC. 51A-4.205. LODGING USES

(x) Short-Term Rental.

(A) Definition: A full or partial dwelling unit that is rented to occupants for fewer than 30 consecutive days per rental period.

(i) **Type 1 short-term rental**: A short-term rental as defined above that is occupied by the owner of the property. Occupied status is determined by property tax homestead exemption status as recorded by the Central Appraisal District for the county in which the property is located.

(ii) **Type 2 short-term rental**: A short-term rental as defined above that is not occupied by the owner of the property and is intended for full-time use as a short-term rental.





## Option A: Definition and <u>additional</u> regulations in Zoning

## SEC. 51A-4.205. LODGING USES

(x) Short-Term Rental. (cont'd)

- (B) Districts permitted:
  - (i) For a Type 1 short-term rental, by right in all districts. {Owner Occupied}
  - (ii) For a Type 2 short-term rental: {Non-Owner Occupied}

(a) by right in the following districts: A(A) - Agricultural, MF-1(A) - Multifamily, mixed use, CR – Community Retail, RR – Regional Retail, CS – Commercial Service, LI – Light Industrial, IM – Industrial Manufacturing, IR – Industrial Research, and central area.

## Draft Zoning Ordinance Amendment Event Venue: Proposed new use RETAIL AND PERSONAL SERVICE USES. Event venue.

(A) Definition: An establishment primarily engaged for the purpose of hosting guests at private events such as banquets, receptions, charitable gatherings, ceremonies, or celebrations. This use does not include a residential property when used for events hosted by the occupant of the property.

(B) Districts permitted: By right in the following zoning districts: CR - Community Retail, RR – Regional Retail, CS – Commercial Service, industrial, central area, mixed use, multiple commercial, UC-2 – Urban Corridor, and UC-3 – Urban Corridor districts. Residential Adjacency Review (RAR) is required for any event venue that is located within 300 feet, measured in a direct line between the nearest property line where this use is conducted and the nearest boundary of a residential zoning district.

- (C) Required off-street parking: one space per 200 square feet of floor area.
- (D) Required off-street loading:

## Event Venue: Proposed new use

### SEC. 51A-4.210. RETAIL AND PERSONAL SERVICE USES. (cont.)

(E) Additional provisions:

(i) If applicable, an event venue must comply with Chapter 42A, "Special Events; Neighborhood Markets; Dallas Farmers Market Farmers Market; Streetlight Pole Banners" of the Dallas City Code.

Registration - owner/host/agent (ATL/ARL)

Require STRs to obtain a license prior to platform listing within the City of Dallas (ATL/ARL)

Allow for the collection of fees to cover all costs (COD/ATL/ARL)

Require distance between STRs of 1,500 feet for single family and duplex districts; maximum of 10% of the total dwelling units on a property for all other zoning districts

Notification of neighbors within 300 ft by city staff (ATL)

Require owner to have an emergency contact on file to respond onsite to emergency concerns within a one-hour timeframe

Require all listings on platforms to include the license number

No exemption from Single Family Registration if owner rents for periods greater than 30 days (ATL/ARL)

Registration to be renewed annually or at the change of ownership (ARL)

Allow for inspections, including night inspections (ARL/ATL)

Self-certification program eligibility for good neighbor properties (COD)

Host/owner/agent liability for failure to allow for inspections of short-term rental properties (ATL/ARL)

Revocation of license (ATL/ARL)

Minimum night stay of not less than two (2) days (ARL)

Occupancy limits from TX Property Code (ATL/ARL)

Include available parking and restrictions on platform listing (ARL/ATL)

Encourage the use of a noise monitoring device (ATL)

Prohibit amplified sound that is audible beyond the property line or exceeds decibel levels listed in 51A (ARL)

Violations of the STR ordinance would be eligible violations under the Habitual Nuisance Property designation – 3 citations

Director's Discretion for suspension or revocation of licenses after serious offenses



# Challenges



## **Options For Legal Review**

Hold a platform accountable for failure to comply with provisions of this chapter (ARL)

Require platforms to provide locations being listed within the City of Dallas

Require platforms to remove any listing that is not licensed

Require the collection of HOT and submit remittance

## **Options Not Recommended**

Set limits on total nights per year for non-owner occupied


Provide limits to the number of STR's from a single owner/investor

Prohibit out of town ownership



# **Registration Process**





**Revocation Enforcement Tool** May occur after three substantiated disturbances within one year; STR license may be revoked, and the address barred from applying for renewal of license for one year □ Includes but is not limited to parking, noise, litter, destruction of property, disorderly/criminal conduct or failure to pay hotel occupancy taxes □ Locations with a revoked registration may appeal to the Permit, License and Appeal Board for review

# **Registration Licensing Requirements**



### **Application Requirements**

- 1. Submit Application and Fee
- 2. Provide Owner/Host Contact information
- 3. Provide emergency contacts that can respond onsite within 1 hour
- 4. Supply Hotel Occupancy Tax Registration Number and Certificate of Occupancy

### 5. Acknowledgements:

- City Ordinance Requirements
- Occupancy Limits
- Parking Requirements
- Understanding of revocation process
- Advertising and signage limitations
- 6. Initial inspection must be completed and in compliance before license is issued
- 7. Post emergency contact, license number, and Certificate of Occupancy onsite

### Planning for Impact Beyond the Park



### Economic Development

- Together with the Dallas Zoo's Master Plan, the collective capital investment will exceed \$250 million, the largest investment in Southern Dallas' history with an estimated economic impact of over \$1billion from the Phase I park in the first 5 years
- SGP is bookended by three federally-designated Opportunity Zones
- Potential for a Southern Gateway TIF and/or PID



### Planning for Impact Beyond the Park



### Transportation & Neighborhood Connectivity

- Possible connections to Dallas Streetcar and expanded network of hike/bike trails
- Neighborhood connectivity study/plan for crossings from DART to Zoo and Zoo to Park – awarded RAISE planning grant in 2021 in partnership with City of Dallas and Dallas Zoo
- Possible opportunity for street, sidewalk, and multi-modal improvements along Marsalis in the next bond program and within implementation of the Sidewalk Master Plan and CONNECT Dallas.



### Planning for Impact Beyond the Park

### Housing

- Explore policy options to stabilize neighborhoods
- Council expanded the Neighborhood Empowerment Zones in 2020 to include The Bottom and 10th Street Historic District northeast of the park.
- Southern Gateway corridor is categorized as an "Emerging Market Area" in the Comprehensive Housing Plan and market value analysis and a potential location for public incentives to support, maintain, or create workforce housing.





# Broadband and Digital Equity Strategic Plan



### Recommendation 1: City Fiber Back Bone

- Begin by building 200+ miles of fiber
- Focus on areas of the city that are least serviced by broadband and those with the greatest need for connecting City services
- City infrastructure connectivity (traffic cameras, traffic signal controllers, data centers)

### Recommendation 2: Fixed Wireless Infrastructure

- Expand fixed wireless infrastructure for city residents in areas with less existing broadband infrastructure
- Shared infrastructure with DISD

### Recommendation 3: Digital Equity Initiatives

- Expand the Digital Navigators program to help families enroll in ISPs' low-cost programs & federal subsidy programs
- Fund the expansion of digital skills training offered through the Digital Navigators program



# Recommendation 3: Digital Equity Initiatives/

- Digital Navigators Program
  - <u>Access</u> broadband infrastructure and reliable high-speed broadband plans available for purchase.
  - <u>Affordability</u> broadband service that is not only available but can be obtained at reasonable prices by all.
  - <u>Devices</u> residents own or have access to well-functioning, up-to-date computers and have capacity to maintain and replace these devices if needed
  - <u>Skills</u> residents are able to make full use of computers and online resources, and thus are able to use these tools to communicate, work, learn, attend medical appointments, and accomplish other desired tasks all while avoiding online risks and harms.
- Align with Dallas Public Library enhanced library card and other City offerings and programs








# Additional Digital Divide Efforts



## Digital Sustainability – Transportation & Public Works



- 10 City of Dallas sites to which the City's network has been extended to provide free City Wi-Fi
  - Initially provisioned by Neo Networks now managed by the City's ITS department
- All new traffic signals have provisions for fiber optic connections
- Developed an interim standard for placement of fiber optic conduits within city ROW
- Interdepartmental coordination of fiber optic deployment








### **Richmond Avenue and Tietze Park Projects**

- Installation of fiber from Fire Stations #5 & #17 to traffic signals/streetlights along the routes in each area.
- City will install multi-function devices which include:
  - Access points providing free City Wi-Fi
  - High-resolution cameras
  - Gun shot detection
  - Lighting controls
  - Air quality monitoring



## Digital Sustainability – Library, Parks & Recreation

- Four libraries designated to which free City Wi-Fi was extended to their parking lots
- Hardware devices available for check-out to the public with City support 3,000 Hotspots and 1,500 Laptop Bundles
- \$3 million designated to extend free City Wi-Fi to PKR parks and facilities
- Prioritized list of PKR parks and facilities identified and project underway to deploy City Wi-Fi
- Locations to which free City Wi-Fi is being extended based upon identified areas of need





## Texas Metro City/County Broadband Collaborative

- Coalition of metro cities and counties across Texas working together to advocate for our common interests at the state and federal level and share best practices and lessons learned.
- Recent activity:
  - Comments to NTIA related to BEAD and Middle Mile Grant Programs
  - Comments to FCC related to Digital Discrimination Rulemaking
  - Comments to Texas State Affairs Committee related to HB 5
  - Comments to State Broadband Office in the development of the State Broadband Plan





# Federal Funding Opportunities





## Infrastructure Investment and Jobs Act

- \$1.2T bill passed by Congress and signed into law by President Biden on November 15, 2021
- Largest ever investments in high-speed internet, rail and transit, clean energy, and water
- Roughly \$65B invested in high-speed internet efforts through 7 federal programs:
  - Administered by National Telecommunications and Information Administration (NTIA)
    - Broadband, Equity, Access, and Deployment (BEAD) Program (\$42.45B)
    - Digital Equity Planning, Capacity, and Competitive Grants (\$2.75B)
    - Tribal Broadband Connectivity Program (\$2.00B)
    - Middle Mile Broadband Infrastructure Program (\$1.0B)
  - Administered by other federal Agencies
    - Affordable Connectivity Program (\$14.2B)
    - Rural Broadband Programs at the Department of Agriculture (\$2.0B)
    - Private Activity Bonds (\$.06B)



- Funding Pool: \$42.45B
- A program to get all Americans online by funding partnerships between states or territories, communities, and stakeholders to build infrastructure where we need it to increase adoption of high-speed internet
- Eligible uses of funds:
  - Planning for deployment of internet
  - Deploying or upgrading internet
  - Installing internet in multi-tenant buildings
  - Implementing adoption and digital equity programs
  - Workforce and job training
- Notice of Funding Opportunity currently open, closes 7/18/2022
  - Local government not eligible to apply

# **Digital Equity Act Program**

- Funding Pool: \$2.75B
  - State Planning \$0.60B
  - State Capacity \$1.44B
  - Competitive \$1.25B
- Three programs that provide funding to promote digital inclusion and advance equity for all. They aim to ensure that all communities can access and use affordable, reliable, highspeed internet to meet their needs and to improve their lives
- Eligible uses of funds:
  - Develop digital equity plans; state must develop a plan to be eligible for state capacity grants
  - Implementing digital equity plans and related activities
  - Making awards to other entities to help make digital equity plans
  - Providing digital literacy and digital skills education
  - Improving accessibility and inclusivity of public resources
  - Facilitating the adoption of high-speed internet
- Notice of Funding Opportunity State Planning Program currently open, closes 7/12/2022

## Middle Mile Grant Program

- Funding Pool: \$1B
- A program to expand middle mile infrastructure, to reduce the cost of connecting unserved and underserved areas.
- Eligible uses of funds:
  - Construction, improvement, or acquisition of facilities and equipment
  - Engineering design, permitting, and work related to projects
  - Personnel costs, including salaries and benefits
  - Other costs necessary for program's activities
- Notice of Funding Opportunity Opens 6/21/2022, closes 9/30/2022
  - Local government eligible to apply







- Funding Pool: \$14.2B
- Program to help low-income families pay for internet service. Families can get up to \$30 per month, or \$75 per month if they live on qualifying Tribal Lands. And they can get \$100 to help pay for a desktop, laptop, or tablet computer.
- Two-Step Process:
  - Submit an application to <u>www.AffordableConnectivity.gov</u> or by mail.
  - Apply to internet service provider and select a plan to have the discount applied to the bill.
