  - Lockridge Workforce Housing Project on 52<sup>nd</sup> Street 67 units
  - Affordable Single-Family Housing Project on Forest Lane 40 units
  - Valwood Park Project in Farmers Branch 20 units
  - Dallas Catalyst Housing Project in the Forest District of Dallas 7 units
  - The Five Mile Neighborhood Project in Dallas will add 80 units
  - o Gateway Oak Cliff Project at 400 S. Beckley in Dallas 187 units
  - Low Income Senior Resident Project, Oaklawn Place in Dallas 84 units
  - Lake June Single-Family Housing Development in Dallas 100 units
  - JJ Lemon Project Sigle-Family Housing Development 500+ units
