





# Update on Budget Initiatives

### Update on Budget Initiatives FY23-24



- Initiative 1 Strengthen park security presence and enhance parks and trails enforcement by installing additional lighting, security cameras, and Emergency Blue Light tower phones. In FY 2023-24, PKR will hire eight City Marshals (including supervisor), hire four park rangers, install new lighting, install new security cameras, and install Emergency Blue Light tower phones.
  - The City Marshal's Office is currently in the process of recruiting and interviewing for the eight City Marshal positions with 3 positions expected to be sent to Parks after training. 2 Park Ranger positions are currently vacant, PKR is looking to fill during June Job Fair. For park security, 20 cameras are currently pending installation by the end of FY 2023-24 in 17 different parks, trails, and tennis court locations. Weather has delayed the installation of lights at the 5 remaining parks around the city. Camera trailers have been delivered to the Marshal's office with ITS working with the vendor to connect to the servers. The Marshals transport trailer has been purchased and received with the Marshals allocation of Drones, UTVs and Bikes in their possession. PKR has their allocation of bikes and UTVs as well.
- Initiative 27 Install WiFi at 63 park facilities.
  - This was an initiative started in FY21-22 with ARPA funding. Fourteen high priority sites were completed. Currently, cabling installation of additional sites was completed in April for a total of 23. Marcus Recreation Center is in progress. The remaining 40 WiFi sites have received Access Point equipment and an installation timelines has been established. This project was greatly impacted by supply chain issues and the change of vendor mid-project.

**SUBJECT Electronic Smoking Device Ordinance Update** 

#### **Background**

On May 10, 2023, the Environmental Health Committee of the Environmental Commission (Environmental Commission) recommended that the City restrict vaping in public spaces after identifying the negative health effects of vaping aerosol exposure. The American Lung Association, American Heart Association, World Health Organization, Center for Disease Control, and the U.S. Surgeon General warn that both direct inhalation and second-hand inhalation from vaping and e-cigarettes have health risks, particularly for vulnerable populations such as children and elderly individuals.

On November 6, 2023, the Environmental Commission and the Office of Environmental Quality and Sustainability (OEQS) briefed the Parks, Trails, and the Environment (PTE) Committee regarding the recommendation to update the definition of "Smoking" to include the use of an electronic smoking device (Item No. 23-2814). The Environmental Commission and OEQS briefed the PTE Committee again on March 4, 2024 device (Item No. [24-746]), where the Committee requested that OEQS and the Environmental Commission recommend and ordinance that includes the update to the "Smoking" definition and an update to signage requirements that includes electronic smoking devices.

#### **Code Amendment Recommendation**

The Office of Environmental Quality and Sustainability, in partnership with the Environmental Commission, seeks to amend Chapter 41 of the Dallas City Code by updating the definition of "Smoking" to include the use of an electronic smoking device and updating signage requirements to include electronic smoking devices. Attached please find the recommended code amendments.

#### Next Steps

OEQS and Environmental Commission plan to seek adoption of the recommended ordinance by the end of this fiscal year.

ORDINANCE NO.	

An ordinance amending Chapter 41, "Smoking," of the Dallas City Code, by amending Sections 41-1, 41-2, and 41-3; providing a definition of electronic smoking device; revising the definition of smoking to include the use of an electronic smoking device; providing additional signage requirements for electronic smoking devices; providing a penalty not to exceed \$500; providing a saving clause; providing a severability clause; and providing an effective date.

Now, Therefore,

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That Section 41-1, "Definitions," of Article I, "General Provisions," of Chapter 41, "Smoking," of the Dallas City Code, is amended to read as follows:

#### "SEC. 41-1. DEFINITIONS.

In this chapter:

- (1) BAR means an establishment principally for the sale and consumption of alcoholic beverages on the premises that derives 75 percent or more of its gross revenue on a quarterly (three-month) basis from the sale or service of alcoholic beverages, as defined in the Texas Alcoholic Beverage Code, for on-premises consumption. If an establishment is located in a hotel or motel, the gross revenues of the particular establishment, rather than the gross revenues of the entire hotel or motel, will be used in calculating the percentage of revenues derived from the sale or service of alcoholic beverages.
- (2) BILLIARDS means any game played on a cloth-covered table with balls and cue sticks where the balls are struck by the sticks and the balls strike against one another.
  - (3) BILLIARD HALL means an establishment that:
- (A) holds a valid billiard hall license issued by the city under Chapter 9A of this code;
- (B) has at least 12 billiard tables that are not coin-operated available for rent to persons desiring to play billiards on the premises; and

- (C) derives 70 percent or more of its gross revenue on a quarterly (three-month) basis from the sale or service of alcoholic beverages, as defined in the Texas Alcoholic Beverage Code, for on-premises consumption and from the rental of billiard tables and billiard equipment to persons desiring to play billiards on the premises.
- (4) CIGAR BAR means a bar that derives 15 percent or more of its gross revenue on a quarterly (three-month) basis from the sale or rental of tobacco, tobacco products, smoking implements, or smoking accessories for on-premises consumption.
- (5) DIRECTOR means the director of the department designated by the city manager to enforce and administer this chapter, or the director's designated representative.
- (6) EATING ESTABLISHMENT means any establishment that prepares or serves food or beverages, regardless of whether the establishment provides seating or facilities for on-premises consumption. The term includes, but is not limited to, restaurants, coffee shops, cafeterias, short order cafes, fast food establishments, luncheonettes, lunchrooms, soda fountains, food carts, food vending vehicles, and catering establishments.
- (7) <u>ELECTRONIC SMOKING DEVICE means any product containing or delivering nicotine or any other substance intended for human consumption that can be used by a person in any manner for the purpose of inhaling vapor or aerosol from the product. The term includes any such device, whether manufactured, distributed, marketed, or sold as an e-cigarette, e-cigar, e-pipe, e-hookah, dab rig or vape pen, or under any other product name or descriptor.</u>
- (8) EMPLOYEE means any person who works for hire at an indoor or enclosed area including an independent contractor with an assigned indoor location.
  - (9[8]) EMPLOYER means any person who employs one or more employees.
  - (10[9]) ENCLOSED means an area that:
- (A) is closed in overhead by a roof or other covering of any material, whether permanent or temporary; and
- (B) has 40 percent or more of its perimeter closed in by walls or other coverings of any material, whether permanent or temporary.
- (11[10]) HOSPITAL means any institution that provides medical, surgical, and overnight facilities for patients.
  - (12[11]) MINOR means an individual:
    - (A) under 21 years of age; or
- (B) at least 18 years of age and presenting a valid military identification card of the United States military forces or the state military forces.

- (13[12]) PARK PARTNER means any entity that contracts with the city for the operation, maintenance, or management of park property.
- (14[13]) PARK PROPERTY means property under the control and jurisdiction of the park board.
- $(\underline{15}[44])$  PERSON means an individual, firm, partnership, association, or other legal entity.
- (16[15]) RETAIL OR SERVICE ESTABLISHMENT means any establishment that sells goods or services to the general public, including but not limited to any eating establishment, bar, hotel, motel, department store, grocery store, drug store, shopping mall, laundromat, bingo parlor, bowling center, billiard hall, or hair styling salon.
- (17[16]) SECOND-HAND SMOKE means ambient smoke resulting from the act of smoking.
- (18[17]) SMOKE OR SMOKING means inhaling, exhaling, <u>burning</u>, possessing, or carrying any lighted or <u>heated</u> [<u>burning</u>] cigar, [or] cigarette, <u>hookah</u>, <u>electronic smoking device</u>, or any pipe or other device that contains lighted or burning tobacco or <u>plant</u> [tobacco] products <u>intended for inhalation</u>, <u>whether natural or synthetic</u>, <u>including marijuana or cannabis in any manner or in any form.</u>
- (19[18]) TOBACCO SHOP means a retail or service establishment that derives 90 percent or more of its gross revenue on a quarterly (three-month) basis from the sale of tobacco, tobacco products, or smoking implements.
- (20[19]) WORKPLACE means any indoor or enclosed area where an employee works for an employer."
- SECTION 2. That Section 41-2, "Smoking Prohibited in Certain Areas," of Article II, "Smoking Prohibitions," of Chapter 41, "Smoking," of the Dallas City Code, is amended to read as follows:

### "SEC. 41-2. SMOKING <u>AND ELECTRONIC SMOKING DEVICES</u> PROHIBITED IN CERTAIN AREAS.

- (a) A person commits an offense if he smokes <u>or uses an electronic smoking device</u>:
  - (1) in any indoor or enclosed area in the city;
  - (2) within 15 feet of any entrance to an indoor or enclosed area in the city;

- (3) in any area designated as nonsmoking <u>or no electronic smoking devices</u> <u>allowed</u> by the owner, operator, or person in control of the area and marked with a no smoking <u>and no electronic smoking device</u> sign complying with Section 41-3; or
  - (4) on park property.
- (b) An owner, operator, or person in control of an indoor or enclosed area in the city commits an offense if he, either personally or through an employee or agent, permits a person to smoke or use an electronic smoking device in the indoor or enclosed area.
- (c) For purposes of this chapter, an indoor or enclosed area includes but is not limited to the following:
  - (1) An elevator.
  - (2) A hospital or nursing home.
  - (3) Any facility owned, operated, or managed by the city.
  - (4) Any retail or service establishment.
  - (5) Any workplace.
- (6) Any facility of a public or private primary or secondary school or any enclosed theater, movie house, library, museum, or transit system vehicle.
- (d) It is a defense to prosecution under Subsection (a)(1), (a)(3), or (b) of this section if the person was smoking or using an electronic smoking device in a location that was:
- (1) a private residence, except that this defense does not apply when the residence is being used as a child care facility, adult day care facility, or health care facility;
- (2) a stage or set of a production of a television program, a theatrical presentation, or a motion picture or filming event where smoking by an actor or performer is essential to the production;
  - (3) a cigar bar that:
- (A) was lawfully operating as a cigar bar on December 10, 2008 (except that this defense does not apply if the cigar bar is expanded, is relocated, or changes majority ownership after December 10, 2008);
- (B) does not open into any other indoor or enclosed area in which smoking is prohibited under this section;
  - (C) is not generally accessible by a minor; and

- (D) keeps all windows and doors closed at all times except as reasonably necessary for the expeditious entering and exiting of the cigar bar;
  - (4) a tobacco shop that:
- (A) does not open into any other indoor or enclosed area in which smoking is prohibited under this section; and
- (B) keeps all windows and doors closed at all times except as reasonably necessary for the expeditious entering and exiting of the tobacco shop;
- (5) an unenclosed outdoor seating area associated with an indoor or enclosed area, including but not limited to a bar, hotel, motel, or eating establishment, except that this defense does not apply if:
- (A) the outdoor seating area is adjacent to a playground or play area for children; or
- (B) the location was posted as a nonsmoking area by the owner, operator, or person in control of the establishment or area with a sign complying with Section 41-3; or
- (6) a private, rented guest room in a hotel or motel that has been designated as a smoking room by the owner, operator, or person in control of the hotel or motel.
- (e) It is a defense to prosecution under Subsection (a)(2) of this section if the person was smoking or using an electronic smoking device in a location that was an unenclosed outdoor seating area associated with an indoor or enclosed area, including but not limited to a bar, hotel, motel, or eating establishment, except that this defense does not apply if:
- (1) the outdoor seating area is adjacent to a playground or play area for children; or
- (2) the location was posted as a nonsmoking area by the owner, operator, or person in control of the establishment or area with a sign complying with Section 41-3.
- (f) It is a defense to prosecution under Subsection (a)(4) of this section if the person was smoking in a location that was:
  - (1) a golf course, if the location was:
- (i) between the tee box of the first hole and the end of the green of the 18th hole;
  - (ii) on the driving range; or

- (iii) on the outdoor patio;
- (2) the Elm Fork Shooting Range; or
- (3) at a park partner site."

SECTION 3. That Section 41-3, "Signage and Other Requirements," of Article II, "Smoking Prohibitions," of Chapter 41, "Smoking," of the Dallas City Code, is amended to read as follows:

#### "SEC. 41-3. SIGNAGE AND OTHER REQUIREMENTS.

- (a) The owner, operator, or person in control of an establishment or other area in which smoking and the use of an electronic smoking device is prohibited under Section 41-2(a)(1) or (a)(3) shall post a conspicuous sign at the main entrance to the establishment or area. The sign must contain the words "No Smoking or Use Of An Electronic Smoking Device, City of Dallas Ordinance," the universal symbol for no smoking, or other language that clearly prohibits smoking or the use of an electronic smoking device.
- (b) The owner, operator, or person in control of an indoor or enclosed area to which the smoking or the use of an electronic smoking device prohibition of Section 41-2(a)(2) applies shall post a conspicuous sign at each entrance to the indoor or enclosed area. The sign must contain the words "No Smoking or Use Of An Electronic Smoking Device within 15 Feet of Entrance, City of Dallas Ordinance." The universal symbol for no smoking and no electronic smoking device may be substituted for the words "No Smoking and No Electronic Smoking Device."
- (c) The owner, operator, or person in control of an establishment or area in which smoking or the use of an electronic smoking device is prohibited under Section 41-2 shall remove all ashtrays from the establishment or area.
- (d) It is a defense to prosecution under this section that the establishment or area is a location for which a defense to prosecution is provided under Section 41-2(d)."
- SECTION 4. That, unless specifically provided otherwise by this ordinance or by state law, a person violating a provision of this ordinance is, upon conviction, punishable by a fine not to exceed \$500.
- SECTION 5. That Chapter 41 of the Dallas City Code shall remain in full force and effect, save and except as amended by this ordinance.

SECTION 6. That any act done or right vested or accrued, or any proceeding, suit, or

prosecution had or commenced in any action before the amendment or repeal of any ordinance, or

part thereof, shall not be affected or impaired by amendment or repeal of any ordinance, or part

thereof, and shall be treated as still remaining in full force and effect for all intents and purposes

as if the amended or repealed ordinance, or part thereof, had remained in force.

SECTION 7. That the terms and provisions of this ordinance are severable and are

governed by Section 1-4 of Chapter 1 of the Dallas City Code, as amended.

SECTION 8. That this ordinance shall take effect immediately from and after its passage

and publication in accordance with the provisions of the Charter of the City of Dallas, and it is

accordingly so ordained.

#### **Background**

On February 5, 2024, the Parks, Trails, and the Environment (PTE) Committee requested the Office of Environmental Quality and Sustainability (OEQS) to draft a resolution that better ensures the incorporation of the Comprehensive Environmental and Climate Action Plan (CECAP) and Dallas Environmental Commission (EVC) recommendations into the 2024 Bond Program. The purpose of this resolution (attached) is to protect the public health, safety, and welfare of residents, while continuing to be a leader in addressing climate change and improving environmental quality.

WHEREAS, on January 22, 2003, through the 2003 Bond Program, the City of Dallas adopted the Green Building Program by Resolution No. 03-0367, which advanced the United States Green Building Council's (USGBC's) Leadership in Energy and Environmental Design (LEED™) certification system using the LEED™ Silver certification for new and replacement facilities over 10,000 square feet of occupied space; and using LEED™ principles for renovation and rehabilitation projects; and

**WHEREAS**, on January 26, 2005, the City of Dallas adopted the Environmental Policy by Resolution No. 05-0362, indicating the City's commitment to uphold environmental performance through laws, procedures, and stewardship for all personnel, contractors, and businesses in association; and

**WHEREAS**, through the 2006 Bond Program, the City of Dallas began implementing the current practice of advancing LEED™ Gold certification for new and replacement facilities over 10,000 square feet of occupied space; and

**WHEREAS**, on April 9, 2008, the City of Dallas updated the Green Building Program by Resolution No. 08-1070, which included advancements to improve energy efficiency, water conservation, and reducing the heat island effect; and expanded the Green Building Program to include residential and commercial projects; and

**WHEREAS**, on March 9, 2011, by Resolution No. 11-0657, the Revised Cement Preference was reformatted from another cement policy to give preference to cement manufacturers who could meet stricter environmental emission rates during the vendor bidding process; and

**WHEREAS**, on September 26, 2012, the City of Dallas updated the Green Building Program by Resolution No. 12-2428, adopting Ordinance No. 28813 that, after reviewing recommendations by the Green Building Task Force, included amendments to City ordinance to implement a Cool Roof Policy that requires commercial buildings less than 50,000 square feet to require vegetative roofs with slopes of 2:12: or less; and

WHEREAS, on January 27, 2016, the City of Dallas adopted Complete Streets by Resolution No. 19-1431, which uses context sensitive design, construction, operation, and maintenance practices to advance, for example: more live-able, walkable, bikeable, transportation-efficient, and sustainable street projects; integrated stormwater management (iSWM) principles; and other environmental and climate goals; and

**WHEREAS**, on December 19, 2016, the City of Dallas updated the Green Building Program by Resolution No. 17-0212, which incorporated the revisions to the International Green Construction Code of the International Code Council; and

**WHEREAS**, on June 22, 2018, the City of Dallas adopted the Tree and Landscape Ordinance Update by Resolution No. 18-0977, which provided greater protections and foliage specifications for area native species of trees to protect the environment and promote safety and beautification; and

**WHEREAS**, on August 8, 2018, City Council adopted the Resilient Dallas plan by Resolution No. 18-1026 that, among other things, identified efforts to reduce emissions and mitigate the impacts of climate change as part of the strategy to make Dallas neighborhoods and communities thrive; and

**WHEREAS**, on April 10, 2019, the City of Dallas adopted the Green Energy Policy by Resolution No. 19-0484, which commits the City of Dallas to one hundred percent renewable energy for municipal operations and sets forth the groundwork to make that goal achievable; and

**WHEREAS**, on September 11, 2019, the City of Dallas adopted updates to the City Paving and Drainage Criteria by Resolution No. 19-1431, which included setting new standard principles and practices for designing drainage facilities. These are designed to reduce flooding, prevent erosion, and achieve other environmental goals; and

WHEREAS, on May 27, 2020, the City of Dallas adopted the Comprehensive Environmental Climate Action Plan (CECAP) by Resolution No. 20-0688, directing the City Manager, through the Office of Environmental Quality and Sustainability (OEQS), to coordinate City of Dallas initiatives and partnerships necessary to implement the actions and goals set forth in the CECAP, convene an Environment and Sustainability Advisory Committee towards implementation of a permanent board or commission, and provide annual reporting on progress towards meeting the goals and measurable targets set forth in the CECAP; and

WHEREAS, the CECAP includes 97 climate mitigation, climate adaptation, environmental quality, and environmental justice actions to advance the following eight goals: Goal 1, Dallas' buildings are energy efficient and climate resilient; Goal 2, Dallas generates and uses renewable, reliable, and affordable energy; Goal 3, Dallas' communities have access to sustainable, affordable transportation options; Goal 4, Dallas is a Zero Waste community; Goal 5, Dallas protects its water resources and its communities from flooding and drought; Goal 6, Dallas protects and enhances its ecosystems, trees, and green spaces that in turn improve public health; Goal 7, All Dallas' communities have access to healthy, local food; and Goal 8, All Dallas' communities breathe clean air; and

**WHEREAS,** on May 26, 2021, the City of Dallas adopted the Sustainable Procurement Policy by Resolution No. 21-0908, which advances environmental, economic, and social benefits through the procurement process; and

**WHEREAS**, on June 9, 2021, the City of Dallas adopted the Urban Forest Master Plan by Resolution No. 21-1030 to preserve and encourage the growth of Dallas forests using research-based methods and community involvement to provide environmental, social, and economic benefits; and

**WHEREAS**, on August 24, 2022, the City of Dallas adopted the Racial Equity Plan by Resolution No. 22-1588, which includes goals, actions, and measures to advance racial equity and inclusion, including big audacious goals to advance environmental justice; and

WHEREAS, on January 25, 2023, the City of Dallas adopted the Economic Development Incentive Policy by Resolution No. 23-0220 that, among other things, advances Goal 7 of the CECAP (All Dallas' Communities have Access to Healthy, Local Food) by recommending abatement, loan, and grant incentives for community development projects like grocery stores in our communities, including our historically disadvantaged communities; and

**WHEREAS**, on March 8, 2023, the City of Dallas adopted the Comprehensive Urban Agriculture Plan by Resolution No. 23-0373 that, among other things, advances Goal 7 of the CECAP ("All Dallas' Communities Have Access To Healthy, Local Food"), and addresses gaps in the resiliency of Dallas' food system by implementing specific actions to advance local urban agriculture production, access, and sourcing, particularly in communities lacking equitable access to food; and

WHEREAS, on May 10, 2023, the City of Dallas Environmental Commission (EVC) unanimously supported recommendations from the EVC Strategic Partnerships & Innovation Committee, which included: requiring LEED™ Gold for appropriate City buildings and considering piloting building projects using more sustainable certification levels and programs (e.g., LEED™ Zero Carbon, Architecture 2030 Framework, International Living Future Institute design principles); requiring Envision and/or SITES for non-building infrastructure projects and considering piloting Smart Surface tools, Parksmart, and Climate Positive Design; requiring appliances and equipment with a top 20% energy rating; requiring the energy benchmarking and tracking of performance data of projects using the Department of Energy's Green Button product; and requiring the submittal by vendors of environmental product disclosures (EPDs) at the time of bid; and;

**WHEREAS**, the City of Dallas remains committed to protecting the public health, safety, and welfare of its residents and leading the region in addressing climate change, improving environmental quality, and advancing environmental justice; and;

**WHEREAS**, the City of Dallas recognizes the 2024 bond provides a critical opportunity to execute that commitment and advance each of the goals associated with the CECAP and the REP; and;

**WHEREAS**, according to the City of Dallas' 2019 Greenhouse Gas Inventory Report: commercial and residential buildings continue to produce 43% of greenhouse gas emissions in the City of Dallas; and additional reduction measures will be required in order to meet 2030 emissions goals, especially given the anticipation of future growth and development among these sectors; and;

**WHEREAS**, the City of Dallas recognizes the need to account for the greenhouse gas emissions emitted from the construction and transportation of materials used to construct City infrastructure; and

**WHEREAS**, the City of Dallas recognizes the need to improve water quality, manage stormwater runoff, maintain and potentially restore City ecosystems, and implement safer sustainable practices when constructing and managing non-building infrastructure; and

**WHEREAS,** the City of Dallas continues to acknowledge the need to invest in energy efficient equipment and sustainable materials in order to reduce GHG emissions, meet the Paris Climate Agreement, and all of the CECAP goals; and

**WHEREAS,** according to Architecture 2030, the production of cement, iron, steel, and aluminum, alone, account for 7.3% of global GHG emissions for infrastructure and 7.7% in buildings, totaling to 15% of total annual global CO<sub>2</sub> emissions; and

**WHEREAS**, the USGBC's LEED™ certification system continues to be the leading standard for designing, constructing, and certifying the world's greenest buildings; and

WHEREAS, the USGBC's SITES certification system has emerged as a leading standard for sustainable land design and development projects and is intended to seamlessly integrate with LEED™; and

**WHEREAS**, the Institute for Sustainable Infrastructure's (ISI's) Envision certification system has emerged as a leading standard for civil infrastructure projects that advance sustainable, resilient, and equitable design; and

**WHEREAS**, the Energy Star Portfolio Manager is endorsed through the Environmental Protection Agency (EPA) and the Department of Energy (DOE) for its ability to accurately benchmark energy consumption in buildings; and

**WHEREAS**, EPDs can provide greater accuracy on greenhouse gas emissions from the construction and transportation of materials used to construct City infrastructure; assist with greater accuracy for total greenhouse gas emissions; and aid in future planning efforts in achieving City climate goals; and

**WHEREAS**, the 2023 United Nations Climate Change Conference (COP28) stresses that current efforts will not meet the Paris Climate Agreement's Goal of limiting warming global temperatures to 1.5 degrees Celsius, which is critical to preventing irreversible effects of climate change and its harming effects; and

**WHEREAS**, similarly, the USGBC predicts that without interventions in the building and infrastructure sector, embodied carbon will account for 74% of new construction emissions within the next decade. Reduction measures, such as EPDs and "green" certifications, can reduce these emissions and create a more positive impact on our climate; and

**WHEREAS,** in order for Dallas to remain a leader in protecting the public health, safety, and welfare of its residents, advancing the CECAP and REP with the 2024 bond is required.

Now, Therefore,

#### BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

**SECTION 1.** That the City Council recognizes that environmental sustainability and environmental justice are long-term commitments that require investments in City infrastructure projects included in the 2024 Bond Program and thereafter, particularly in historically disadvantaged communities, and supports bold leadership to advance the goals of the CECAP and REP.

**SECTION 2.** That the City Council continues to prioritize the implementation of all ordinances, policies, guidelines, and standards that advance the City's environmental sustainability and environmental justice goals, including: the Green Building Policy; the Environmental Policy; the Complete Streets Policy; the Tree and Landscape Ordinance; Resilient Dallas; the Green Energy Policy; the Paving and Drainage Criteria; the Sustainable Procurement Policy; the Urban Forest Master Plan; the Economic Development Incentive Policy; the Revised Cement Preference the Comprehensive Urban Agriculture Plan; the REP; and the CECAP.

**SECTION 3.** That the goal is established for City infrastructure projects included in the 2024 Bond Program and thereafter to target, to the greatest extent practical:

A. Obtaining the USGBC's LEED™ gold level certification for new and replacement facilities over 10,000 square feet of occupied space; considering certification levels and products that would increase benefits for new and replacement facilities over 10,000 square feet of occupied space such as LEED™ Zero Carbon , the architecture 2030 framework, and the International Living Future Institute design principles; using the principles of LEED for renovation and rehabilitation projects; seek and identify the appropriate certification level with the goal of maximizing long-term

benefits, such as operating and maintenance savings, while minimizing up-front project cost.

- B. Obtaining the USGBC's SITES certification and/or the ISI's Envision certification for non-building infrastructure projects or, otherwise, incorporating SITES and/or Envision principles into non-building infrastructure projects; considering certification levels and products that would increase benefits for non-building infrastructure projects such as Smart Surface tools, Parksmart, Climate Positive Design, and Pathfinder; and identifying the appropriate certification level with the goal of maximizing long-term benefits, such as operating and maintenance savings, while minimizing up-front project cost.
- C. Purchasing and installing appliances and equipment with the top 20% energy star rating.
- D. Monitoring the energy use of facilities using EPA's Energy Star Portfolio Manager with the goal of identifying opportunities to reduce energy use at facilities.
- E. Obtaining, during the bidding process, EPDs for, at minimum, concrete, iron, asphalt, aluminum, and glass materials used for projects.
- **SECTION 4.** That each relevant department train its staff to meet the goals of this Resolution; and the OEQS provide supplemental support by, for example, working in partnership with constructing departments to develop model language and, where appropriate, training to City Staff. The City Manager will operationalize an interdepartmental working group to better integrate the aforementioned environmental sustainability concepts into bond projects, with OEQS responsible for providing technical expertise on matters related to environmental sustainability.
- **SECTION 5.** That the City Manager provide the City Council, the Parks, Trails, and Environment (PTE) Committee, any PTE successor committee, or other designated City Council Committee with at least one annual update regarding: the status of environmental sustainability and environmental justice integration into the projects of the 2024 Bond Program and future bond programs, including the advancement of CECAP and REP goals.
- **SECTION 6.** That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.

If the presiding officer fails to act, any member of the City Council may move to require enforcement of the rules, and the affirmative vote of a majority of the City Council shall require the presiding officer to act." Section 3.3(c) of the City Council Rules of Procedure.
