2. Office of the City Auditor: Preliminary Fiscal Year 2020-2021 Budget Proposal Presenter(s): Mark S. Swann, City Auditor

Action Taken/Committee Recommendation(s): City Auditor Mark Swann presented a briefing detailing his office's FY 2020-2021 budget proposal. The proposal met the Office of Budget reduction target by reducing professional services and eliminating three staff positions.

3. Dallas First Procurement

Presenters: M. Elizabeth Reich, Chief Financial Officer; Chhunny Chhean, Director, Office of Procurement Action Taken/Committee Recommendation(s): Director of Procurement Chhunny Chhean briefed the "Dallas First" proposed expansion of the City's local preference program. There were questions about program development, existing local preference policies in Ch. 2, and the scope of the expansion beyond the City's COVID-19 response.

A motion was made to amend the proposed resolution to a) remove COVID-19 and economic recovery language, b) add a 'WHEREAS' clause referencing the City's existing local preference program, and c) instruct staff to bring a briefing on the "Dallas First" local preference program back to City Council for adoption before implementation.
