# Background



- City Council unanimously adopted the CECAP on May 27, 2020
- CECAP calls for an advisory body to guide and shape the plan's implementation
- Advisory committee will help develop the permanent commission



# **CECAP** Resolution



SECTION 3: "That the City Manager identify and convene an Environment and Sustainability Advisory Committee, under guidelines established by the City Manager, comprised of professionals and community members to advise on environment, sustainability, and CECAP implementation. The Environment and Sustainability Advisory Committee shall be convened for as long as the City Manager finds that it furthers the purposes of the Environment and Sustainability Committee including implementation of the CECAP."

(Resolution 20-688)

## From the CECAP Resolution

SECTION 4: "That the City Manager coordinate with the Environment and Sustainability Committee regarding the scope and potential roles of a permanent board or commission with a goal of implementation and making appropriate appointments between or around October 1, 2021 and January 1, 2022."



## **Committee Structure**



- Committee will include "a diverse, inclusive and representative group of professionals and community members to advise on environment, sustainability, and CECAP implementation" (Resolution 20-688)
- 15-member committee should be reflective of the eight CECAP sectors
- Staff recommends selecting representatives from the business community, environmental advocacy, and environmental/public health



## **Selection Process**



- Staff is working with local stakeholders to identify potential members for this interim advisory working group
- Full City Council may also submit names to be included on the potential interim advisory working group list
- Special consideration should be given to candidates who have experience working in any of the following areas:
  - Building energy efficiency
  - Renewable energy
  - Multi-modal transportation
  - Zero waste
  - Water resource management
  - Ecosystem/green space conservation

- Urban agriculture/food security
- ❖ Air quality
- Environmental advocacy
- Environmental justice
- Public health



## **Selection Process**



- Staff will provide the ENVS Committee with a list of potential candidates
- Council Committee members will each nominate two members
- Staff will select remaining five members to ensure committee reflects a wide range of backgrounds, experience, expertise, and diversity



## Membership



- Members will be appointed to a two-year term and will be led by:
  - Chair appointed by the Council Committee Chair
  - Vice Chair appointed by the ENVS Committee
- OEQS will provide staff support and CECAP orientation training
- Meeting schedule will be determined by the committee



# Roles and Responsibilities



- Serve as interim CECAP advisory working group to the ENVS Committee
  - Monthly briefing via a standing agenda item
- Provide public input for CECAP implementation
- Assist with development of the permanent commission, which will be established by City Ordinance



# **Next Steps**



- Staff have worked with stakeholders to compile a list of potential candidates
- ENVS Committee members will each select two members by August 18 to the Committee Chair
- Final selection by City Manager or designee in September
- ENVS Committee Chair selects Working Group Chair
- ENVS Committee selects Co-Chair in September

# Background - Bulk and Brush



- On June 12, 2019, the City Council approved an ordinance establishing reasonable limits for bulk and brush collections, and additional regulations related to size and placement
  - Collection limits went into effect July 1, 2020
  - Limits set out to 10 cubic yards
  - Residents may request an oversize collection of up to 20 cubic yards once a year by calling 3-1-1 the week in advance of pickup
  - Ongoing public awareness campaign began in May 2020
  - "Clean Curb" approach









# Background — Bulk and Brush



- "Clean Curb" approach
  - All waste on the curb is collected
  - Piles exceeding the 10 cubic yard limit will be collected and documented
  - Piles with items outside of guidelines (construction debris, loose trash) will be collected and documented
  - After a "soft launch" for education and outreach, residents are billed for the excess volume over the limit or prohibited items



# Background — Bulk and Brush



- "Clean Curb" Positive Impacts
  - Decrease annual collection volumes by an estimated 20-30 thousand tons
  - Reduce monthly volume spikes
  - Improved collection timeliness
  - Increase in neighborhood cleanliness
- Council requested that following the effective date of the bulk/brush limits in July 2020, recommendations be brought forward to further improve the efficiency of the bulk and brush program along with other collection efficiency suggestions


## Phase II - Bulk and Brush Collections



### Phase II – Bulk and Brush Collections



 Phase I of the Bulk and Brush program updates did not address the separation of bulky trash and brush and/or organic waste



- Greatest opportunity for increased diversion is of organic material
- 2018 Set-out survey demonstrated that 72% setouts contain some brush or yard waste
  - Of this total, over 55% were brush-only setouts and could be easily diverted

- Challenges to a new program:
  - Need for substantial public outreach and education
    - What level/type of enforcement
  - Development of mulching and/or composting facility
    - Possible public/private partnership
  - If scenario 3 is selected, is brush allowed during bulk only months
  - Possibility of increased litter, illegal dumping, bulky trash violations
    - Development of new community drop off locations and extended transfer station/landfill availability





# Part 2: Garbage and Recycling Collections— Safety and Efficiency Improvements



### Garbage and Recycling Collection Improvements: Current Program



- City crews provide once per week collection of refuse and recycling carts using fully automated side-load collection vehicles and semi-automated rear-load vehicles
- Collections occur both curbside and in alleys

Move to full automated collection would represent \$6.6MM (est.) in annual expense savings





### Automation Benefits

- Safety Improvements
  - Reduction in accidents and worker injuries
  - Improved workers compensation losses
  - Touch-free collections (lessons learned during COVID-19)
- Operational Efficiencies
  - Lower route hours
  - Fewer delays related to personnel
- Opportunities for employee advancements
  - Development of career path opportunities for labor positions
    - Training program for laborers to transition to truck drivers and other skilled labor positions






### Automation Challenges

- Alley Collection
  - Currently 44% of collection occur in alleys. By comparison, the City of Austin collects approximately 10% of households in the alley while Fort Worth collects close to 3%
- Alley Collection Impact
  - Safety Due to space constraints, damage to gas meters, fences, yards and approaches occur daily
  - Efficiency collections in the alley can take up to roughly 2x the time as curbside collection
  - Less space for carts some alleys have only 8' or less pavement and only 2' alley easement for carts, eliminating the ability for automated trucks to collect from the side of the truck
  - Pavement condition Narrow, light weight alley pavement does not hold up well to continued use by heavy sanitation vehicles





















### Staff Recommendations

- Transition to 95% automated collection over the next 2-3 years
- Develop concise alley condition/size requirements to allow for collections in alley with automated equipment
- Produce effective marketing and outreach campaign with adequate time for launch
- Staff a cart relocation crew to assist moving carts to curbside for those in need of assistance
- Offer smaller carts and or helping hand service to those with genuine limitations/ability to pull carts to curb

Upcoming Agenda Items, August 26, City Council Agenda – Texas Commission on Environmental Quality (TCEQ) Air Monitoring Grant Contracts

The following two items will be considered by the City Council on the August 26, 2020 City Council Agenda:

Renewal of the contract with TCEQ for the Rockwall and Particulate Matter (PM) 2.5 Monitoring Program – Authorize the continued operation and monitoring of the ambient air monitoring station in Rockwall County and air quality monitoring of the PM 2.5 network. The PM 2.5 particles are measured at less than 2.5 microns in diameter, which are small enough to be transported through the upper respiratory causing direct health hazards. This network consists of several samplers located within the City of Dallas. The site in Rockwall County is part of the Dallas/Ft. Worth region's ambient air monitoring network. TCEQ purchased and installed major components of the station and will maintain these components for the facility to be operational. The contract amount is \$96,707.48 for the period September 1, 2020 to August 31, 2021. No matching from the City is required.

Renewal of the contract with TCEQ for the Whole Air Monitoring (Biowatch) – Authorize the continued operation and monitoring of the Whole Air monitoring network in the Dallas area. In turn, TCEQ serves as liaison between the contract awardee and the Department of Homeland Security on matters of BioWatch field operations in the state of Texas. This program was established in 2003 to help provide early warning of a bioterrorist attack. This early warning helps decision makers plan an effective, coordinated, and rapid response. The work requires daily collection operations and equipment maintenance on dozens of air samplers across Dallas County. The air samples are transported to a local lab for daily testing. The contract amount is \$309,511.31 for the period September 1, 2020 to April 30, 2021. No matching from the City is required. TCEQ is in the process of firming up the schedule to extend the contract past April 2021.
