#### **A. COVID-19 Vaccine, Testing, and Data Update**

**Presenter(s):** Dr. Phil Huang, Director, Dallas County Health and Human Services; Dr. Timothy Bray, Director, Institute for Urban Policy Research, University of Texas at Dallas; Rocky Vaz, Director, Office of Emergency Management

**Action Taken/Committee Recommendation(s):** The region's health experts gave updates on COVID-19 vaccine, testing, and data efforts in the City of Dallas and Dallas County. Ad Hoc Committee members discussed and asked questions on several topics, including the prevalence and containment of the B.1.1.7 coronavirus variant, vaccine distribution by zip code, communications regarding the vaccine, allocation of vaccine doses, equity in vaccine distribution, efforts to mobilize vaccine distribution, source of data for vaccine distribution efforts, ICU bed capacity, and more. #### **B. Update on Vaccine Administration Contracts**

**Presenter(s):** Rocky Vaz, Director, Office of Emergency Management; Chhunhy Chhean, Director, Procurement Services

**Action Taken/Committee Recommendation(s):** Director Vaz provided an update on efforts to procure vendors for vaccine distribution. Ad Hoc Committee members asked questions about alternative distribution methods to reach hard-to-reach populations and communications with volunteers at vaccine distribution sites. Information only.

#### **C. Bridging the Digital Divide – Project Updates**

**Presenter(s):** Genesis D. Gavino, Resilience Officer, Office of Equity & Inclusion

**Action Taken/Committee Recommendation(s):** Officer Gavino provided an update on several projects and programs that various City departments are executing to bridge the digital divide in Dallas. Ad Hoc Committee members discussed and asked questions on several topics, including door hangers to inform residents about the digital navigators program, if other cities are taking the same approach as Dallas, how the City can improve its

efforts, communication to residents in Spanish, funding sources for various programs, target outreach numbers for the digital navigators program, and more. CM Atkins requested that staff provide information on how various ISDs utilized the City's matching funds for the Texas Education Agency's Bulk Ordering Program and a timeline for door hanger deployment and streetlight upgrades. CM Narvaez requested that staff explore refurbishing City-owned hardware for distribution to families. CM Gates requested information from staff on the type of technology available at the new Vickery Meadow Branch Library. Information only.

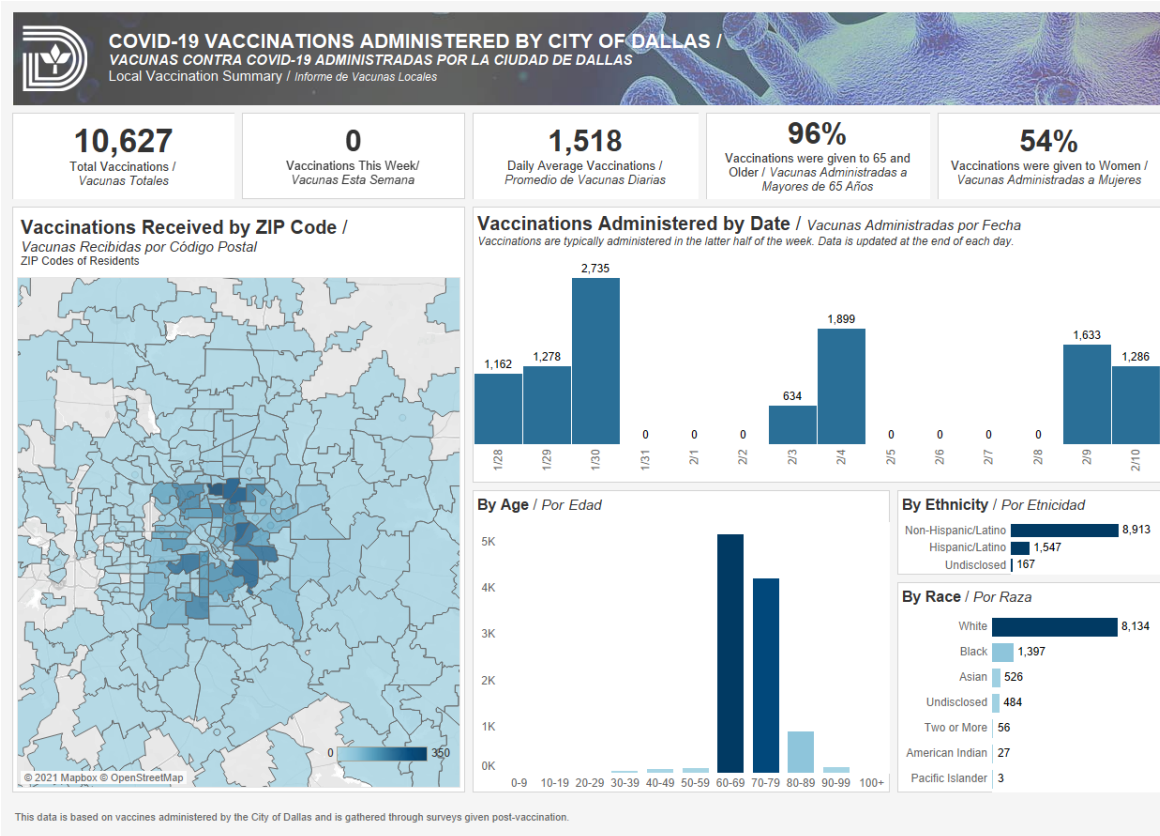

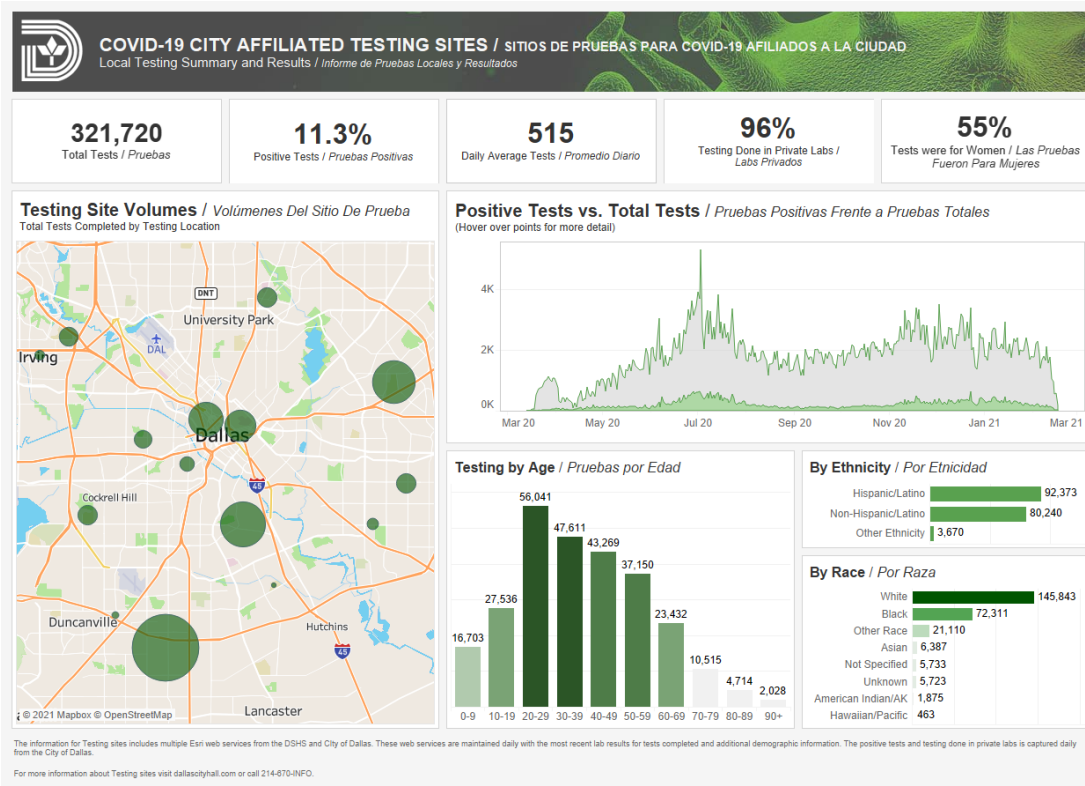

The Office of Data Analytics and Business Intelligence (DBI) launched a bilingual COVID-19 vaccine distribution dashboard for the City of Dallas on February 2, which can be found here: [COVID-19 Vaccine Distribution Dashboard](#). The dashboard includes anonymous demographic data on vaccine recipients including race, ethnicity, gender, age, and the ZIP code of residence for each vaccine recipient who received their vaccine from the City of Dallas, either at the Kay Bailey Hutchinson Convention Center or at Methodist Hospital.

DBI also updated other dashboard tabs to continue to provide information on COVID-19 testing, number of cases, and fatality information, and to include enhanced information on hospital capacity and occupancy for Dallas County and the DFW region.



DBI built the dashboard on a Tableau platform, which is a data visualization solution that helps people see and understand data. The COVID-19 dashboard provides clear visualizations with built-in tool tips to help users understand the data.

SUBJECT **Update on City of Dallas Ongoing Efforts to Address COVID-19 Health Access Disparities**

On Thursday May 28, 2020, Chair Thomas requested a special-called meeting as a follow-up from the Monday, May 11, 2020, Workforce, Education, and Equity Committee briefing where the Office of Equity and Office of Resilience addressed COVID-19 critical needs and equitable health access. During this meeting, it was requested that a monthly briefing memo with updates on the City of Dallas's continuous efforts be provided. The following information highlights the ongoing efforts to address COVID-19 health access disparities:

#### **Testing:**

- The Office of Emergency Management continues to coordinate both community testing sites as well as in-home testing options. MCI Diagnostics continues to help us serve City of Dallas residents who do not have transportation by providing a maximum capacity of 60 tests per day. We have a cumulative testing number of about 322,000 as of February 23, 2021. MCI Diagnostics has performed nearly 1,000 in-home tests since November 2020. Our testing sites were closed the week of February 15, 2021 due to the winter storm event and are now back up and running.

#### **Vaccinations:**

- The Office of Emergency Management continues to coordinate our vaccination efforts with Dallas County. The City of Dallas has conducted over 10,000 vaccinations to date at the Kay Bailey Hutchison Convention Center. Our vaccinations have been given to residents that meet the Phase 1A or 1B requirements and have been prioritized by Dallas County and the Parkland Center for Clinical Innovation (PCCI) through their Vulnerability Index. The city has also partnered with Methodist Dallas Medical Center and has shared a portion of our vaccine allocation with them. This has widened access to individuals who are unable to utilize a drive through due to lack of transportation.
- This week, the Federal Emergency Management Agency (FEMA), in partnership with the City of Dallas and Dallas County, conducted a soft opening of a Community Vaccination Center (CVC) at Fair Park. Based on guidance from the White House and FEMA that these sites should serve the economically disadvantaged population, we worked with PCCI to identify the population that met the criteria. PCCI used the vulnerability index, proximity of high COVID cases index and poverty data and recommended the following zip codes as priority for vaccinations.

**Internet Access:**

- Staff briefed the Ad Hoc Committee on COVID-19 Recovery and Assistance on February 11, 2021 regarding Bridging the Digital Divide Project Updates and covered information related to Digital Navigators Program, Strategic Engineering Consultant, Private Cellular Network, Fiber Optic/Wireless Broadband Network and Streetlight Upgrades. **Community Outreach:**

- Communications, Outreach, and Marketing (COM) has continued to share public service announcement information and multilingual graphics in more than a dozen multicultural publications reaching Black, Latinx, Asian-American, and Jewish residents. The department has broadcasted the La Alianza DFW Spanish vaccine hesitancy panel on the City's TV and digital channels in partnership with the Consul General de Mexico, Dallas County Commissioner Elba Garcia, UTSW, and Los Barrios Unidos, moderated by CM Resendez. COM has translated COVID-19 messages and designed multilingual graphics with Dallas County messages which they shared across their channels. COM is also active in the Black COVID Task Force facilitated by Chair Casey Thomas and OEM vaccine outreach efforts to promote the forthcoming FEMA pilot program targeting specific zip codes.

SUBJECT **Update on City of Dallas Ongoing Efforts to Address COVID-19 Health Access Disparities**

**Transportation:**

- On December 15, 2020, the Dallas County Commissioners' Court approved funding for the Major Capital Improvement Projects (MCIP) totaling \$69,863,000 for 49 projects in the City of Dallas. This approval encompasses approving more than 95% of the projects and 80% of the funding requested by the City during the application process in October 2019.
- Key projects that were approved included several safety related projects covering crosswalks improvements, pedestrian infrastructure upgrades to improve access to transit facilities and other similar projects.
- The County's MCIP program typically funds 50% of the cost of a project with the partner city or other entities responsible for the remaining costs. The City of Dallas typically funds its portion with bond funds, general or enterprise funds, or other sources. Some of the projects already have matching funds identified from previous or current bond programs, or from partnering entity funding. Others will need to have funding identified at a future date from either future bond allocations or other sources.
- Attached is a map and list of projects in six zip codes identified by the Equity Impact Assessment Tool (pages 6 – 8). The targeted effort is to improve safety, equity and accessibility to transit through the improvements listed by the scope of these projects.

**Food Access:**

- Through the Office of Community Care's (OCC) Coronavirus Relief Funds (CRF) Making Food Accessible program, more than 13,000 clients received food distributions through five nonprofit subrecipients. OCC is preparing to release a solicitation to identify for CARES Community Development Block Grant (CDBG – CV-COVID-19) Drivers of Poverty project funds that will include available funding for the continuation of Making Food Accessible programming to support individuals who have been adversely impacted by the COVID-19 pandemic.

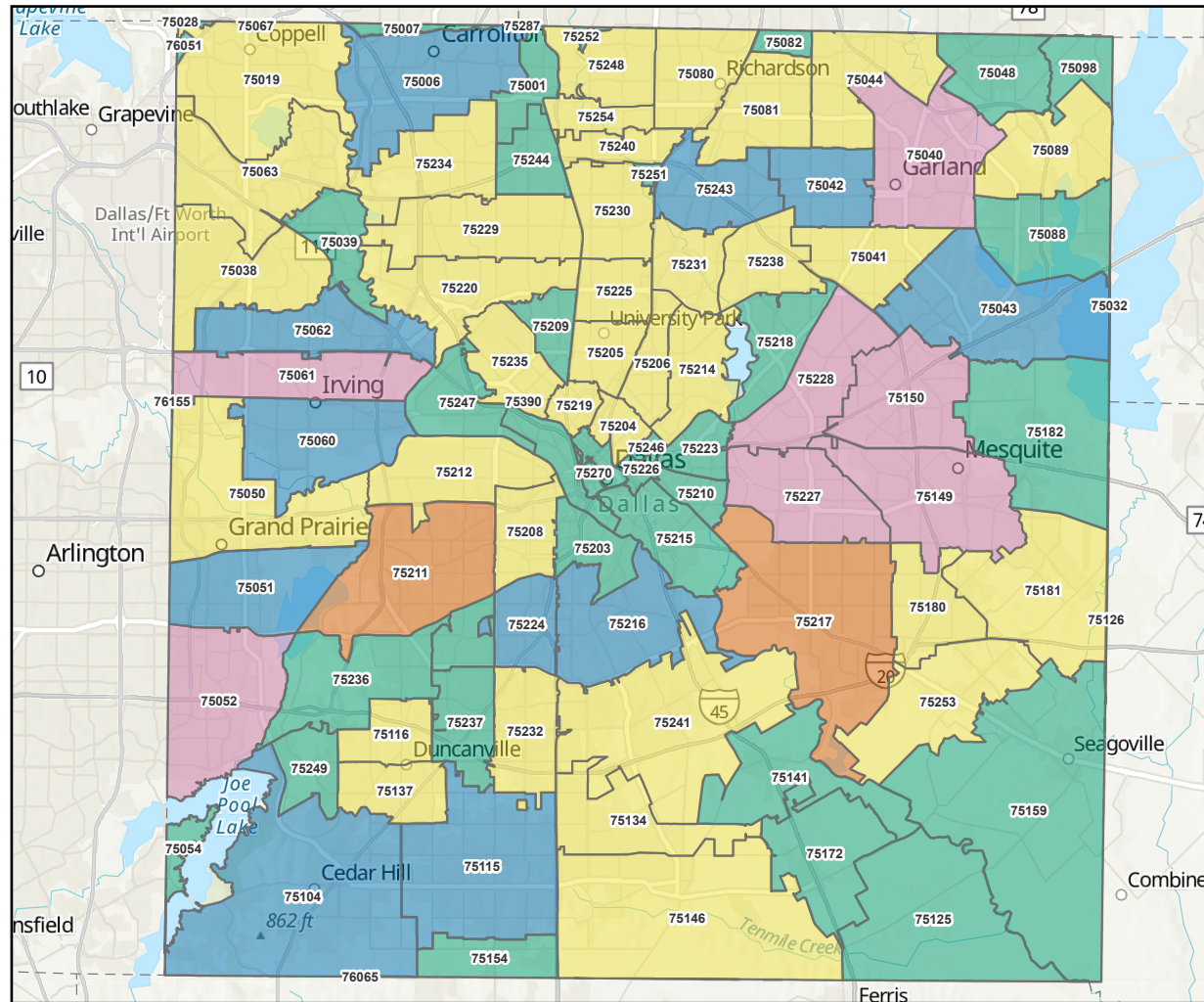

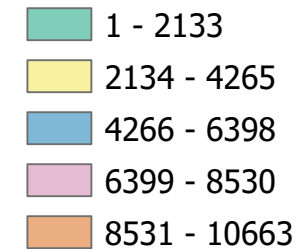

SUBJECT **Monitoring and Enforcement of Current City Emergency Regulations**

The following is a combined monitoring and enforcement update of COVID-19 City Emergency Regulations. As of February 23, 2021, the 311 Call Center has received a total of 13,036 calls regarding COVID-19 since March 17<sup>th</sup> 2020. Approximately 277 COVID-related calls were received in December 2020, compared with 999 in January 2021, and 1,829 received as of February 23, 2021. The majority of increased call activity can be attributed to the City's recent opening of a dedicated COVID vaccine appointment hotline.

A total of 23,035 COVID-19 related violation service requests (SRs) have been submitted since March 17th, including proactive service requests. Approximately 650 Parks related emergency violation SRs have been submitted since March 20th. 311 continues to monitor emergency regulations to ensure current SRs are reflective of current regulations in place.

For February 2021, the Code Compliance COVID-19 Special Task Force conducted a total of 100 inspections and no citations were issued during this time. There have been 6,226 Notices of Violation issued since March 2020, and only 31 locations required citations to bring about compliance. Code continues to conduct education and outreach for COVID-19 resulting in 39,133 locations monitored, educated and or informational materials distributed.

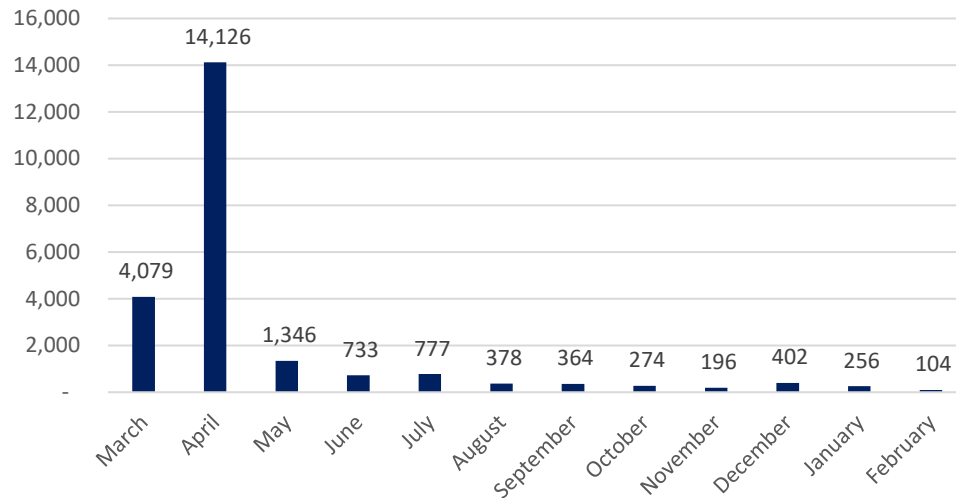

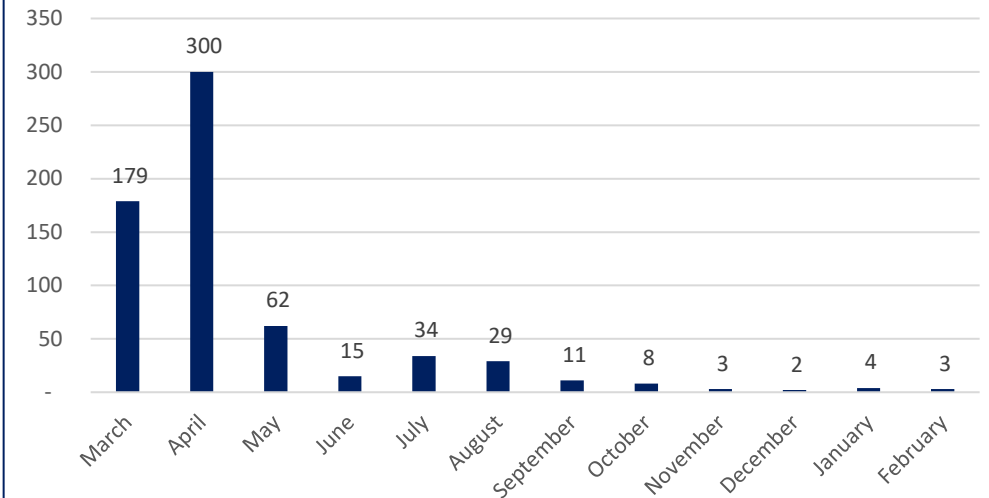
# COVID-19 Service Request Data

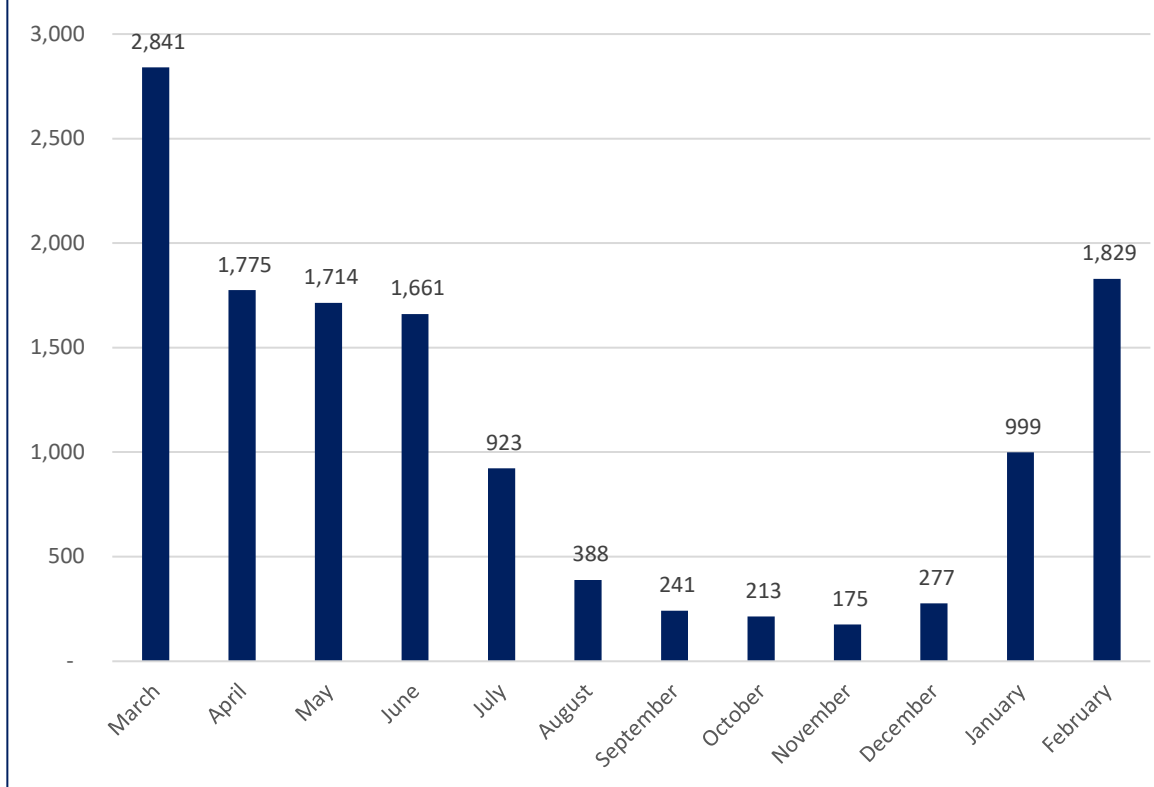
