BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That **(1)** a three-year master agreement for the purchase of various types of herbicides and pesticides for multiple City departments is authorized with Es Opco USA LLC dba Vesperis (VC24153) in the estimated amount of \$363,574.12, Marubeni America Corporation dba Helena Agri-Enterprises, LLC (VC22910) in the estimated amount of \$353,435.43, Rentokil North America, Inc. dba Target Specialty Products (VS91457) in the estimated amount of \$302,132.96, Simplot AB Retail, Inc. dba Simplot Grower Solutions, Simplot Turf & Horticulture (VC22891) in the estimated amount of \$287,818.50, Nutrien Ag Solutions (VS0000000040) in the estimated amount of \$78,323.00, Harrell's, LLC (VC0000013094) in the estimated amount of \$54,374.65, SiteOne Landscape Supply, LLC (VS0000077016) in the estimated amount of \$37,832.17, and Winfield Solutions LLC dba Winfield United (VC0000009702) in the estimated amount of \$6,408.15; and **(2)** a three-year master agreement for the purchase of various types of herbicides and pesticides for multiple City departments is authorized with BWI-Dallas/Ft. Worth dba BWI Companies, Inc. (501400) in the estimated amount of \$331,246.10 and Simplot AB Retail, Inc. dba Simplot Grower Solutions, Simplot Turf & Horticulture in the estimated amount of \$1,454.15 through The Local Government Purchasing Cooperative (BuyBoard) agreement approved as to form by the City Attorney, in the total estimated amount of \$1,816,599.23. The amount payable pursuant to this master agreement may exceed the estimated amount, but may not exceed the amount of budgetary appropriations for this master agreement during its term. The City Manager is further authorized, in the City Manager's sole discretion, to exercise an option to extend the agreement for six months by filing a notice of extension with the City Secretary's Office.

SECTION 2. That the Purchasing Agent is authorized, upon appropriate request and documented need by a user department, to issue a purchase order for various types of herbicides and pesticides for multiple City departments. If a written contract is required or requested for any or all purchases of various types of herbicides and pesticides for multiple City departments under the master agreement instead of individual purchase orders, the City Manager is hereby authorized to execute a contract, approved as to form by the City Attorney.

SECTION 3. That the Chief Financial Officer is hereby authorized to disburse funds in an estimated amount of at least \$1,816,599.23, but not more than the amount of budgetary appropriations for this master agreement during its term to Es Opco USA LLC dba Vesperis, Marubeni America Corporation dba Helena Agri-Enterprises, LLC, BWI-Dallas/Ft. Worth dba BWI Companies, Inc., Rentokil North America, Inc. dba Target Specialty Products, Simplot AB Retail, Inc. dba Simplot Grower Solutions, Simplot Turf & Horticulture, Nutrien Ag Solutions, Harrell's, LLC, SiteOne Landscape Supply, LLC, and Winfield Solutions LLC dba Winfield United from Master Agreement Contract No. POM-2021-00015612.
