WHEREAS, funding was awarded to the City of Dallas under the Community Oriented Policing Services (COPS), 2021 Community Policing Development Crisis Intervention Teams Solicitation (CIT) Grant, Grant No. 15JCOPS-21-GG-02320-SPPS, CFDA No. 16.710 for the Fiscal Years (FY) 2022 and 2023; and

WHEREAS, it is in the best interest of the City of Dallas to accept such funding.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the City Manager is hereby authorized to apply for and accept the 2021 Community Policing Development Crisis Intervention Teams Solicitation (CIT) Grant (Federal/State Award ID. No. 15JCOPS-21-GG-02320-SPPS, CFDA No. 16.710) in the amount of \$250,000.00 from the U.S. Department of Justice passed through the Dallas Police Department for the purpose of funding two mobile crisis response coordinators to form a Long-Term Care CIT Program for two years for the period September 1, 2021 through August 31, 2023; and execution of the grant agreement and all terms, conditions, and documents required by the grant agreement, approved as to form by the City Attorney.

SECTION 2. That the City Manager is hereby authorized to establish appropriations in an amount not to exceed \$250,000.00 in the FY22 Community Policing Development Crisis Intervention Teams Fund, Fund F700, Department DPD, Unit 271C, various Object Codes, in accordance with the attached Schedule A.

SECTION 3. That the Chief Financial Officer is hereby authorized to receive and deposit funds in an amount not to exceed \$250,000.00 in FY22 Community Policing Development Crisis Intervention Teams Fund, Fund F700, Department DPD, Unit 271C, Revenue Code 6506.

SECTION 4. That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$250,000.00 from the FY22 Community Policing Development Crisis Intervention Teams Fund, Fund F700, Department DPD, Unit 271C, various Object Codes, in accordance with the attached Schedule A.

SECTION 5. That in the event of loss or misuse of funds, the grantee will return grant funds to the DOJ in full. The City Manager shall notify the appropriate City Council Committee of expenditures identified as ineligible not later than 30 days after the reimbursement.

SECTION 6. That the City Manager shall keep the appropriate City Council Committee informed of all the DOJ final monitoring reports not later than 30 days after the receipt of the report.

SECTION 7. That this contract is designated as Contract No. DPD-2022-00018313.

SECTION 8. That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
