SUBJECT Short-Term Rental Task Force Restructuring

Colleagues,

The purpose of this memo is to provide an update on the Short-Term Rental (STR) ordinance and regulation process. I would first like to thank Councilmembers Blackmon, Narvaez, and Ridley for their leadership throughout this process, and for working with stakeholders to craft policy recommendations up to this point. Over the past several months, working groups that include the task force led by my colleagues mentioned above, have collaborated with residents to develop regulations and policies for STRs to be presented to the Quality of Life, Arts, and Culture (QLAC) Committee. We have made great progress thus far.

The previous committee started this process with a timeline that we have not yet met. As the Chair of Quality of Life, Arts and Culture (QLAC) Committee, I am pleased to announce new timeline expectations along with structural changes to the working group task force. To streamline this process, I would like for the STR task force to meet biweekly from now until the end of January 2022. This will allow for us to conduct at least five meetings before bringing the task force's recommendations to the Quality of Life, Arts and Culture (QLAC) Committee special-called meeting scheduled for January 31, 2022 at 9:00am. There will also be opportunity for public comments.

The task force meetings will be live-streamed via the City of Dallas website and conducted in-person at City Hall. The task force will be limited to nine members, and will be cochaired by myself, Chair Bazaldua, and committee Vice Chair, Mayor Pro Tem West. The remaining seven members will be appointed by the Quality of Life, Arts & Culture (QLAC) Committee members on a first-come, first-served basis, and will be required to meet the following qualifications:

- Must be residents of the City of Dallas
- 1 Task Force member must be the owner/operator of an owner-occupied STR
- 1 Task Force member must be a commercial STR owner/operator
- 1 Task Force member must represent an STR platform
- 4 Task Force members must be community stakeholders (residents or business owners)

Task force members must be appointed by Thursday, November 11, 2021.

I look forward to continuing the work towards smart and equitable policies for STRs.
