Technology



ProjectDox – Permitting Software

- The User Acceptance Testing (UAT) was completed on June 6, 2022
- Issues identified and resolved include:
 - Payment
 - Workflow missing a step
 - Some features in the current version not included in the 9.2 update
 - Permits not going to "issued" status or not generated in POSSE



Technology (continued)



ProjectDox – Permitting Software

- The current version of the system being used has been having issues at least once or twice a week
 - A total of 15 Trouble Tickets were reported from May 1 –
 June 10, and issues are normally addressed within a day
 - Communication with stake holders are ongoing
- Staff meets with Information & Technology Services (ITS) on a weekly basis to discuss issues that arise with the system
- Staff is working on a dedicated IT team for all software the department implements



Technology (cont.)



- For the new update, staff training will begin the week of June 27, 2022
- Stakeholders virtual demo several opportunities week of July 11, 2022
- The go-live date is scheduled for the first week of August 2022
- In-person training for stakeholders will begin the first Saturday following the go-live date



Technology (cont.)



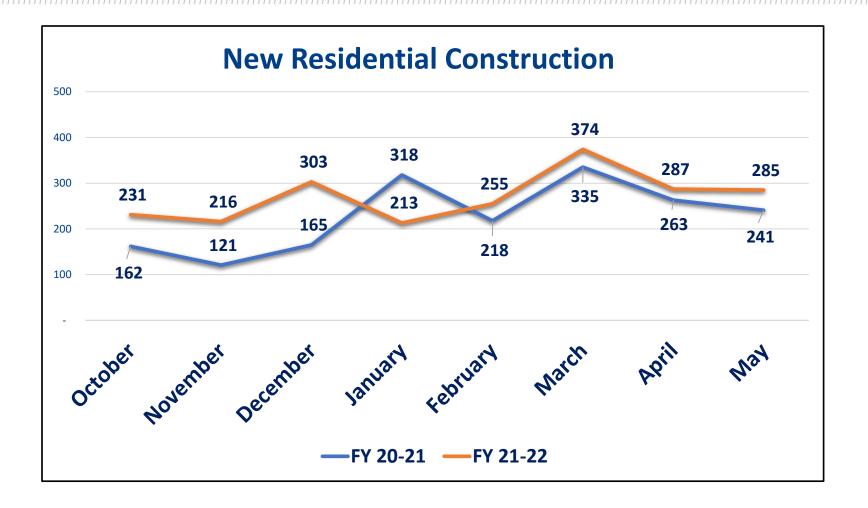
Posse Replacement

- City staff has continued to meet with the software consultant
 - Weekly reoccurring meetings
 - Scope of Work is in DRAFT format and being refined, and final DRAFT is expected to be completed September/October 2022



Residential Permit Metrics





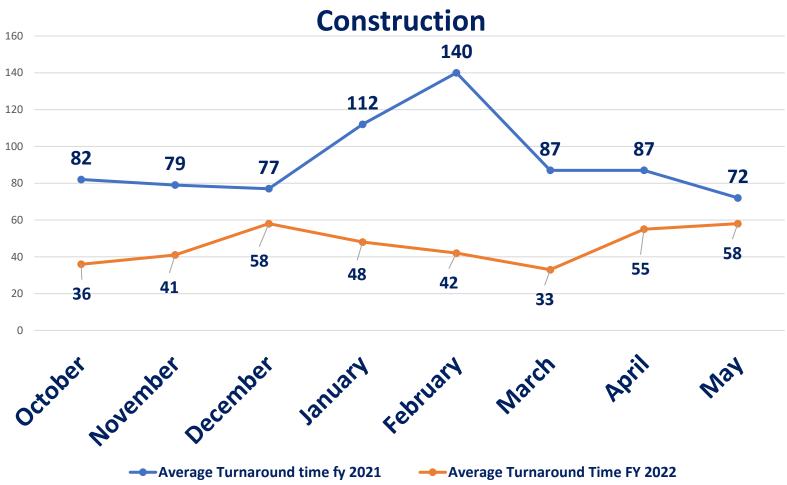
Total Fiscal Year (FY) to Date 2,164 = 16% Increase from FY 2021
