WHEREAS, Dallas Water Utilities (DWU) provides water to approximately 2.6 million residents in the City of Dallas and neighboring communities and operates three potable water treatment plants with a combined treatment capacity of approximately 900 million gallons per day; and

WHEREAS, DWU has identified the need for various major maintenance and rehabilitation improvements at each of its water treatment plants to address aging infrastructure, meet regulatory standards, operate safely, and ensure reliable water service; and

WHEREAS, DWU has prepared construction plans and specifications for major maintenance and rehabilitation improvements at each of its water treatment plants; and

WHEREAS, on June 3, 2022, one bid was received for major maintenance and rehabilitation improvements at Dallas Water Utilities Water Treatment Plants, Contract No. 22-005 listed as follows:

WHEREAS, the bid submitted by Archer Western Construction, LLC, 1411 Greenway Drive, Irving, Texas 75038, in the amount of \$25,427,590.00, is the only bid received; and

WHEREAS, DWU has reviewed this procurement and determined that the bid was conducted in accordance with Administrative Directive 4-5 and that reasonable efforts were made to increase bid participation. DWU has also determined that this procurement meets the requirements of a single bid and represents a good value for the work to be performed.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the bid submitted by Archer Western Construction, LLC, in the amount of \$25,427,590.00, for doing the work covered by the plans, specifications, and contract documents, Contract No. 22-005, be accepted.

SECTION 2. That the City Manager is hereby authorized to execute a construction services contract with Archer Western Construction, LLC, approved as to form by the City Attorney, for major maintenance and rehabilitation improvements at Dallas Water Utilities Water Treatment Plants, in an amount not to exceed \$25,427,590.00.

SECTION 3. That the City Manager is hereby authorized to increase appropriations in an amount not to exceed \$20,001,590.00 in the Water Construction Fund, Fund 0102, Department DWU, Unit CW31, Object Code 4320.

SECTION 4. That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$25,427,590.00 to Archer Western Construction, LLC, as follows:
