WHEREAS, the City's stormwater permit requires control of the quality of stormwater discharged. Specifically, the permit requires implementation of programs to collect and recycle, reuse, or properly dispose of Household Hazardous Waste (HHW) and to make those programs available to the residential sector; and

WHEREAS, the City of Dallas is a crucial partner (one of 16 participating cities) in a region's Household Hazardous Waste (HHW) collection program, operated by Dallas County; and

WHEREAS, on August 24, 1994, City Council authorized an Interlocal Agreement with Dallas County to undertake a variety of activities necessary to coordinate planning and implementation of an HHW collection system which has been renewed every year since then by Resolution No. 94-3064; and

WHEREAS, it is now desirable to enter into a new interlocal agreement with Dallas County, to replace the expired agreement, to address costs associated with collection and disposal of HHW originating in the City of Dallas, for a twelve-month period in an amount not to exceed \$1,171,900.00, appropriating FY 2022-23 funding amount of \$1,171,900.00. The appropriation of \$1,171,900.00 include \$391,779.00 for the City's share of the HHW Program operational and capital budget and the rest is for the projected disposal cost that will be invoiced monthly by Dallas County based on the actual participation of City of Dallas residents during the month, and subsequent extensions of agreement are subject to appropriations; and

WHEREAS, Dallas County is willing to enter this interlocal agreement in accordance with the Interlocal Cooperation Act, Chapter 791 of the Texas Government Code for FY2007-08.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the City Manager is hereby authorized to execute an Interlocal Agreement with Dallas County, approved as to form by the City Attorney, for participation in Dallas Area Household Hazardous Waste (HHW) Network collection program for the period from October 1, 2022, to September 30, 2023, with options to extend agreement for four additional twelve-month periods.

SECTION 2. That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$1,171,900.00 in FY 2022-23, \$1,242,214.00 in FY 2023-24, \$1,316,747.00 in FY 2024-25, \$1,395,751.00 in FY 2025-26, and \$1,479,496.00 in FY 2026-27 to Dallas County from Sanitation Operation Fund, Fund 0440, Department SAN, Unit 3598, Object 3099, Vendor 014003, Encumbrance/Contract No. SAN-2022-00019771, which are subject to appropriations in annual budget adoption each fiscal year.

SECTION 3. That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
