WHEREAS, the City Council has ordered a special election to be held on Tuesday, November 8, 2022; and

WHEREAS, the purpose of the special election is on the question of approving and implementing a resolution designating the expansion of the Kay Bailey Hutchison Convention Center Dallas (KBHCCD) and certain improvements at Fair Park within the City of Dallas as venue projects and designating the method of financing pursuant to Chapter 334, Texas Local Government Code (the Act); making provisions for the conduct of the election; and providing an effective date; and

WHEREAS, Dallas County and other jurisdictions have also ordered elections to be held on Tuesday, November 8, 2022; and

WHEREAS, the City of Dallas and other jurisdictions holding elections on Tuesday, November 8, 2022, desire to hold the elections jointly in accordance with Chapter 271 of the Texas Election Code; and

WHEREAS, the City of Dallas and other jurisdictions holding elections on Tuesday, November 8, 2022, desire to contract with Dallas County on behalf of the Dallas County Elections Administrator for election services in accordance with Subchapter D of Chapter 31 of the Texas Election Code; and

WHEREAS, the joint election services contract provides that the Elections Administrator will arrange for the selection, training and compensation of precinct election judges, subject to the approval of the City and the other contracting authorities.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the City Manager is authorized to execute a joint election services contract between the City of Dallas, Dallas County, and other jurisdictions holding joint elections on Tuesday, November 8, 2022, to be administered by the Dallas County Elections Administrator in accordance with Subchapter D of Chapter 31 and Chapter 271 of the Texas Election Code.

SECTION 2. That the joint election services contract will provide that the Dallas County Elections Administrator will perform or supervise the performance of any or all of the corresponding duties and functions in connection with a Dallas County-wide election.

- **SECTION 3.** That the joint election services contract will provide that the Dallas County Elections Administrator may contract with third parties for election services and supplies and pay the claims for those election expenses from funds deposited by the City and the other contracting authorities in an election services contract fund in the county treasury established for this election.
- **SECTION 4.** That the Dallas County Elections Administrator has provided the City Secretary with an itemized list of estimated election expenses to be paid from the election services contract fund prior to execution of the contract, and will provide an itemized list of actual election expenses to be paid from the election services contract fund no later than the 180th day after the date of the election.
- **SECTION 5.** That the City Secretary is authorized to approve on behalf of the City any changes in the list of recommended election judges which may become necessary because of the inability or refusal to serve of any of the persons named in joint election services contract.
- **SECTION 6.** That the Chief Financial Officer is hereby authorized to pay the Dallas County Treasurer for deposit in the election services contract fund as the City's estimated share of the costs of the Tuesday, November 8, 2022 joint election an amount not to exceed \$1,656,319.45, (subject to annual appropriations) from the following appropriations: General Fund, Fund 0001, Department SEC, Unit 1190, Object 3070, Fiscal Year 2021-2022, Encumbrance/Contract No. SEC-2022-00020287, Vendor 014003.
- **SECTION 7.** That the Chief Financial Officer is hereby authorized to pay for notices and advertising services in an amount not to exceed \$195,000.00 from General Fund, Fund 0001, Department SEC, Appropriation Unit 0001ELE, Unit 1190, Object 3320.
- **SECTION 8.** That the Chief Financial Officer is hereby authorized to pay for translation services in an amount not to exceed \$5,000.00 from General Fund, Fund 0001, Department SEC, Appropriation Unit 0001ELE, Unit 1190, Object 3099.
- **SECTION 9.** That the Chief Financial Officer is hereby authorized to transfer funds for the purpose of reimbursement not to exceed \$1,856,319.45 from Convention Center Capital Construction Fund, Fund 0082, Department CCT, Unit W433, Object Code 3090, to General Fund, Fund 0001, Department SEC, Appropriation Unit 0001ELE, Unit 1190, Object Code 5011.
- **SECTION 10.** That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
