**WHEREAS**, a grant from the Community Challenge Grant from American Association of Retired Persons (AARP) providing funding to the City of Dallas has been awarded; and

**WHEREAS**, this grant is for the benefit of the West Dallas Multipurpose Center to support the purchase of benches and signage; and

**WHEREAS**, the City of Dallas will benefit from these funds by enhancing the perimeter of the West Dallas Multipurpose Center campus, increasing usage of the multigeneration activities at the Center; and

**WHEREAS**, the use and benefit of these benches can increase multigenerational physical activity and thus slightly improve the quality of life for our West Dallas residents.

**Now, Therefore,**

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:**

**SECTION 1.** That the City Manager is hereby authorized to **(1)** accept the grant from the Community Challenge Grant from AARP for the West Dallas Multipurpose Center in the amount of \$10,000.00 for the period September 1, 2022 through December 31, 2022 **(2)** for the purchase and installation of five benches and two signs at the West Dallas Multipurpose Center, a facility of the City of Dallas, to provide community with vaccinations for the monkeypox; and **(3)** and execute the grant agreement with the AARP with all terms, conditions and documents required by the agreement, including mutual indemnity, waiver of jury trial, and venue, approved as to form by the City Attorney.

**SECTION 2.** That the Chief Financial Officer is hereby authorized to receive and deposit grant funds from AARP in an amount not to exceed \$10,000.00 in the Community Challenge Grant AARP Fund, Fund P166, Department MGT, Unit 298C, Revenue Code 8411.

**SECTION 3.** That the City Manager is hereby authorized to establish appropriations in an amount not to exceed \$10,000.00 in the Community Challenge Grant AARP Fund, Fund P166, Department MGT, Unit 298C, Object 3099.

**SECTION 4.** That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$10,000.00 from the Community Challenge Grant AARP Fund, Fund P166, Department MGT, Unit 298C, Object 3099.

**SECTION 5.** That the City Manager is hereby authorized to reimburse the AARP any expenditures identified as ineligible by the granting agency and notify the appropriate City Council Committee of expenditures identified as ineligible not later than 30 days after reimbursement.

**SECTION 6.** That the City Manager shall keep the appropriate City Council Committee informed of all final granting agency monitoring reports not later than 30 days after the delivery of the report.

**SECTION 7.** That the City Manager of his designee is authorized to provide additional information, adjust, and take other actions related to the implementation of the grant as necessary to satisfy the terms of the grant award.

**SECTION 8.** That this contract is designated as Contract No. OCC-2022-00019973.

**SECTION 9.** That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
