WHEREAS, the Fair Housing Ordinance, Chapter 20A of the Dallas City Code, was amended on November 7, 1990 and September 25, 1991 for the purpose of obtaining certification from the U.S. Department of Housing and Urban Development (HUD) that the City of Dallas is a fair housing agency operating substantially equivalent to HUD; and

**WHEREAS,** on June 12, 1992, HUD granted the City of Dallas interim certification as a substantially equivalent fair housing agency; and

**WHEREAS**, on April 24, 1995, HUD granted the City of Dallas final certification as a substantially equivalent fair housing agency; and

**WHEREAS,** on October 14, 2015, City Council authorized the acceptance of a grant from HUD for the Fair Housing Assistance Program (FHAP) in the amount of \$274,825.00 for the period October 1, 2015 through September 30, 2016 by Resolution No. 15-1870; and

**WHEREAS,** on August 10, 2016, City Council authorized the acceptance of a grant from HUD for the FHAP in the amount of \$20,000.00 for the period May 20, 2016 through September 30, 2017, by Resolution No. 16-1178; and

**WHEREAS,** on October 11, 2016, City Council authorized acceptance of a grant from HUD for the FHAP in the amount of \$277,350.00 for the period October 1, 2016 through September 30, 2017, by Resolution No. 16-1653; and

**WHEREAS**, on October 25, 2017, City Council authorized acceptance of the FY 2017-18 grant from HUD for the FHAP in the amount of \$284,850.00 for the period October 1, 2017 through September 30, 2018, by Resolution No. 17-1651; and

**WHEREAS,** on October 24, 2018, City Council authorized acceptance of the FY 2018-19 grant from HUD for the FHAP in the amount of \$279,900.00 for the period October 1, 2018 through September 30, 2019, by Resolution No. 18-1507; and

**WHEREAS,** on September 11, 2019, City Council authorized acceptance of the FY 2019-20 grant from HUD for the FHAP in the amount of \$257,300.00 for the period of October 1, 2019 through September 30, 2020, by Resolution No. 19-1400; and

WHEREAS, on September 23, 2020, City Council authorized acceptance of the FY 2020-21 grant from HUD for the FHAP in the amount of \$290,400.00 for the period of October 1, 2020 through September 30, 2021 and acceptance of the HUD Partnership Grant for FHAP in the amount of \$17,500.00 for the period April 3, 2020 through April 3, 2023, by Resolution No. 20-1435; and

**WHEREAS,** on September 9, 2021, City Council authorized acceptance of the FY 2021-22 grant from HUD for the FHAP in the amount of \$171,900.00 for the period of October 1, 2021 through September 30, 2022, by Resolution 21-1462; and

**WHEREAS,** on August 22, 2022, HUD awarded the City of Dallas FHAP Cooperative Agreement funds for Fiscal Year 2022-23 in the amount of \$173,580.00.

Now, Therefore,

## BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

**SECTION 1.** That the City Manager is hereby authorized to accept the FY 2022-23 grant from HUD for the Fair Housing Assistance Program (Grant No. FF206K226005, CDFA No. 14.401) in the amount of \$173,580.00 for processing, investigating, and conciliating housing discrimination complaints, administrative costs, and HUD required staff training for the period October 1, 2022 through September 30, 2023, and execute the cooperative agreement and all terms, conditions, and documents required by the grant, approved as to form by the City Attorney.

**SECTION 2.** That the Chief Financial Officer is hereby authorized to receive and deposit grant funds in an amount not to exceed \$173,580.00 in the HUD-FY22 Fair Housing Assistance Program FY23 Fund, Fund F717, Department MGT, Unit 317C, Revenue Code 6506.

**SECTION 3.** That the City Manager is hereby authorized to establish appropriations in an amount not to exceed \$173,580.00 in the HUD-FY22 Fair Housing Assistance Program FY23 Fund, Fund F717, Department MGT, Unit 317C, various Object Codes according to the attached Schedule A.

**SECTION 4.** That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$173,580.00 from the HUD-FY22 Fair Housing Assistance Program FY23 Fund, Fund F717, Department MGT, Unit 317C, various Object Codes, according to the attached Schedule A.

**SECTION 5.** That the City Manager is hereby authorized to reimburse HUD any expenditure identified as ineligible. The City Manager shall notify the appropriate City Council Committee of expenditures identified as ineligible no later than 30 days after the reimbursement.

**SECTION 6.** That the City Manager shall keep the appropriate City Council Committee informed of all final HUD monitoring reports no later than 30 days after the receipt of the report.

**SECTION 7.** That this contract is designated as Contract No. FHO-2022-00020273.

**SECTION 8.** That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
