systems without the necessity at any time of procuring the permission of anyone. (Any public utility shall have the right of ingress and

egress to private property for the purpose of reading meters and any maintenance or service required or ordinarily performed by that Water main and wastewater easements shall also include additional area of working space for construction and maintenance of the systems. Additional easement area is also conveyed for installation and maintenance of manholes, cleanouts, fire hydrants, water

services and wastewater services from the main to the curb or pavement line, and description of such additional easements herein
