**WHEREAS**, in late April 2022, the U.S. Department of Housing and Urban Development (HUD) announced that approximately \$24.4 million of Community Development Block Grant Disaster Recovery funding has been allocated to the City of Dallas under the second tranche of funds released from the Disaster Relief and Supplemental Appropriations Act of 2022; and

**WHEREAS**, funding was allocated to the City as a result of the winter and ice storm (FEMA Disaster No. 4586) that occurred in Dallas, TX in February 2021; and

**WHEREAS**, Community Development Block Grant Disaster Recovery (CDBG-DR) Funds must only be spent for necessary activities related to-restoration of infrastructure and housing, economic revitalization, and mitigation in the “most impacted and distressed (MID)” areas of qualifying disasters and includes all of Dallas; and

**WHEREAS**, funds may only be used for unmet disaster recovery or mitigation needs not addressed by other resources; and

**WHEREAS**, on December 14, 2022, the City Council authorized final adoption of the 2022 CDBG-DR Budget and Action Plan by Resolution No. 22-1836; and

**WHEREAS**, on January 18, 2023, HUD distributed an Allocation Amendment Notice increasing the amount of CDBG-DR funds allocating additional CDBG-DR funds to the City of Dallas in the amount of \$15,967,000 from the Continuing Appropriations Act, 2023 (Pub. L. 117-180); and

**WHEREAS**, pursuant to the aforementioned notice, the City is permitted to submit a single budget and Action Plan including all funds allocated under both laws; and

**WHEREAS**, on February 10, 2023, City Council was briefed by memorandum on the Proposed 2022 Amended CDBG-DR Budget and draft Action Plan; and

**WHEREAS**, on March 2, 2023, the Community Development Commission was provided an update on the proposed 2022 Amended CDBG-DR Budget and draft Action Plan; and

**WHEREAS**, on March 8, 2023, City Council authorized preliminary adoption of the Proposed Amended CDBG-DR Budget and draft Action Plan and a public hearing to receive comments on the proposed use of funds by Resolution No. 23-0354; and

**WHEREAS**, on April 4, 2023, City Council was briefed on the Proposed 2022 Amended CDBG-DR Budget and draft Action Plan; and

**WHEREAS**, Federal regulations require that a public hearing be held on the City’s Proposed 2022 Amended CDBG-DR Budget and draft Action Plan; and

**WHEREAS**, a summary of the Proposed 2022 Amended CDBG-DR Budget and draft Action Plan was made available for public review and comment on or about March 8, 2023 through April 11, 2023 and a notice was published in the Dallas Morning News on or about March 19, 2023 to provide residents an opportunity to submit written comments through April 11, 2023, satisfied the requirements set forth in HUD regulations.

**Now, Therefore,**

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:**

**SECTION 1.** That final adoption of the 2022 Amended Community Development Block Grant Disaster Recovery (CDBG-DR) Budget and Action Plan to accept additional CDBG-DR funds in the amount of \$15,967,000, increasing the total amount to be received from the U.S. Department of Housing and Urban Development from \$24,433,000 to \$40,400,000, as set forth in the attached Schedule.

**SECTION 2.** That the City Manager is hereby authorized to increase appropriations in the CDBG-Disaster Recovery Fund, Fund CDD1, in an amount not to exceed \$15,967,000 (Grant No. B-21-MF-48-0003, P-21-DA-48-LDZ) and Federal Assistance Listing No. 14.218 & 14.228) according to the attached Schedule.

**SECTION 3.** That the Chief Financial Officer is hereby authorized to receive and deposit additional grant funds as reimbursement from HUD in an amount not to exceed \$15,967,000 in the CDBG-Disaster Recovery Fund, Fund CDD1, Revenue Code 6506 according to the attached Schedule.

**SECTION 4.** That the Chief Financial Officer is hereby authorized to disburse additional grant funds in an amount not to exceed \$15,967,000 in the CDBG-Disaster Recovery Fund, Fund CDD1, according to the attached Schedule.

**SECTION 5.** That the City Manager is authorized to take all actions necessary to account for and report the use of grant funds from CDBG-Disaster Recovery Fund, Fund CDD1, including but not limited to creating additional units, and transferring appropriations, and/or expenses between units as needed to implement the disaster recovery program

**SECTION 6.** That the City Manager is hereby authorized to reimburse to HUD any expenditures identified as ineligible.

**SECTION 7.** That the City Manager shall notify the appropriate City Council Committee of expenditures identified as ineligible not later than 30 days after the reimbursement.

**SECTION 8.** That the City Manager shall keep the appropriate City Council Committee informed of all final HUD audit reports not later than 30 days after the receipt of the reports.

**SECTION 9.** That the City Manager is authorized to provide additional information, adjust, and take other actions relating to these grants and grant budgets as may be necessary in order to satisfy HUD requirements.

**SECTION 10.** That the City Manager be authorized to execute the contracts and grant agreements with HUD and all documents related to the execution of the grants, and all documents and agreements necessary to implement programs funded hereunder, approved as to form by the City Attorney.

**SECTION 11.** That the CDBG-DR Grant from HUD is designated as Contract No. BMS-2022-00020617.

**SECTION 12.** That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
