An ordinance amending Ordinance No. 28714, by altering Section 5, providing for consideration to be paid to the City of Dallas; providing for payment of the publication fee; providing a savings clause; and effective date.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That Ordinance No. 28714 adopted by the City Council of the City of Dallas on August 8, 2012, be and the same is hereby amended by altering Section 5 to read as follows:

SECTION 5. That the licensed area shall be used by **GRANTEE** for the following purposes under the direction of the Director of Department of Sustainable Development and Construction of the City of Dallas: installation and maintenance of <u>chilled water lines in St. Joseph Street right-of-way and</u> six fiber optic subsurface communication cables in Apple Street, Swiss Avenue and St. Joseph Street rights-of-way.

SECTION 2. That, as consideration for amending Ordinance No. 28714, Dallas Theological Seminary agrees to pay monetary consideration in the sum of ONE THOUSAND AND NO/100 (\$1,000.00) DOLLARS.

SECTION 3. That the Chief Financial Officer is hereby authorized to deposit the sum paid by **GRANTEE** pursuant to Section 2 above in the General Fund, Fund 0001, Department PBW, Unit 1181, Revenue Code 8200.

SECTION 4. That Ordinance No. 28714 adopted by the City Council of the City of Dallas on August 8, 2012, be and the same is hereby amended by altering Section 5 hereto and made a part hereof.

SECTION 5. That the terms and conditions of Ordinance 28714 shall remain in full force and effect except as amended hereby.

SECTION 6. That the City Secretary is hereby authorized and directed to certify a copy of this ordinance for recordation in the Deed Records of Dallas County, Texas, which certified copy shall be delivered to the Director of Department of Public Works, or designee. Upon receipt of fees pursuant to Section 2 of this ordinance, an acceptable certificate of insurance

and the fee for publishing this ordinance which **GRANTEE** shall likewise pay, the Director of Department of Public Works, or designee shall deliver to **GRANTEE** the certified copy of this ordinance. The Director of Department of Public Works, or designee, shall be the sole source for receiving certified copies of this ordinance for one year after its passage.

SECTION 7. That this ordinance is designated for City purposes as Contract No. PBW-2022-00020265.

SECTION 8. That this ordinance shall take effect immediately from and after its passage and publication in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so ordained.
