WHEREAS, during the 88th Texas State Legislative Session funding was appropriated in Strategy B.1.1, Criminal Justice, the \$10,000,000.00 in General Revenue in each fiscal year of the biennium for the purpose of providing a grant for the design and construction of a Dallas Police Department regional law enforcement training facility at the University of North Texas at Dallas campus; and

WHEREAS, the funding aims to address the critical infrastructural and facility challenges at the Dallas Police Training Academy to meet the growing demand for Dallas Police Department regional police training; and

WHEREAS, this appropriation of funds will be used for a state-of-the-art Dallas Police Department regional training facility that accommodates increased recruits, enhances training quality, and ultimately contributes to better public safety in Dallas; and

WHEREAS, will provide funding for an owner's representative, and planning and design work for the new facility; and

WHEREAS, the City of Dallas agrees that in the event of loss or misuse of the CJD funds, the City of Dallas assures that the funds will be returned to the CJD in full; and

WHEREAS, it is in the best interest of the City of Dallas to accept such funding.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the City Manager is hereby authorized to accept DPD Police Academy from Office of Governor (Grant No. 4922901) in the amount of \$10,000,000.00 for the design and construction of a Dallas Police Department regional law enforcement training facility at the University of North Texas at Dallas campus for the period October 1, 2023 through September 30, 2025; and execution of the grant agreement with the Office of Governor and all terms, conditions, and documents required by the agreement, approved as to form by the City Attorney.

SECTION 2. That the City Manager is hereby authorized to establish appropriations in an amount not to exceed \$10,000,000.00 in the LE-Regional Law Enforcement Facility Fund, Fund S410, Department DPD, Unit 678V, Object 4110 and 4116.

- **SECTION 3.** That the Chief Financial Officer is hereby authorized to receive and deposit grant funds in an amount not to exceed \$10,000,000.00 in the LE-Regional Law Enforcement Facility Fund, Fund S410, Department DPD, Unit 678V, Revenue Code 6516.
- **SECTION 4.** That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$10,000,000.00 from the LE-Regional Law Enforcement Facility Fund, Fund S410, Department DPD, Unit 678V, Object Codes 4110 and 4116.
- **SECTION 5.** That the City Manager is hereby authorized to reimburse to the granting agency any expenditure identified as ineligible. The City Manager shall notify the appropriate City Council Committee of expenditures identified as ineligible not later than 30 days after the reimbursement.
- **SECTION 6.** That the City Manager or his designee is authorized to provide additional information, make adjustments, and take other actions related to the implementation of the grant as may be necessary to satisfy the Office of the Governor.
- **SECTION 7.** That this grant agreement is designated as Contract No. DPD-2024-00024144.
- **SECTION 8.** That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
