BACKGROUND INFORMATION:

- On June 22, 2022, Planned Development District No. 1086 was established by Ordinance No. 32245.
- Development and use of the Property must comply with the development plan (Exhibit 1086C).
- Landscaping must be provided as shown on the landscape plan (Exhibit 1086D).

REQUEST DETAILS:

The applicant is requesting to amend the development plan and landscape plan in Planned District No. 1068.

The proposed development plan reflects a slightly reconfigured building footprint, adjusted property lines to match plat, adjusted curb lines, and revised parking spaces interior to the site as well as along surrounding street frontages due to bike lanes along Sylvan Avenue.

The proposed landscape plan reflects the amendments made to the development plan and allows for the removal, replacement, and relocation of trees due to utility conflicts and curb realignment, sidewalks, and proximity to structures. The landscape plan was reviewed by the City Arborist and determined they have no objections.

The Transportation Development Services Division of the Transportation Department has reviewed the request and has no objection to the proposed minor amendment.

This is not a zoning change request and no changes to the existing zoning standards can be considered. The only purpose of this hearing is to determine if the proposed amendment to the development plan complies with the standards established for minor amendments. The Dallas City Code requires that if the plan amendment complies with the standards for a minor amendment, the plan shall be approved.

Upon review of the proposed development plan, staff has determined that the request meets the minor amendment criteria for a development plan, a landscape plan, complies with the requirements set forth by Planned Development Subdistrict No. 1086, and does not impact any other provisions of the ordinance.








