- 15 appointees tasked with reviewing the Charter and recommending amendments to City Council.
- Required by Charter every 10 years.
- Meetings began September 27, 2023.
- Suggested amendments were solicited between October 15, 2023 and January 19, 2024.

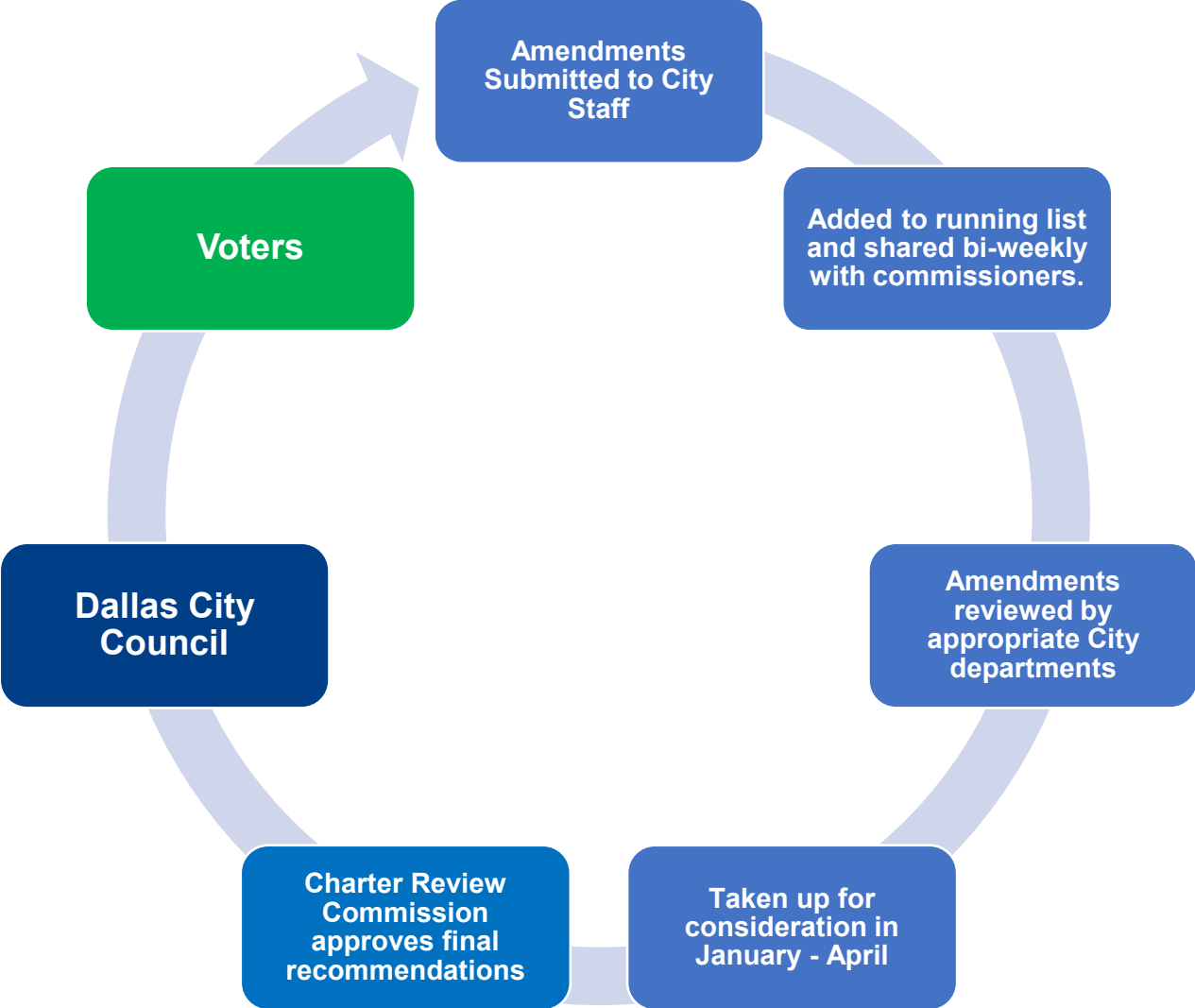

Pursuant to Chapter II, Section 3 of the Charter, the Charter "shall be reviewed by a commission appointed by the council." The Commission is responsible for reviewing the Charter and submitting a report to the city council no later than May 21, 2024. After receiving the Commission's report, the city council may adopt, modify, or disregard the Commission's recommended amendments and/or propose its own.

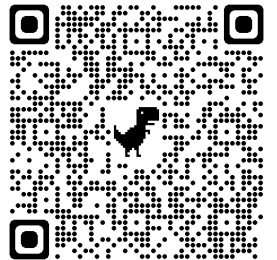

Solicitation of Suggested Amendments



- On October 15, 2023, the Commission issued a call for suggested amendments to Councilmembers, City departments, and general stakeholders.
- Deadline for submission was extended to January 19, 2024.
- Every amendment was placed on a meeting agenda, except those withdrawn by the submitters.

Considered Proposals



- 125 amendments were submitted for consideration.
 - ☐ 12 amendments were withdrawn by submitters before being considered.
 - ☐ 78 amendments were considered and excluded from the final report.
 - ☐ 35 amendments were included as recommendations to the City Council.

CRC Recommendations



- **Technical Amendments Included for Final Consideration:**
 - ☐ Eleven amendments recommended by the City Attorney's Office, City Secretary's Office, Civil Service, and Human Resources.
 - ☐ Clarify that, in addition to annual salaries, the mayor and councilmembers may also receive benefits for elected officials as permitted by law.
 - ☐ Change charter language to be more inclusive in certain provisions.



CRC Recommendations



- **Operational Amendments Included for Final Consideration:**
 - ☐ Allow boards and commissions to elect their own vice chairs.
 - ☐ Delete the requirement for bids to be opened in a public place.
 - ☐ Treat reorganizations and reductions in force in the same manner with respect to compensation and reassignment.



CRC Recommendations



- **Operational Amendments Included for Final Consideration:**
 - ☐ Require that special called meetings of council require five councilmember signatures rather than three.
 - ☐ Provide the city secretary and city auditor with assistants and employees.
 - ☐ Broaden the city's notification process to include other media options, in addition to newspaper publication.



CRC Recommendations



- **Operational Amendments Included for Final Consideration:**
 - ☐ Require that the Office of Community Police Oversight director be appointed by and report directly to the city council.
 - ☐ Establish the Office of Inspector General in the city charter with the Inspector General being appointed by city council.
 - ☐ Delete the provision prohibiting the city council from interfering with appointments and subordinates of the city manager.



CRC Recommendations



- **Policy Amendments Included for Final Consideration:**

- ☐ Extend the deadline petitioners must meet to collect the required signatures on a petition from 60 to 120 days.
- ☐ Reduce the number of signatures required on a petition in support of holding a referendum.
- ☐ Allow authorized residents to serve on Park Board, Redistricting Commission, Civil Service Board, and the City Plan Commission, not just citizens or registered voters.



What Amendments is CRC Considering?



- **Policy Amendments Included for Final Consideration:**
 - ☐ Establish a Community Bond Commission.
 - ☐ Add a provision triggering the implementation of ranked choice voting in municipal elections once the state law is amended to allow for it.
 - ☐ Increase the annual salary for councilmembers to \$125k/year and for the mayor to \$140k/year, indexed to Consumer Price Index.



What Amendments is CRC Considering?



- **Policy Amendments Included for Final Consideration:**
 - ☐ Allow city council's appointments to boards and commissions to be replaced by city council prior to the completion of the member's term.
 - ☐ Add eligibility criteria for serving on the redistricting commission.

Proposed Process



- Councilmembers will have until Wednesday, May 15 at 5:00 p.m. to submit their own suggested amendments for review. All amendments after that deadline must be made on the floor.
- The Council will cast straw votes on the Commission's recommendations in the final report on May 15 and June 5.
- June 5 and 18 meetings will be used to review and cast straw votes on any new amendments submitted by Councilmembers by the May 15 deadline.
- Possible special-called meeting dates, if needed: June 10, 11, 20, 24, 25.



Next Steps



- May 3 - Friday memo with process for submitting amendments to staff.
- Between now and the May 15 deadline, staff and attorneys will be available to assist in drafting amendments and to provide legal advice, as needed.
