BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the bid submitted by Thalle Construction Co., Inc., in the amount of \$13,198,722.40, for doing the work covered by the plans, specifications, and contract documents, Contract No. 19-399/400, be accepted.

SECTION 2. That the City Manager is hereby authorized to execute a construction contract with Thalle Construction Co., Inc., approved as to form by the City Attorney, for the installation and rehabilitation of water and wastewater mains at three locations and the Azalea Drainage Relief Improvement, in an amount not to exceed \$13,198,722.40.

SECTION 3. That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$13,198,722.40 to Thalle Construction Co., Inc., as follows:
