**WHEREAS**, on June 17, 2015, City Council authorized a thirty-six-month service contract for veterinary services for Dallas Police canine and equine units and Fire-Rescue canine unit with East Lake Veterinary Hospital, P.C. in the amount of \$235,000 and Cedar Hill Veterinary Clinic in the amount of \$70,000, by Resolution No. 15-1229; and

**WHEREAS**, on June 18, 2018, Administrative Action No. 18-6110 authorized a six-month service contract for veterinary services for Police canine and equine units and Fire Rescue canine unit from June 16, 2018 to December 31, 2018, with East Lake Veterinary Hospital, P.C. in an amount not to exceed \$32,500, from \$235,000 to \$267,500.

**Now, Therefore,**

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:**

**SECTION 1.** That the City Manager is hereby authorized to execute a service price agreement with Casa Linda Animal Clinic, Inc. (182834) in the estimated amount of \$671,600 and The Equine Hospital at Lone Star Park dba Lone Star Park Equine Hospital (VC0000004944) in the estimated amount of \$75,000, approved as to form by the City Attorney, to provide veterinary services for the Police Department's canine and equine units, and the Fire-Rescue Department's canine unit for a term of five years, in the total estimated amount of \$746,600. The amount payable pursuant to this service price agreement may exceed the estimated amount, but may not exceed the amount of budgetary appropriations for this service price agreement during its term. Payments made to Casa Linda Animal Clinic, Inc. and The Equine Hospital at Lone Star Park dba Lone Star Park Equine Hospital shall be based only on the amount of the services directed to be performed by the City and properly performed by Casa Linda Animal Clinic, Inc. and The Equine Hospital at Lone Star Park dba Lone Star Park Equine Hospital under the service price agreement. The City Manager is further authorized, in the City Manager's sole discretion, to exercise an option to extend the contract for six months by filing a notice of extension with the City Secretary's Office.

**SECTION 2.** That the Chief Financial Officer is hereby authorized to disburse funds in an estimated amount of at least \$746,600, but not more than the amount of budgetary appropriations for this service price agreement during its term to Casa Linda Animal Clinic, Inc. and The Equine Hospital at Lone Star Park dba Lone Star Park Equine Hospital from Service Price Agreement No. POM-2019-00010907.

**SECTION 3.** That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
