WHEREAS, the Texas Department of Transportation (TxDOT) will construct upgrades to the nine existing traffic signals at, Scyene Road (State Highway 352) and Prairie Creek Road (CSJ 0430-01-060), Robert B. Cullum Boulevard (State Highway 352) and Fitzhugh Avenue (CSJ 0197-01-013), Scyene Road (State Highway 352) and St. Augustine Drive (CSJ 0430-01-061), Buckner Boulevard (Loop 12) and Samuell Boulevard (CSJ 0581-01-143), Buckner Boulevard (Loop 12) and Mercer Drive (CSJ 0581-01-153), Buckner Boulevard (Loop 12) and Lake Highlands Drive (CSJ 0581-01-149), Kiest Boulevard (Spur 303) and Duncanville Road (CSJ 2208-02-024), Lancaster Road (State Highway 342) and Camp Wisdom Road (CSJ 0918-47-229), and Harry Hines Boulevard (Loop 354) at Lombardy Lane (CSJ 0196-06-031); and

WHEREAS, on September 26, 2018, City Council authorized the City Manager to sign a Local Project Advance Funding Agreement with TxDOT; and

WHEREAS, based on construction bids received by TxDOT in June 2019, the bids exceeded the original cost estimate by \$117,589.95; and

WHEREAS, the City of Dallas is responsible for 100 percent of project costs exceeding the original estimate in the amount of \$117,589.95.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the City Manager is hereby authorized to issue a payment in the amount of \$117,589.95 in accordance with the terms in the Interlocal Agreement with TxDOT, authorized by previous Council Resolution No. 18-1360 on September 26, 2018, for project cost overruns related to the intersection and traffic signal improvements at the following nine on-system locations: Scyene Road (State Highway 352) and Prairie Creek Road, Robert B. Cullum Boulevard (State Highway 352) and Fitzhugh Avenue, Scyene Road (State Highway 352) and St. Augustine Drive, Buckner Boulevard (Loop 12) and Samuell Boulevard, Buckner Boulevard (Loop 12) and Mercer Drive, Buckner Boulevard (Loop 12) and Lake Highlands Drive, Kiest Boulevard (Spur 303) and Duncanville Road, Lancaster Road (State Highway 342) and Camp Wisdom Road, and Harry Hines Boulevard (Loop 354) at Lombardy Lane.

SECTION 2. That the Chief Financial Officer is hereby authorized to issue a warrant check in the amount of \$117,589.95 to TxDOT in accordance with the terms and conditions of the agreement from the General Fund, Fund 0001, Department TRN, Unit 3002, Object 4820, Vendor 020318.

SECTION 3. That this contract is designated as Contract No. TRN-2018-00007515.
