WHEREAS, on April 11, 2018, City Council authorized a Local Project Advance Funding Agreement (LPAFA) with the Texas Department of Transportation (TxDOT) (CSJ 0918-47-243, CFDA No. 20.205) for design and construction of the intersection improvements at Walnut Street and Greenville Avenue, Abrams Road, and Richland College (Richland East Drive) and on Park Lane at U.S. Highway 75; and payment to TxDOT for the City's share of design and construction-related engineering review costs, in the amount of \$26,560.00, by Resolution No. 18-0524; and

WHEREAS, on January 23, 2019, City Council authorized an amendment to Resolution No. 18-0524, previously approved on April 11, 2018 for a LPAFA with TxDOT (CSJ 0918-47-243, CFDA No. 20.205) for the design and construction of the intersection improvements at Walnut Street and Greenville Avenue, Abrams Road, and Richland College (Richland East Drive) and on Park Lane at U.S. Highway 75 to delete any reference to the term "not to exceed"; and include a term that the City of Dallas is responsible for any project cost overruns in excess of the Federal and State funding participation as described in the agreement by Resolution No. 19-0173; and

WHEREAS, on December 28, 2018, three bids were received for the construction of the intersection improvements at Walnut Street and Greenville Avenue, Abrams Road, and Richland College (Richland East Drive) and on Park Lane at U.S. Highway 75, as follows:

SECTION 4. That the Chief Financial Officer is hereby authorized to receive and deposit funds from TxDOT in the amount of \$288,000.00 in the Park Lane/Walnut Street Intersection Improvement Fund (Park Lane), Fund F617, Department PBW, Unit 5065, Revenue Code 6506.

SECTION 5. That the Chief Financial Officer is hereby authorized to receive and deposit funds from TxDOT in the amount of \$672,000.00 in the Park Lane/Walnut Street Intersection Improvement Fund (Walnut Street), Fund F617, Department PBW, Unit 5066, Revenue Code 6506.

SECTION 6. That the Chief Financial Officer is hereby authorized to disburse funds in the amount of \$1,667,034.75 to Mels Electric, L.P. in accordance with the terms and conditions of the contract, as follows:
