Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the City Manager is hereby authorized to execute Supplemental Agreement No. 27 to exercise the first of two, two-year renewal options, to the service contract with Deloitte Consulting, LLP (516612), approved as to form by the City Attorney, for managed services, support, hosted infrastructure, and services for the utility billing system for the Water Utilities Department, in an amount not to exceed \$12,292,440.

SECTION 2. That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$12,292,440 (subject to annual appropriations) to Deloitte Consulting, LLP from Service Contract No. DSV-2016-00000418.

SECTION 3. That is resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
