WHEREAS, on January 27, 2016, City Council authorized a three-year service contract for litter maintenance services for Park and Recreation with Good Earth Corporation in an amount not to exceed \$5,504,967.63 and T. Smith's Lawn Service, LLC in a total amount not to exceed \$2,608,751.05, in a total amount not to exceed \$8,113,718.68, by Resolution No. 16-0159; and

WHEREAS, on December 4, 2018, Administrative Action No. 19-5160 authorized to extend the service contract for six-months for litter maintenance services with Good Earth Corporation, with zero cost, having no effect on the contract amount.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the City Manager is hereby authorized to execute a service price agreement with Good Earth Corporation (510006) in the estimated amount of \$6,581,946.82, T. Smith's Lawn Service, LLC (VS0000052924) in the estimated amount of \$3,941,138.18, and V. L. & I., Inc. dba Urban Landscaping & Irrigation (514920) in the estimated amount of \$1,574,076.06, approved as to form by the City Attorney, for litter maintenance services and trash removal at City-owned parks, recreation centers, aquatic centers, and splash grounds for the Park and Recreation Department for a term of three-years, in the total estimated amount of \$12,097,161.06. The amount payable pursuant to this service price agreement may exceed the estimated amount, but may not exceed the amount of budgetary appropriations for this service price agreement during its term. Payments made to Good Earth Corporation, T. Smith's Lawn Service, LLC, and V. L. & I., Inc. dba Urban Landscaping & Irrigation shall be based only on the amount of the services directed to be performed by the City and properly performed by Good Earth Corporation, T. Smith's Lawn Service, LLC, and V. L. & I., Inc. dba Urban Landscaping & Irrigation under the service price agreement. The City Manager is further authorized, in the City Manager's sole discretion, to exercise an option to extend the agreement for six months by filing a notice of extension with the City Secretary's Office.

SECTION 2. That the Chief Financial Officer is hereby authorized to disburse funds in an estimated amount of at least \$12,097,161.06, but not more than the amount of budgetary appropriations for this service price agreement during its term to Good Earth Corporation, T. Smith's Lawn Service, LLC, and V. L. & I., Inc. dba Urban Landscaping & Irrigation from Service Price Agreement Contract No. PKR-2019-00010422.

SECTION 3. That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
