**WHEREAS,** the National Recreation and Park Association (NRPA) is a leading non-profit organization dedicated to the advancement of public parks, recreation and conservation, whose work draws national focus to the far-reaching impact of successes generated at the local level; and

**WHEREAS,** the NRPA Connecting to Communities Through Outdoor Play Grant Program allocates a portion of their funding toward local grants across the nation; and

**WHEREAS,** the City of Dallas is fully eligible to receive assistance under this program for playground improvements to Daniel Dale Park located at 500 West Wheatland Road; and

**WHEREAS,** on November 22, 2019, the City of Dallas was awarded an NRPA Connecting to Communities Through Outdoor Play Grant in the amount of \$26,000.00 for the purchase and installation of one unit of playground equipment at Daniel Dale Park located at 500 West Wheatland Road; and

**WHEREAS,** it is deemed feasible and the NRPA is willing to enter into a Grant agreement with the City.

**Now, Therefore,**

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:**

**SECTION 1.** That the City Manager is hereby authorized to accept a grant from the National Recreation and Park Association Connecting to Communities Through Outdoor Play Grant Program in the amount of \$26,000.00 for the purchase and installation of one unit of play equipment at Daniel Dale Park located at 500 West Wheatland Road for the period December 2, 2019 through June 30, 2020; and execute the grant agreement and all terms, conditions, and documents required by the agreement, approved as to form by the City Attorney.

**SECTION 2.** That the Chief Financial Officer is hereby authorized to receive and deposit funds in an amount not to exceed \$26,000.00 in the NRPA-Daniel Dale Park Fund, Fund P141, Department PKR, Unit 5076, Revenue Code 8411.

**SECTION 3.** That the City Manager is hereby authorized to established appropriations in an amount not to exceed \$26,000.00 in the NRPA-Daniel Dale Park Fund, Fund P141, Department PKR, Unit 5076, Object 4890.

**SECTION 4.** That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$26,000.00 from the NRPA-Daniel Dale Park Fund, Fund P141, Department PKR, Unit 5076, Object 4890, Encumbrance/Contract No. PKR-2020-00012960.

**SECTION 5.** That the City Manager is hereby authorized to reimburse to the granting agency expenditures identified as ineligible. Further, the City Manager shall notify the appropriate City Council Committee of expenditures identified as ineligible no later than 30 days after the reimbursement.

**SECTION 6.** That the City Manager shall keep the appropriate City Council Committee informed of all final granting agency monitoring reports not later than 30 days after the receipt of the report.

**SECTION 7.** That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
