

ORDINANCE NO. \_\_\_\_\_

An ordinance by the City Council of the City of Dallas, Texas, approving Resolution No. 2020-03-065 adopted by the Dallas Fort Worth International Airport Board on March 5, 2020 for the purpose of amending Chapters 1, 2, 3, 4, 5, and 8 of the Code of Rules and Regulations of the Dallas Fort Worth International Airport Board, as shown in the attachment hereto.

**WHEREAS**, Sections 22.082 of the Texas Transportation Code, as amended, and Section 8.F. of the 1968 Contract and Agreement, as amended, provide that such rules, regulations or orders by the Dallas Fort Worth International Airport Board will become effective only upon approval of the governing bodies of the Cities of Dallas and Fort Worth and proper publication;

**WHEREAS**, pursuant to the foregoing, the Dallas Fort Worth International Airport Board adopted the Code of Rules and Regulations of the Dallas-Fort Worth International Airport Board, which regulates traffic, travel, and conduct within the Dallas-Fort Worth International Airport and establishes certain procedures for the adoption of additional rules, regulations and orders; and

**WHEREAS**, in accordance with Section 1-8 of Chapter 1 of the Code of Rules and Regulations of the Dallas Fort Worth International Airport Board, as amended, the Dallas-Fort Worth International Airport Board has requested that the City Councils of the Cities of Dallas and Fort Worth approve Resolution No. 2020-03-065 in order that it may become effective;

**Now Therefore**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DALLAS:**

**SECTION 1.** That all of the declarations and findings contained in the preambles of this ordinance are made a part hereof and shall be fully effective as a part of the ordained subject matter of this ordinance.

**SECTION 2.** That Resolution No. 2020-03-065 of the Dallas Fort Worth International Airport Board, a duly certified copy of which is attached hereto as Exhibit A and made a part of this ordinance by reference, is hereby approved.

**SECTION 3.** That after publication of a substantive statement relating to the contents of Resolution No. 2020-03-065 of the Dallas Fort Worth International Airport Board in a newspaper of general circulation in each of the counties of Dallas and Tarrant, stating that the full text of Resolution No. 2020-03-065 and any attachments are on file in the principal office of the Dallas Fort Worth International Airport Board to be read by any interested party, Resolution No. 2020-03-065 shall thereafter have the same force and effect within the boundaries of the Dallas Fort Worth International Airport as an ordinance by the City Council of the City of Dallas would have in the City of Dallas, and the penalty shall be enforced in the same manner in which penalties prescribed by other ordinances of the City of Dallas are enforced.

**SECTION 4.** That the sections, paragraphs, sentences, clauses, and phrases of this ordinance and Resolution No. 2020-03-065 are severable, and if any phrase, clause, sentence, paragraph, or section shall be declared unconstitutional or invalid by the valid judgment or decree of any court of competent jurisdiction, the unconstitutionality or invalidity shall not affect any of the remaining phrases, clauses, sentences, paragraphs, and sections of these ordinances or Resolution No. 2020-03-065, since the same would have been enacted without the incorporation of any unconstitutional phrase, clause, sentence, paragraph, or section.

**SECTION 5.** That this ordinance will take effect immediately from and after its passage and publication in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so ordained.

<b>Description of major substantive code changes:</b> <ul style="list-style-type: none"><li>• Chapter 2 (Traffic Regulation): Failure to pay parking and access charges will become a civil offense, punishable by a \$58 fine, in addition to the parking and access charges themselves.</li><li>• Chapter 3 (Miscellaneous Offenses): Failure to return security credentials will become an offense.</li><li>• Chapter 3 (Miscellaneous Offenses): The Board's duty to file a declaratory judgment action in court every time a permit is refused or revoked, if a hearing is requested by the permit holder or applicant, is being deleted.</li><li>• Chapter 8 (Commercial Activities): The general prohibition against commercial activity on the airport without a permit from the Airport Board will be rewritten to broaden its scope.</li></ul>				
<b>Justification</b> <ul style="list-style-type: none"><li>• These changes will eliminate unnecessary procedures and allow better enforcement of Board policies.</li></ul>
