COMMENCING at a point in the Southeast line of McBroom Street, formerly Saratoga Street, a 40' wide public right-of-way dedicated by said Joe A. Irwin Addition, from which a 1/2" iron rod found for controlling monument bears N 45°15'23" W, 0.25', at the transitional right-of-way of Toronto Street, formerly Mineola Street, a 50' wide public right-of-way dedicated by said Joe A. Irwin Addition, being the beginning of a tangent curve to the left having a central angle of 61°25'53", a radius of 54.00' and a chord bearing and distance of South 14°01'40" West, 55.16':

Thence Southerly along said curve to the left and said transitional right-of-way, an arc distance of 57.90' to a point for corner and the PLACE OF BEGINNING of the herein decsribed tract of land;

Thence North 67°06'10" East, passing through said Block 16/7162, a distance of 300.56' to a point for corner;

Thence North 44°44'37" East, a distance of 146.42' to a point for corner in the Southeast line of said Lot 14; Thence South 04°56'02" West, 1.00' West of and parallel to the projection of an East line of said Obayangban tract, a distance of 23.43' to a point for corner;

Thence South 44°44'37" West, a distance of 58.34' to a point for corner;

Thence South 22°53'50" East, a distance of 41.57' to a point for corner;

Thence South 88°57'10" East, a distance of 17.99' to a point for corner;

Thence South 04°56'02" West, 1.00' West of and parallel to the East line of said Lot 27, a distance of 7.52' to a point for corner in the South line of said Lot 41, in the North line of said Lot 27;

Thence South 01°00'45" West, along the common line of said Lots 27 and 28, a distance of 7.50' to a point for corner, from which bears a 1/2" iron rod found for controlling monument at South 88°57'10" East, a distance of 1.00' and South 01°02'42" West, a distance of 143.76';

Thence North 88°57'10" West, a distance of 85.21' to a point for corner;

Thence South 67°06'10" West, passing through said Block 16/7162, a distance of 302.60' to a point for corner in the said transitional right-of-way of McBroom Street and Toronto Street, at the beginning of a non-tangent curve to the right having a central angle of 15°58'35", a radius of 54.00' and a chord bearing and distance of North 24°49'54" West, 15.01';

Thence Northerly, along said curve to the right and said transitional right-of-way, an arc distance of 15.06' to the PLACE OF BEGINNING and containing 8,795 square feet or 0.202 of an acre of land.







