**SECTION 1.** That the City Manager is hereby authorized to execute a construction contract with Estrada Concrete Company, LLC, approved as to form by the City Attorney, for the reconstruction of street paving and storm drainage improvements for Street Reconstruction Group 17-5007, in an amount not to exceed \$1,774,658.50, this being the lowest responsible bid received as indicated by the tabulation of bids.

**SECTION 2.** That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$1,774,658.50 to Estrada Concrete Company, LLC in accordance with the terms and conditions of the contract, as follows:
