FIELD NOTES

DESCRIBING A TRACT OF LAND FOR FEE SIMPLE ACQUISITION OF RIGHT-OF-WAY FOR THE LAKE TAWAKONI RAW WATER TRANSMISSION MAIN

KAUFMAN COUNTY, TEXAS Parcel: 262

BEING a 3.940 acre tract of land in the Samuel E. Pyle Survey, Abstract No. 381, in Kaufman County, Texas and the Samuel E. Pyle Survey, Abstract No. 658, in Van Zandt County, Texas, being part of a tract of land described as "Tract One" in a Warranty Deed with Vendor's Lien to Justin Scott, dated October 15, 2009, as recorded in Volume 3667, Page 105, in the Deed Records Kaufman County, Texas (D.R.K.C.T.), same being recorded in Document No 2010-000329, in the Deed Records of Van Zandt County, Texas (D.R.V.Z.C.T.), and being more particularly described as follows:

BEGINNING at a concrete monument with cap stamped "City of Dallas" found at the northeast corner of said "Tract One", same being the southeast corner of a City of Dallas Water Line Right-of-Way (130 foot wide Right-of-Way), as recorded in Volume 670, Page 203, D.R.V.Z.C.T., also being in the west line of a tract of land described as "First Tract" to the Sabine River Authority, as recorded in Volume 483, Pg. 32, D.R.V.Z.C.T.;

THENCE South 01 degrees 45 minutes 11 seconds East, with the east line of said "Tract One" and the west line of said "First Tract", a distance of 130.90 feet to a 1/2-inch iron rod with red cap stamped. "DAL-TECH" (hereinafter referred to as "with cap") set;

THENCE South 81 degrees 32 minutes 24 seconds West, departing the east line of said "Tract One" and the west line of said "First Tract", a distance of 1,321.85 feet to a 1/2-inch iron rod with cap set in the west line of said "Tract One", being the east line of 21.54 acre tract, as recorded in Volume 4534, Page 133 (D.R.K.C.T.);

THENCE North 00 degrees 17 minutes 25 seconds West, with the west line of said "Tract One" and the east line of said 21.54 acre tract, a distance of 131.33 feet to a concrete monument with cap stamped "City of Dallas" found at the northwest corner of said "Tract One" and the northeast corner of said 21.54 acre tract, also being the southwest corner of a City of Dallas Water Line Right-of-Way, recorded in Volume 500, Page 413, D.R.K.C.T.;

THENCE North 81 degrees 32 minutes 24 seconds East, with the north line of said "Tract One" and with the south lines of the aforementioned City of Dallas Water Line Right-of-Way tracts, a distance of 1,318.47 feet to the POINT OF BEGINNING and containing 171,621 square feet (3.940 acres) of land.


