WHEREAS, on April 25, 2018, City Council authorized a professional services contract with HNTB Corporation to provide design and construction documents for the Reconstruction of Runway 13R/31L Project at Dallas Love Field, in an amount not to exceed \$5,096,677.00, by Resolution No. 18-0598; and

WHEREAS, on May 23, 2018, City Council authorized an Other Transaction Agreement with the FAA to provide Limited Design and Implementation Reimbursable Agreement for analyzing the impact of FAA facilities due to Runway 13R/31L Reconstruction Project at Dallas Love Field, in an amount not to exceed \$98,677.00, by Resolution No. 18-0735; and

WHEREAS, on October 23, 2019, City Council authorized an engineering services contract with HNTB Corporation to provide design and construction administration services for the rehabilitation of Taxiway C at Dallas Love Field, in an amount not to exceed \$3,363,326.00, by Resolution No. 19-1638; and

WHEREAS, on November 25, 2019, Administrative Action No. 19-7016 authorized an Other Transaction Agreement with the FAA to provide engineering support services for the Rehabilitation of Taxiway C Phases I & II Project at Dallas Love Field, in an amount not to exceed \$43,530.35; and

WHEREAS, on March 25, 2020, City Council authorized the application for and acceptance of a series of grants from the U.S. Department of Transportation, FAA for the federal share of the eligible capital improvement projects for the Airport Improvement Program (AIP) at Dallas Love Field, in in a total amount not to exceed \$75,000,000.00 for the Reconstruct of Runway Construction by Resolution No. 20-0456; and

WHEREAS, it is now necessary for the Department of Aviation to reconstruct Runway 13R/31L and Taxiway C Phase I; and

WHEREAS, the Department of Aviation employed the Request for Bids process in accordance with City of Dallas and Federal Aviation Administration procurement guidelines for construction services; and

WHEREAS, construction bids were publicly advertised, received and opened on March 13, 2020 for the Reconstruction of Runway 13R/31L and Taxiway C Phase I Project at Dallas Love Field as follows:

WHEREAS, Flatiron Constructors, Inc. was identified as the lowest responsive and responsible bidder of four in accordance with City of Dallas procurement guidelines; and

WHEREAS, it is now necessary to authorize a construction services contract with Flatiron Constructors, Inc., lowest responsive bidder of four, for the construction of the Reconstruction of Runway 13R/31L and Taxiway C Phase I Project at the Dallas Love Field, in an amount not to exceed \$124,279,998.00.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the City Manager is hereby authorized to execute a construction contract with Flatiron Constructors, Inc., approved as to form by the City Attorney, for the construction of the Reconstruction of Runway 13R/31L and Taxiway C Phase I Project at Dallas Love Field, in an amount not to exceed \$124,279,998.00.

SECTION 2. That the City Manager is hereby authorized to increase appropriations in an amount not to exceed \$37,056,064.76 in the Aviation Passenger Facility Charge - Near Term Projects Fund, Fund A477, Department AVI, Unit D019, Object 4599, increasing the appropriations amount from \$68,780,793.69 to \$105,836,858.45.

SECTION 3. That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$124,279,998.00 to Flatiron Constructors, Inc. in accordance with the terms and conditions of the construction services contract, as follows:

SECTION 4. That the City will apply for an amendment to the existing approved Passenger Facility Charge (PFC) application, No. 19-05-C-00-DAL, at Dallas Love Field (DAL) to reflect the actual expenses for construction of the Reconstruction of Runway 13R/31L Project, in an amount not to exceed \$105,836,858.45. The Chief Financial Officer is hereby authorized to deposit PFC revenues received in Passenger Facility Charge Fund, Fund 0477, Department AVI, Unit 0781, Revenue Code 781H.

SECTION 5. That the Chief Financial Officer is hereby authorized to transfer the approved PFC amount of \$105,836,858.45 from the Passenger Facility Charge Fund, Fund 0477, Department AVI, Balance Sheet Account 0001, to the Aviation Passenger Facility Charge Fund, Fund A477, Department AVI, Balance Sheet Account 0001.

SECTION 6. That the City will apply for Passenger Facility Charge (PFC) funding at a later date for the eligible construction costs (\$18,443,139.55) of the Rehabilitation of - Taxiway C Phase I; and upon approval of the PFC for this project, the Chief Financial Officer is hereby authorized to transfer an amount not to exceed \$18,443,139.55 from the Passenger Facility Charge Fund, Fund 0477, Department AVI, Balance Sheet Account 0001 to the Aviation Passenger Facility Charge - Near Term Projects Fund, Fund A477, Department AVI, Balance Sheet Account 0001. The transfer of cash is contingent upon the approval of Passenger Facility Charge Funds by the Federal Aviation Administration.

SECTION 7. That this contract is designated as Contract No. AVI-2020-00011943.

SECTION 8. That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
