**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:**

**SECTION 1.** That the bid submitted by Muniz Construction, Inc., in the amount of \$6,481,076.00, for doing the work covered by the plans, specifications, and contract documents, Contract No. 20-109/110, be accepted.

**SECTION 2.** That the City Manager is hereby authorized to execute a construction contract with Muniz Construction, Inc., approved as to form by the City Attorney, for the replacement of water and wastewater mains at 16 locations, in an amount not to exceed \$6,481,076.00.

**SECTION 3.** That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$6,481,076.00 to Muniz Construction, Inc., as follows:
