WHEREAS, the Coronavirus Disease 2019 (COVID-19) pandemic has been declared a public health disaster; and

WHEREAS, the U.S. Department of Treasury has made funding available to the City of Dallas to cover expenses incurred due to the COVID-19 pandemic; and

WHEREAS, 20% of Dallas County residents face food insecurity and nearly 38% of Dallas residents live in food deserts; and

WHEREAS, many residents of Dallas are experiencing job loss, pay loss, added expenses and other issues making it difficult to afford healthy and nutritious foods; and

WHEREAS, individuals who may be diagnosed with COVID-19 or quarantined due to exposure, may find themselves too sick or otherwise unable to travel and purchase food; and

WHEREAS, the City of Dallas seeks to support the provision of services that address food insecurity and support access to food for identified populations and for COVID-19 confirmed patients.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the City Manager is hereby authorized to execute five subrecipient agreements for making food accessible services with **(1)** Citizens Development Center dba Achieve in the amount of \$90,000.00; **(2)** CitySquare in the amount of \$127,469.00; **(3)** First Presbyterian Church of Dallas, Texas dba The Stewpot in the amount of \$105,928.00; **(4)** Services of Hope Entities, Inc. in the amount of \$388,903.00; and **(5)** The Visiting Nurse Association of Texas in the amount of \$137,700.00 for the period September 1, 2020 (or upon contract execution) through December 31, 2020, approved as to form by the City Attorney.

SECTION 2. That the Chief Financial Officer is hereby authorized to disburse funds **(1)** in an amount not to exceed \$90,000.00 to Citizens Development Center dba Achieve; **(2)** in an amount not to exceed \$127,469.00 to CitySquare; **(3)** in an amount not to exceed \$105,928.00 to First Presbyterian Church of Dallas, Texas dba The Stewpot; **(4)** in an amount not to exceed \$388,903.00 to Services of Hope Entities, Inc.; and **(5)** in an amount not to exceed \$137,700.00 to The Visiting Nurses Association of Texas, for a total amount not to exceed \$850,000.00, as follows:

SECTION 4. That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$127,469.00 to CitySquare from U.S. Department of Treasury Coronavirus Relief Funds, Fund F620, Department MGT, Unit 956F, Object 3070, Encumbrance/Contract No. OCC-2020-00014499, Vendor VS0000000497.

SECTION 5. That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$105,928.00 to First Presbyterian Church of Dallas, Texas dba The Stewpot from U.S. Department of Treasury Coronavirus Relief Funds, Fund F620, Department MGT, Unit 956F, Object 3070, Encumbrance/Contract No. OCC-2020-00014500, Vendor VS0000048892.

SECTION 6. That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$388,903.00 to Services of Hope Entities, Inc. from U.S. Department of Treasury Coronavirus Relief Funds, Fund F620, Department MGT, Unit 956F, Object 3070, Encumbrance/Contract No. OCC-2020-00014501, Vendor VC0000004593.

SECTION 7. That the Chief Financial Officer is hereby authorized to disburse funds in an amount not to exceed \$137,700.00 to The Visiting Nurses Association of Texas U.S. Department of Treasury Coronavirus Relief Funds, Fund F620, Department MGT, Unit 956F, Object 3070, Encumbrance/Contract No. OCC-2020-00014502, Vendor VS0000063573.

SECTION 8. That this project will spend funds from the Coronavirus Relief Funds authorized by City Council on April 22, 2020.

SECTION 9. That this resolution shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the City of Dallas, and it is accordingly so resolved.
