WHEREAS, on February 27, 2019, the City Council approved a resolution to authorize and establish the Fiscal Year 2019-20 Cultural Organizations Program to support cultural services in the City of Dallas, and approved the program guidelines by Resolution No. 19-0339; and

WHEREAS, the Cultural Organizations Program provides operating support to eligible organizations in exchange for cultural services to residents and visitors of Dallas over a twelve-month period; and

WHEREAS, the Cultural Organizations Program Fiscal Year 2019-20 contracts were approved by Resolution No. 19-1588 for a total amount not to exceed \$4,811,910.00; and

WHEREAS, the thirty-four organizations contracted for services through the Fiscal Year 2019-20 Cultural Organizations Program were drastically impacted by COVID-19 and were unable to provide the full in-person services contracted due to various public health measures; and

WHEREAS, the thirty-four organizations adapted and pivoted towards arts and cultural offerings through virtual and take-home means for Dallas residents; and

WHEREAS, it is necessary for the City to amend the contracted services received through the Cultural Organizations Program for Fiscal Year 2019-20 to reflect updated projections, and to amend contract amounts accordingly for Fiscal Year 2019-20 services.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the City Manager is hereby authorized to amend the Cultural Organizations Program contracts approved and executed last year for the period October 1, 2019 through September 30, 2020, to: **(1)** revise each organization's scope of services to reflect their new capacity and capability to perform arts and culture services for the residents and visitors of Dallas; and **(2)** reduce the contract amounts by 8 percent for each organization authorized by Resolution No. 19-1588, previously approved on October 8, 2019, to reflect the reduction in services that were provided due to the impact of COVID-19 and related government restrictions to ensure public health. Reduction amount for all contracts not to exceed \$384,954.

SECTION 2. That the Chief Financial Officer is hereby authorized to reduce \$384,954 total for all the contracts as follows from General Fund, Fund 0001, Department OCA, Object 3089, Encumbrance/Contract No. MASC-OCA-2019-00011411:
