**WHEREAS**, the City of Dallas has identified the need to address storm drainage and erosion improvements at 12 locations within the City of Dallas; and

**WHEREAS**, engineering services are required to complete drainage and feasibility studies and develop construction documents to improve flooding and erosion control issues at these locations by upgrading storm drainage infrastructure and stabilizing eroded stream banks; and

**WHEREAS,** Kimley-Horn & Associates, Inc., P.O. Box 951640, Dallas, TX 75395 has submitted an acceptable proposal to provide these engineering services.

Now, Therefore,

## BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:
