**WHEREAS**, the City of Dallas has identified the need to provide storm drainage system and erosion control improvements at 11 locations to address known flooding issues and stream bank erosion; and

**WHEREAS**, engineering services are required to complete hydraulic studies and develop construction documents to improve flooding and erosion control issues at these locations by upgrading storm drainage infrastructure and stabilizing eroded stream banks; and

**WHEREAS**, Jones & Carter, Inc., 6330 West Loop South, Suite 150, Bellaire, Texas 77401, has submitted an acceptable proposal to provide these engineering services.
