WHEREAS, on October 24, 2018, by Resolution No. 18-1531, the City Council authorized a twenty-year management contract, with two five-year extension options, with Fair Park First for the management and operation of Fair Park; and

WHEREAS, the quality operation, management, maintenance, promotion, enhancement, and improvement of Fair Park is in the best interest of the City's residents; and

WHEREAS, City and Fair Park First have agreed to amend the Agreement in the interest of enhancing, promoting, and improving Fair Park.

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the City Manager is hereby authorized to execute **(1)** a first amendment to the Fair Park management agreement with Fair Park First, approved as to from by the City Attorney, to amend sections 3.01(c), 3.01(f), 3.02 (a), 4.20, 14.03; and add a section 3.02(b) regarding maintenance and operation of the Children's Aquarium; and **(2)** funding through the Equity Revitalization Capital Fund and the General Fund, in an amount not to exceed \$3,219,095.00.

SECTION 2. That the Chief Financial Officer is hereby authorized to disburse funds in periodic payments, in an amount not to exceed \$2,320,000.00 (subject to annual appropriations) as invoices are processed by the Office of Arts and Culture in the amounts indicated below:
